# Issue

Over the past few weeks, the International Myeloma Foundation's InfoLine has been flooded with calls from patients and caregivers facing insurmountable financial challenges due to the high cost of drugs and increases in insurance copays. In the past, several services have been available to provide financial assistance to patients; but the current atmosphere has severely limited the availability of those funds.

#### **OVERVIEW**

- The way we treat cancer is changing, with oral anti-cancer medications playing an increasingly important role. These targeted therapies available in pill form- directly attack cancer cells, often with few sides effects.
- > Traditional anti-cancer medications were primarily administered intravenously and covered under a health plan's medical benefit, often requiring patients to pay minimal co-pay or no cost at all for the medication.
- > Oral anti-cancer medications are usually part of the health plan's pharmacy benefit, often resulting in high, burdensome out-of-pocket costs through coinsurance (requiring patients to pay a percentage of the overall cost of the prescription drug).
- > This disparity negatively impacts patient adherence and forces physicians to make decisions based on outdated health plan benefit designs rather than what is best for the patient.



# **CANCER DRUG PARITY ACT**

The Cancer Drug Parity Act requires any health plan that provides coverage for cancer chemotherapy treatment to provide coverage for self-administered anticancer medication at a cost no less favorable than the cost of IV, port administered, or injected anticancer medications.

The law is not a mandate as it only applies to health plans that already cover chemotherapy. This bill ensures equality of access and insurance coverage for ALL anticancer regimens. Health insurance cost-sharing schemes should not create barriers to cancer patients' ability to access potentially life-saving medicines.
