#### Freedom of Information Act:

## 5. Letter to Scott Koch, Information and Privacy Coordinator, Central Intelligence Agency

Dear Mr. Scott Koch:

This letter serves as my official appeal of the Central Intelligence Agency's decision to withhold the entirety of my FOIA request for records pertaining to Ordo Templi Orientis which was filed with the Defense Intelligence Agency on 12 November 2005. I was instructed to file this request in your care within 45 days of the date of your letter, and I am sending this document overnight for review by the Agency Release Panel.

The basis for my appeal is that the Ordo Templi Orientis (OTO) is a tax exempt religious institution, and thus should be entitled to all documents covered by the FOIA, as to withhold them would be a direct violation of the first amendment to the United States Constitution which guarantees the free exercise of religion.

It is noted that in your letter FOIA exemptions (b) (1) and (b) (3) are listed as the primary reasons for withholding the records pertaining to OTO. (b) (1) states that this applies to material which is properly classified pursuant to an Executive order in the interest of national defense or foreign policy, while (b) (3) states that this applies to information pertaining to the CIA Director's statutory obligations to protect from disclosure intelligence sources and methods, as well as the organization, functions, names, official titles, salaries, or numbers of personnel employed by the Agency, in accordance with the National Security Act of 1947 and/or the CIA Act of 1949.

It is difficult, to say the least, to freely practice one's religion without knowing whether the person sitting next to you is a covert member of the CIA, allowed to use whatever methods are deemed necessary for surveillance or other operations. Moreover, such acts are a violation of Amendment IV of the U.S. Constitution, which guarantees the right of the people to be secure in their persons, houses, papers

and effects against unreasonable searches and seizures.

However, as the principal founding member of the present day OTO was Aleister Crowley (1875-1947) whose exploits in British intelligence circles during WWI and WWII are increasingly being documented to the public in both book and television format, it is understandable that the CIA may have an interest in his organization.





Jack Parsons (19141952), a rocket scientist who
co-founded the Jet Propulsion laboratory
in Pasadena and has a crater on the moon
named after him for his research in solid
rocket fuels, was also a member of the
OTO who may have come under the review of
the CIA, especially when he attempted to
seek employment in Israel during the late
1940s.

But as both these members are deceased, and their interactions with government intelligence agencies at home and abroad occurred so long ago, why would it still be necessary to withhold information that in a free society should be freely disseminated? The concern I have is that CIA operations with the OTO may be continuing in the present, or that they have taken place within the last few decades.

It should also be noted that Major Grady L. McMurtry (1918-1985) met with Aleister Crowley several times during WWII, at the time when McMurtry was preparing for the invasion of Normandy. He later served our country admirably in Korea. In the late

1960s McMurtry was able to revive the OTO by the use of emergency powers given to him by Crowley, and by the publication of Crowley's Thoth tarot card deck. The OTO has continued to grow to its present organizational level throughout the world in the last 40 years. One question of concern is whether McMurtry was contacted by the CIA while he was in



the employment of the State Department in the 1960s as part of the CIA's "Alternative Programs" which were designed to set up and/or infiltrate New Age groups and religions. It is noted that these programs

were abolished in the 1980s, but it is unknown if any new programs to infiltrate minority religions have taken place since that time. Again, I ask in my appeal for complete disclosure of such activities from the 1960s to the present time.

Thank you for your time and consideration of my appeal. Although it may take another two years to receive a response, rest assured patience is a virtue I have long ago acquired. Copies of this appeal will go to my congressional representatives and select media outlets so that this appeal process will be under their scrutiny as well.

## 15. Letter to Frater Superior and Grand Master Sabazius, Ordo Templi Orientis (OTO)

December 28, 2009 e.v. Anno CV e.n. Moon in Gemini

Dear Frater Superior and Grand Master Sabazius:

Do what thou wilt shall be the whole of the Law. Greetings and salutations this Yule season, and I hope this correspondence finds you both well. As you know, I have been pursuing a Freedom of Information Act investigation to refute allegations made in the book Blood on the Altar: The Secret History of the World's Most Dangerous Secret Society by Craig Heimbichner, published by Independent History & Research. Bluntly, the book states the Order is a CIA front organization. I began my research back in 2005 with the initial request made with the Defense Intelligence Agency... After two years, I received my initial response, stating that the material on the Order must remain classified, and giving exemptions (b) (1) and (b) (3) as its reasoning.

I appealed the decision primarily on constitutional grounds based on the right to practice one's religion without government interference. My appeal was accepted, but denied on the same grounds. I was informed by the CIA that I had the right to seek judicial review in a United States federal court.

As I do not have the funds necessary for such a judicial review, I wrote to the ACLU after completing an over the phone intake survey. I have yet to hear from them.

Over the years I have trusted a small number of elder Thelemites and brothers from my Scottish Rite lodge for their insight and opinions as to what is meant by the exemptions, and speculation as to what the CIA might be up to in regards to a separate agenda. After careful consideration and continued research, I have accepted these theorems: (1) The Order exists under the auspices of the CIA; otherwise we would not exist. (2) There are initiates of the Order who are personnel employed by the CIA. (3) The one document being withheld is commonly referred to as a "directive" which implies a course of action in regards to the Order.

. . .

Thank you both for your time and consideration of this vitally important matter. I believe beyond all else that the Order must be free of all outside agendas to pursue the Great Work. The exemptions listed in the CIA denials raises questions of our legitimacy. We cannot serve another Master, and we cannot be beholden to the will of non-Thelemites.
