The United States Supreme Court currently has before it in its October 1977 Term two of the most crucial "test" cases involving official judicial corruption and Constitutional rights violations since it ruled against former President Nixon's request for "executive privilege" regarding the "Watergate tapes" in July, 1974.

The first case docketed as no. 77-5357 on August 31, 1977 as *Bottos* v. Avakian, et. al. was filed by Alex J. Bottos (Executive Director of the Citizens Bar Assn.) and involved massive allegations of judicial corruption in the Indiana and Federal Courts for the benefit of "organized crime" and members of the "Intelligence community". This suit charges three F.B.I. agents and two Senior Justices of the Indiana Supreme Court (Alfred Pivarnik and Richard Givan) with participation in four separate cases of "false imprisonment" of the nationally respected "crime fighter" and legal researcher while simultaneously concealing and covering up massive thefts of millions of dollars of Federal funds.

Bottos, you will recall, was the man responsible for obtaining government documents (1300 pages) concerning the crash of United Flight no. 553 on December 8, 1972, in which Mrs. E. Howard Hunt and forty others were killed on orders (according to Bottos)

of the "highest authority of the nation" because Mrs. Hunt intended to expose some "reprehensible things" her husband had done for Nixon and Richard Helms (Director of the C.I.A.) over and above the phony Watergate burglary. In 1973 Bottos had all the evidence to prove the flight as "sabotage" and the government knew it. So, National Transportation Safety Board Chairman, Isabell Burgess, suppressed and derailed the hearings on the cause of the crash under direct orders from then N.T.S.B. Director Egil Krogh. (Since then, Krogh has been sent to prison for obstructing justice and perjury in the Watergate affair, while Mrs. Burgess was fired in January of 1976, after disclosure to the Senate that she had taken bribes.)

After fifteen years of Court battles beginning in the 1960s as a ranking member of the "Liberty Amendment Committee, U.S.A." (which nearly succeeded in getting 21 State legislatures to abolish all Constitutional amendments except the original Bill of Rights, the first 10 Amendments), Bottos has had to file these cases as a "pauper", since he has been reduced to precisely that, with himself presently fighting 12 lawsuits without an Attorney against major "corrupt" office holders since 1971. Bottos claims that criminal elements within the various legal Bar Associations operating in Indiana keep trying to prevent him from exposing corruption and leading the Citizen's Bar Association (which he heads) in

their crusade of indicting and exposing corrupt judges, lawyers, and public officials who have escaped prosecution by "fixes" in the Courts.³

Under oath, Bottos has told the Supreme Court and the Indiana U.S. Attorney that four of his key witnesses have died by "violence and unexplained accidents" within the last three years, making this case involving government officials appear even more mysterious. The 'false imprisonment" by the F.B.I. was "unique" in that Bottos was locked away in the Federal Government's special prison in Springfield, Missouri, without charge, hearing or evidence. (Respected columnist Jack Anderson has labeled this prison a "political prison similar to that of the Soviet Union's 'mind control' prison in Minsk, Russia") Bottos claims, "if public pressure and a massive national telephone effort by citizens hadn't taken place, I would never have been able to leave that place alive or sane. They purposely drive men insane there." So, almost five years later he is still trying to win damages for the attempts to silence him and conceal what he knows about the shady doings of major officials involved in Watergate; the full involvement of the Justice Department in the CIA's operation "chaos" and "co-in-tel-pro"; and the intelligence community's "dirty laundry", including the CIA's recently exposed MK-ULTRA "mind control" projects.2

These are the turn of events which

forced the cases eventually to the United States Supreme Court: presiding U.S. District Judge Allen Sharp of Indiana did, according to Court documents, "allow and condone falsification of court documents in Bottos v. Avakian et. al.; Indiana U.S. Attorney John Wilks refused to let Bottos' witnesses testify against the F.B.I. before a Federal Grand Jury despite repeated requests; Bottos then appealed to the 7th U.S. Court of Appeals where the same thing happened, only this time the Appellate Court ordered their decision against Bottos "not to be published" thereby concealing the treachery of both the Tribunal and the lower Court in dismissing the \$1 million suit Bottos had lawfully won from both the eyes of Congressional oversight committees as well as from members of the "Bar". Bottos tendered to the Supreme Court documents signed by Justices Cummings and Fairchild of the 7th U.S. Circuit showing on their face that they had violated not only their own order in Page v. Wright (1940) 116 F. 2nd 449, 453 on the question of the lower Court's jurisdiction (authority); but, also, seven separate United States Supreme Court rulings.1

Also presented as an exhibit to each of the Supreme Court cases was another false imprisonment, this one by then Porter Superior Court Judge Alfred J. Pivarnik (now, Associate Justice of the Indiana Supreme Court) which involved an unlawful contempt conviction of Bottos "in abstentia"

(Bottos was never there) sentencing him to jail in July of 1975... again, to keep Bottos from his totally lawful activity of exposing Pivarnik's hand in approving fraudulent contracts exceeding \$5 million with the presently convicted owners of Metro Construction Company. The contract has since been declared "null and void" by another Special Judge and the Indiana Appellate and Supreme Court have ruled that "the contract did not meet even the minimal requirements of law." 5

Back in 1975, and in order to suppress Bottos' statements made over the radio and news media that the contract was corrupt, Pivarnik publicly labeled Bottos as a "fugitive" from justice despite the fact that there had never been leveled any formal charge, affidavit, evidence or that no hearing or trial ever took place. Pivarnik didn't stop there. His personal attorney, Saul I. Ruman, then proceeded to obtain a fraudulent judgment against Bottos for \$200,000.00 through the help of another "friendly" State Court Judge who is now named as one of 14 defendants in a lawsuit recently filed by Bottos.

As of September 13, 1977, in this latter suit entitled Bottos v. Pivarnik et. al., (H-77-277 Indiana District Court, Hammond, Indiana) presiding Federal Judge Phil McNagny has awarded "default" in favor of Bottos totalling \$12 million in damages, for among other things, trespass, conspiracy, deprivation of

Constitutional rights and procurement of judgement by fraud against two Indiana Supreme Court Justices and their wives.

Thus, it is clear that even a cursory look at the various Court records by a reasonable and unbiased American should be sufficient to illustrate quite possibly the most sinister judiciary in the United States. The Supreme Court of the United States has been asked to look into the record and find out why the Indiana Supreme Court refused to review or rule according to law on the fraudulent judgment "also obtained in-absentia" by Pivarnik's attorney in the case entitled: Indiana Supreme Court no. PS 383, Ruman v. Bottos; why Bottos had been forced to appeal his case against the F.B.I. clearly won by him from the very beginning; why the judges of both Federal courts falsified the Court record; and why Bottos shouldn't be awarded his damages promptly in the amount of \$1 million by thy Supreme Court reversing the lower Court's unlawful activities.

ADDENDUM

From a September 13, 1977, News Release issued by The Citizen's Bar Association.

Recently Bottos has placed both local newspaper Editors on "Notice" that they may be joined in the above suit for failure to report honestly and unbiasedly about his activities and the abuses he has sustained by allegedly "corrupt" lawyers and Judges whom Bottos claims are seeking to "discredit" and "injure" him. In the past Bottos' research was instrumental in either unseating or convicting justices of the Supreme Courts in Oklahoma, Florida and Illinois and in the conviction of now deceased Fed. Appeals Court Judge Otto Kerner. In 1973 Bottos emerged as the "secret" confidential source of the Chicago Strike Force. As such, he forced the conviction of 2 ranking members of Organized Crime in a \$2.2 Million stock theft.

Court watchers have classified his battles as both a "tragedy" and an "American Epic". Four of Bottos' witnesses have been murdered since 1974 and he lost his three children in a blazing inferno in 1965 which Bottos has told the U.S. Supreme Court was done by order of now deceased Mafia Czar Miklos Sperling of Indianapolis.

HAVE THE POLES REALLY BEEN DISCOVERED?

With the coming of the flying saucers, an old question has once more been raised, stemming from the puzzlement regarding the origin of the pesky UFO. Perhaps it is natural that conjecture should include the interior of Earth. It is not too well known by many people today that there is nothing new in this concept, and even less well known is the evidence for such a theory. Back in 1912, Marshall B. Gardner wrote one of the best books on the subject,


and covered it exhaustively with an acumen that is only becoming evident today with new discoveries by our space satellites, and the general acceptance of a theory held in low regard in Marshall's time, the vortexial nebula theory of the formation of planets, which Marshall stressed very strongly in his remarkable book. He was virtually alone then, but he is not alone now! In 1920 he enlarged and revised his book, and it was republished. However, since that

time the book has become unavailable, and rare copies of it are being sold at prices possible only to a collector. Recently photo-copied by Ray Palmer, it is once more available.

One whose acquaintance with cosmogony and physiography is confined to what he learned in school and afterward in popular publications, has certain very definite notions about the shape of Earth, and the construction of its interior. These notions, he thinks, are based on proven discoveries, or impregnable theories of scientists, so he accepts them on blind faith. While they hold to a general theory about the shape and size of Earth, that it is a rigid solid, a shell with a liquid (under enough pressure to make it have the properties of a solid) interior, they will admit that there are many questions that can be raised to dispute their theory. Gardner has "marshalled" an incredible number of these questions and factual observations into his book, so convincingly as to challenge all the old theories. Gardner collects the research stemming from the polar explorations of many explorers, including Peary, Sir John Franklin, Lieutenant McClintock, Dr. Kane, Dr. I.I. Hayes, Sir John Ross, Greely, Adolf Nordenskiold, Nansen, Admiral Melville, Captain Cook, Edwin S. Grew, and literally dozens of the best scientific minds of the day who did research on the discoveries and reports of these intrepid explorers.

To the student of the real nature of our planet, Gardner's book is probably one of the most thought-provoking and stimulating available—perhaps even more valuable because it was written so long ago, yet has stood the test of subsequent discovery, such as the expeditions of Admiral Byrd and all modern explorers, plus new discoveries in science culminating in the research satellites of the space age. Marshall would be delighted today to know how more right he was than he knew, although it has not yet been proved that his concept of the interior of Earth is literally true.

One of the things he stressed was how difficult it is to acquire evidence of a hollow Earth, and how virtually impossible to find the polar entrances he postulates. He stresses Nansen's bewilderment at his failures of navigation, and points out that it is not a matter of "going there and viewing the spectacle of an entrance into. the planet" because mere observation is not enough. Man has always been limited in his concepts of Earth's shape because his eyesight tells him it is flat, so that he cannot accept

without better evidence that it is a spheroid, which is hardly a reasonable theory based on mere eyesight alone.

With what we know today, Gardner's book assumes new stature, and should be a must on every thinker's reading schedule. It is a fascinatingly detailed, expertly presented, absorbingly interesting subject, convincingly handled.

- 7. Is it necessary to have a tax system which forces every taxpayer to sign a purjury oath as a condition to paying his taxes?

- 9. What about the penalties, audits, informers, tax spies, searches and private property seizures, and prison sentences? Is a system of taxation which embraces these really necessary? Does it not sound more like a police state, than the U.S.A.?

does the 16th nullify sections of these and, if so, why aren't the nullified sections removed from those amendments?

- 11. What does it cost to collect taxes by these methods?
- 12. What about discrimination? Isn't this tax system discriminatory beyond description?
- 13. What about fairness? Why tax retirements after the individual has paid taxes all his working life and provide shelters for others in a better position to pay? Why levy capital gains on the sale of a private house when the Congress has caused the inflation that creates the gain?
- 14. What about cash transactions that by-pass the income tax system?
- 15. What about tax-free foundations? Are they not tax shelters for the very wealthy which cause every individual to pay a higher tax rate?
- 16. What about invasion of everyone's privacy?
- 17. Isn't an individuals' income the one most complicated, personal freedom that could be taxed? In most cases it defies classification and should be the individuals private business. Least of all, should it be the business of the tax collector or the government. Isn't this a tax against individual freedom?
- 18. What about inflated tax on inflated income? How does this help control inflation? Doesn't this feed inflation?
- 19. Isn't this method of taxation regressive and the reason why many

people don't care about advancing beyond a certain income bracket, or only work 4 days a week instead of 5 or 6? Or retire younger than they would normally?

- 20. How can you as taxpayers' representatives be so seemingly humanitarian in every other respect and so inhumanly inconsiderate of the American taxpayer?
- 21. Is there not other simpler, more efficient, less painful ways of collecting and paying taxes?
- 22. What do you think George Washington, Thomas Jefferson, John Adams and Ben Franklin, etc. would think of such a ridiculous system of taxation?
- 23. Why doesn't the Congress support H-J Res. No. 23 and eliminate this pre-16th Amendment unconstitutional and illegal legislation so that we can enjoy paying taxes without the confusing, demeaning task of filling out income tax forms?



I do not recall any readers letters in Forum about R. Shaver's rock books as published in your book "The Secret World." So I would like to comment on it.

THE TRUE MEANING OF THE CROSS

A modern mystic, Manly Hall, once stated that there is a gentlemen's agreement, among theological students not to inquire too closely into the origins of Christianity.

It will undoubtedly come as a shock to most orthodox Christians to learn that originally, the Bible was not written at all. Like other ancient Scriptures they were transmitted orally from teacher to pupil. They were considered too sacred and occult to be disseminated to the common herd.

To quote from a brochure by the late Dr. Alvin B. Kuhn, THE LOST KEY TO THE SCRIPTURES: "There is scarcely a single item of the common man's presuppositions about the Christian Scriptures,—who wrote its books, when it was written, what its historical reference, how and why these particular books were selected out of hundreds (Johannes Greber stated out of three thousand manuscripts! M.H.N.) how the composition was dictated or inspired, what its message really means, in what language it was written . . . and other questions by the score . . . that come within the proverbial mile of the actual truth concerning the Bible." He states further: "The Bible becomes infinitely more significant when taken

as allegory than when read as ostensible history."

These ancient teachings consisted of mystery dramas, rituals, songs, mantrams, or prayers, allegories and symbology. The origins are shrouded in mystery, they are hoary with age. In that remarkable book by Dr. George Hunt Williamson, OTHER TONGUES OTHER FLESH, he described a foot print left by a "Saucerian" on firm sand. Symbols had been used to convey a message, which Dr. Williamson was able to understand, for like music, symbology is a universal language.

The Ancient Egyptians, who undoubtedly had derived their religion from the mother country, Atlantis, had the CRUX ANSATE: 0

Certain of their gods and goddesses were carved or painted holding this cross, their symbol of immortality, in their hands. Some scholars also maintain that it is a pictograph of the male and female generative organs. Interestingly, it is almost identical with the astrological symbol for Venus.

At the time of Jesus, the Romans crucified their criminals on a cross shaped like our present day multiplication sign: X. The Latin

cross,

was not used by the Church until about the fifth century. It is an anomaly to picture Christ Jesus nailed to that form of the cross, though this is invariably done.

The use of the cross, in some form—there are over twenty pictured in the Collegiate Webster Dictionary—occurred in numerous ancient nations. It was well-nigh universal. The swastica was a symbol used by the American Indians. When Christian missionaries went to "heathen" nations they found, to their consternation, that the cross had preceded them. Of course they laid that to the machinations of the devil!

To the orthodox Christian, the cross is precious as it typifies Christ's suffering and death; it is the chief symbol of his faith; the promise of salvation because of Christ's atonement. But, as Dr. Kuhn stated, that misses the true meaning "by about a mile!" With Easter approaching, it may be of interest to learn that this festival—as well as Christmas-was adopted from antecedent, so called, Pagan sources. Both are astrological, originally. The tenet of a god dying and then being resurrected, of being a scape-goat for our sins, antecedes Christianity by thousands of years. There are some sixteen known crucified World saviours!

And what is the esoteric meaning of the cross? Just this: the horizontal arm denotes the horizon, the imaginary line between heaven and Earth.

It follows that the space above it, denotes heaven or the spiritual realms. The vertical arm or bar, denotes Spirit incarnating—or going down—into matter, or the Earth plane of consciousness. This applies to every living organism, even to minerals for there is no "dead" matter; Universal Life incarnating or involving itself, in universal matter.

The figure on the cross, allegorically depicts EVERYMAN "crucified on the cross of matter." (It is interesting to note that the symbol for matter is the cube; which, if opened up forms a cross!) We are strangers on the Earth, and by being incarnated at all, are Prodigal sons, in a far country; in hell or Hades, as the Greeks taught; in Sheol; in the Underworld or Amenta of the Egyptians. Esoterically—it does not refer solely to one lone human, allegedly crucified 1937 years ago in Judea.

In the book of Revelation it is stated that "Christ was crucified in Egypt." This is a stumbling block to theologians, they cannot explain it. What, not in Judea? What a muddle, what a contradiction! But no—not if we remember that Christ refers to the Divinity in the breast of every one of us, and that Egypt really means this Earth. As usual the literal interpretation leads to confusion, whereas the esoteric, the true meaning, is crystal clear.


