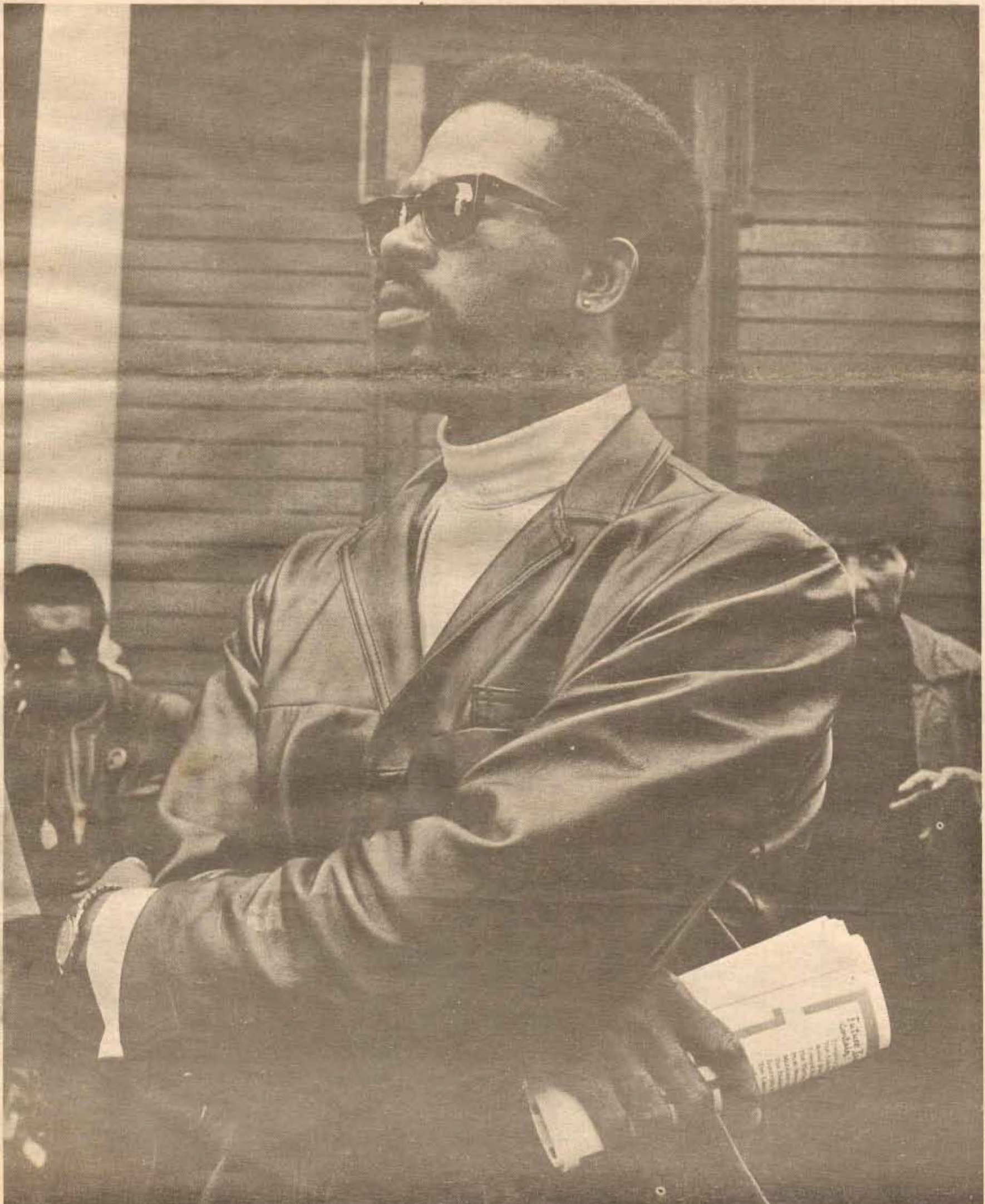

PIGS UPTIGHT: BOMB N.J. PANTHER OFFICE

The bombing of the Black Panther Party New Jersey Headquarters was just another last desperate struggle by the pigs and its racist running dogs. As Chairman Mao Tse-Tung explains it to us "Historically, all reactionary forces on the verge of extinction invariably conduct a last desperate struggle against the revolutionary forces, and some revolutionaries are apt to be deluded for a time by this phenomenon of outward strength but inner weakness, failing to grasp the essential fact that the enemy is nearing extinction while they themselves are approaching victory."

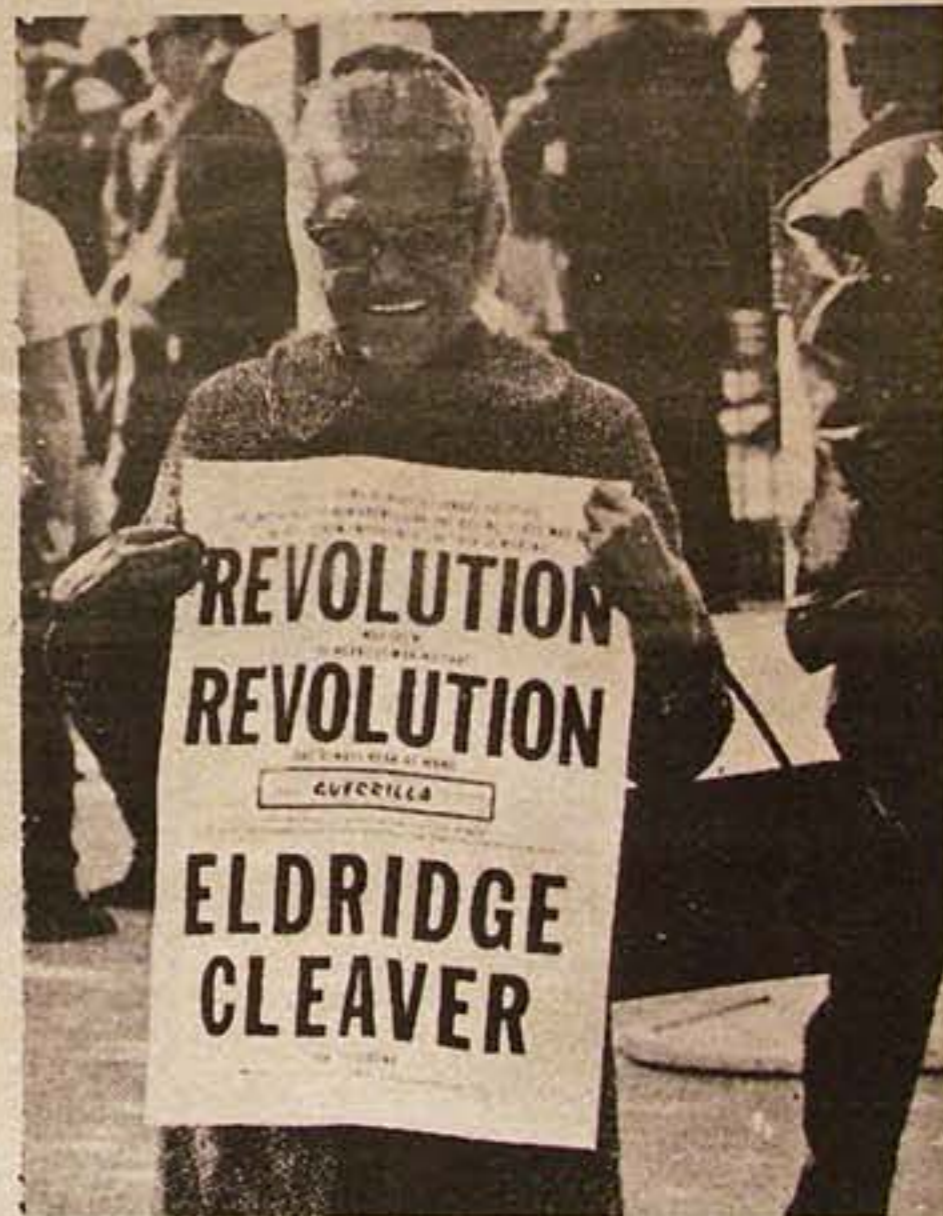
These racist dogs claim that the

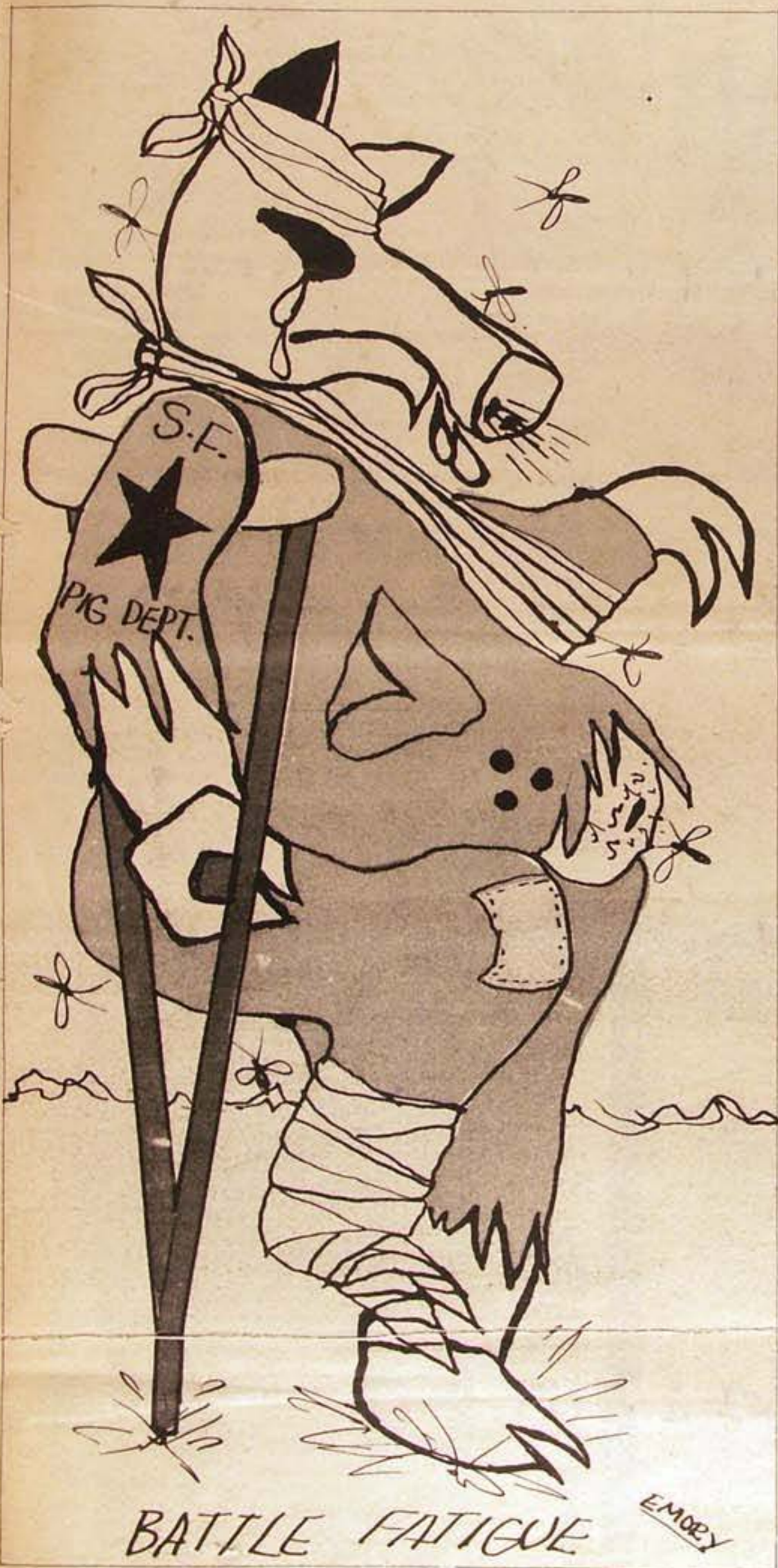

STUDENT REVOLT AT OAKLAND TECHNICAL HIGH

Gregory Harrison, Black Panther and state-wide chairman of the Black Students Union, was arrested on November 18 on charges of inciting a riot, unlawful assembly, disturbing the peace, and abusive language to teachers and administrators. He was picked up 3 days later on a warrant for his arrest. The incident was caused when the pigs swooped down on the school and unjustly arrested over 15 students for crossing the street to get some decent food from cafes surrounding the school. Some students were arrested for trying to find out what was happening. "The revolt was caused by the Oakland Gestapo Pig Department working over the school administration. This was not the only cause but it was a build up of all the frustrations that were built up in the students for a long time. In fact, just two weeks before this incident happened, 2 faggot pigs came walking through the building taking movie films of the students. I followed them out of the building and questioned them at which time one of them oinked "We were assigned here by our chief." While I was questioning one of them, two other cars pulled up and the other pig turned the camera on me. I guess they needed more pigs after they saw the students reaction to their tactic. When we brought this to the attention of the principal, his answer was, "I didn't know they were on campus." In fact, every question we asked this incompetent knuckle-head he answers "I don't know." These things have happened all through the school year; but we had found out some time before this incident happened that it was a school rule and law that pigs must check into the office before entering any other section of the building and it was obvious to us that they were illegal trespassers on our campus. Then it came to this incident in which these same vicious, gestapo, dog pigs, swooped down and hit three sides of the school at once, and arrested every student in sight. These situations in a school make it impossible for any student to participate in any school activities. This only leaves us to one conclusion. That this was not a school but it was virtually a military concentration camp. The school was not being run by our principal, because he had told us that he didn't know anything in the first place, but it was being run by Oakland's Pig Chief Gains. If you don't believe this look at the new set of rules that they have. It's costing the tax payers \$50,000 more. They told me that they were for my protection just like the two incidents I described and like the way they brutally murdered with their sham protection Bobby Hutton. The students recognized what was happening but the old dilapidated people keep telling us we're wrong. The old Toms look back to the days when they went to school. Did they have those mud-wallowing, stanky breasted, lower natured beast, gestapo pigs looking over their shoulders saying, "nigger do your work, or I'm going to put this here iron club over your nappy head!" This is the way it's still done these days. With old negro toms sitting at home on their butts saying look at that crazy new breed of young people with these foolish revolutionary ideas getting their heads busted in for nothing. More brain washed black people or plain toms! What's the choice: you sit down and your head gets busted, or you decide to defend yourself. We have decided to defend ourselves. We also know that these things are wrong.

But how can they tell us that they are with us when they are sitting back on their butts. We judge people by their actions, not by their words. All they are being is negro toms. That's how you age so quick, your mind deteriorates while you age. The next time you see me walking down the street I don't want to hear you say a thing, because you say too much. In fact, that's all you do is talk. The next time we have any type of meeting I want to see you there. If you'r not, don't say anything, because I don't have time for you. FREE HUEY! FREE ALL BLACK POLITICAL PRISONERS! POWER TO THE STUDENTS, POWER TO THE PEOPLE, BLACK POWER TO BLACK PEOPLE, AND PANTHER POWER TO THE VANGUARD."

RULES OF THE BLACK PANTHER PARTY

CENTRAL HEADQUARTERS - OAKLAND, CALIFORNIA

Every member of the BLACK PANTHER PARTY throughout this country of racist America must abide by these rules as functional members of this party. CENTRAL COMMITTEE members, CENTRAL STAFFS, and LOCAL STAFFS, including all captains subordinate to either national, state and local leadership of the BLACK PANTHER PARTY will enforce these rules. Length of suspension or other disciplinary action necessary for violation of these rules will depend upon decisions by national, state or state area, and local committees and staffs where said rules or rules of the BLACK PANTHER PARTY were violated.

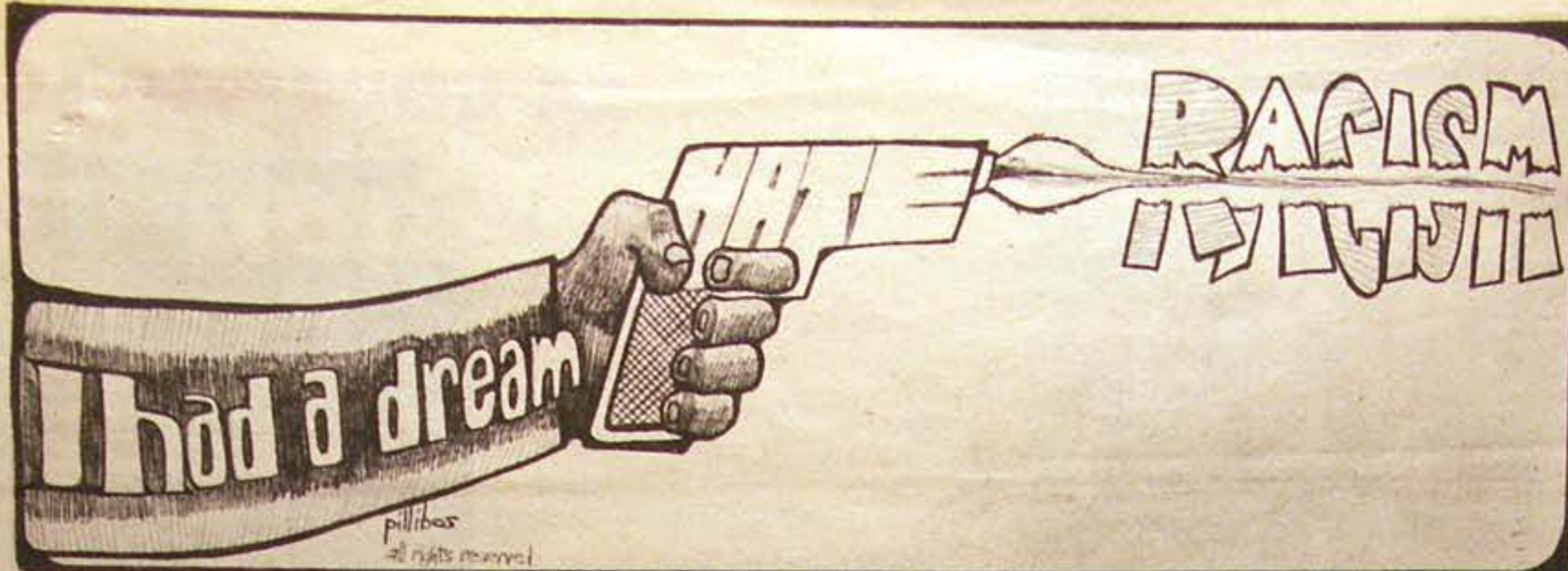
Every member of the party must know these verbatim by heart. And apply them daily. Each member must report any violation of these rules to their leadership or they are counter-revolutionary and are also subjected to suspension by the BLACK PANTHER PARTY.

THE FOLLOWING RULES ARE:

1. No party member can have narcotics or weed in his possession while doing party work.
2. Any party member found shooting narcotics will be expelled from this party.
3. No party member can be drunk while doing daily party work.
4. No party member will violate rules relating to office work, and general meetings of the BLACK PANTHER PARTY, and meetings of the BLACK PANTHER PARTY, ANYWHERE.
5. No party member will point or fire a weapon unnecessarily or accidentally at anyone other than the enemy.
6. No party member can join any other army or force other than the BLACK LIBERATION ARMY.
7. No party member can have a weapon in his possession while drunk or loaded off narcotics or weed.
8. No party member will commit any crimes against other members of BLACK people at all, and cannot steal or take from the people; not even a needle and a piece of thread.
9. When arrested BLACK PANTHER PARTY members will give only name and address and will sign nothing. Legal first aid must be understood by all Party members.
10. The Ten Point Program and platform of the BLACK PANTHER PARTY must be known and understood by each Party member, including all other material of the BLACK PANTHER PARTY.

LETTER FROM NIGERIA BROTHER:

SAYS AMERICAN PIGS DISTORT NIGERIA-BIAFRA FACTS

Dear Editor,

It was very unfortunate to read in your "B.P.", "B.C.N.S." about the wrong statements of the situation in my country, Nigeria. Your paper, the Black Panthers, has always been acclaimed in Nigeria as one of the most objective and promising news media of information to all Blacks in the world over - (along with "Muhammed Speakers").

It was really embarrassing to read about Nigerian crisis and that giving the wrong picture of it to millions of people it was also a pity that you never waited to hear the two sides in the Nigerian conflict before dashing into the press and feeding us wrongly over who aids Nigeria or the Rebels.

It was also surprising to see that you would be allowed by the stupid, Hunkies, white radicals from Berkeley and the Bay Area who profess to be true Black Man's friend in disguise and enemies to brainwash you in order to confuse you with the situation in a Black African country - Nigeria.

We Nigerians realized the importance and plights of every Black man particularly in the United States on the progress, stability, unity of individual Blacks all over the world and that is why we are fully determinate to fight even to the last Black man in my country over the rebels and their collaborators some of whom are Portuguese, Rhodesians and South Africans. It is of late that we are getting to realize that even the Hunkies in America are aiding the rebels so that Black Nigeria may be broken into fragmented states rather than joining hands together to form one and indivisible Black Nation particularly in Nigeria and in the Black world at large.

The Rebels in Nigeria determined to break away after the white Racists have promised them with backings in arms and ammunition to sustain their ill-fated regime. Without this help they

would not have opted from their father land - Nigeria. Now the Hunkies are now sending arms and ammunition, under the guise of relief materials, to the rebels to continue their struggle against the constituted authority of Nigeria. They have also sent mercenaries, pigs to fight along side with them (Rebels) against the gallant Federal Forces but to be honest, Nigeria is fully prepared against these white soldiers of fortune for we black Nigerians believe that "we have a duty particularly when the whites dabble into our affairs to perform by bringing others (some few lust for power Iboes) back into the broken family of man. In our worldhouse, in the context of the modern world, we must as Black revolutionists say, live together as brothers or perish divided as fools.

In as much as you should know that the white Hunkies in America put up Dick Tiger of Nigeria who by mistake is an Ibo man to fight after he had been defeated in the boxing ring to raise money to sustain his fast collapsing regime by acquiring more arms and ammunition to fight fellow blacks - under the guise that the Hunkies in America are very human to the cause of Black men in Nigeria leaving behind and forgetting their genocidal acts in Vietnam, and to withdraw their Law and Order to destroy the freedom and liberty of our black brothers in the United States.

Cassius Clay (Muhammed Ali) whom we all recognized as the world heavy-weight champion of the world was pulled down by the same Hunkie who professed to love Black Nigeria to fight for a cause in Vietnam which is fully unjust and wicked of any reasonable men on earth. You can now compare the attitudes of these white men, helping Dick Tiger a black man in dividing his Black country and pulling down Muham-

med Ali in his task of building a United Black Nation.

Muhammed Ali refused to witness the tournament of Dick Tiger because he does not believe in a fight stage managed by racist America to destroy Nigeria - a black promising country in Africa.

As a matter of fact, well meaning Black Americans know what is really going on in Nigeria, such as James Meredith, the rights worker and Senator E. Brooks. Both have visited Nigeria to see things themselves. Also, you can borrow a leave from "Muhammed Speaks" who everybody - at least every black man knows that it is the most objective paper of the blacks.

As I thought you should have known, the peace and Freedom Party, a predominantly radical white leftist socialist group of which you the Black Panthers do affiliated with had been in sympathy with Nigeria and have been pledging their full support to the solidarity and territorial integrity of our beloved Black Nation - Nigeria. I am sure she would never forgive you and Nigeria will never forgive you if you reflect through the wrong statements which the Hunkies had projected to some few, black greedy, lust for power Ibo groups who want to destroy their country through the help of racist white Americans, Rhodesians, South Africans, Portuguese and French.

Today in Nigeria we have millions of Ibos working happily side by side with other fellow Nigerians even the wounded soldiers of the rebel clique stay in the same hospital with the wounded Federal Nigerian soldiers, receiving the same kind of treatment. The International Observers, invited to Nigeria to watch the conduct of the Federal advance into the only remaining rebel strong-hold, Umahala now known by the rebels as the "Republic of Umuahia" pro-

fessed Federal Troops adhere strictly to the code of conduct and they fought with minimum loss of life and property.

A new Ibo leadership had been chosen to take care and to continue the running of the administration of the Ibo Community in the now East Central State of Nigeria, his name is Okpabi Asika, the most sensible and intelligent Ibo man, followed by eminent Ibo men like San Ikoku, Chike Chukwura, Administrative Secretary of the East Central State and Ben Nwogu, Nigerian World reknown Sculptor. These men together with many others of which I failed to mention here loved the black men. In Nigeria, to live together and fight together with one spirit of Black Brotherhood against any whites whose motive is to divide and rule black nations.

The only thing and the best thing now is to advise Ojukwu, the leader of the secessionists, to come back into the Nigerian Federation, for their lives and properties are guaranteed and that they should stop going to the racist countries for aid in breaking up our black nation and with this the Black people all over the world would forgive and forget the fratricidal war which the rebels have brought into our country - Nigeria.

It is with great regret that we Nigerians feel over the detention of Huey Newton whom we all acclaimed as one of the champions of Black people and not to have been released by the hooded Society of bigots, Hunkies and wicked pigs who are now showing that they love some fraction of our fellow Blacks in Nigeria under the guise of humanitarianism.

Long live United Nigeria, long live the great Panthers, Long live "Uwezo Meusi".

LETTER TO THE EDITOR:

Oakland, Calif.

EDITOR:

I am very much in harmony with the goals of the Black Panther Party, its goals and aspirations, and particularly with the ten-point program. I have visited Panther headquarters and I have volunteered my services through the John Brown Society and Dr. Shapto's medical volunteer group, and generally support the Panther's fight against white racism. In examining my motives, I believe that the primary force behind my identification with the Black man's struggle is related to the fact that I am a Jew. It is easy for me to see the relationship between Oakland Police and Nazi Stormtroopers and between all the subtle and overt examples of oppression throughout the ages against Jews and what is happening to Black people all over the world.

It is for this reason that I am extremely disturbed at what seems to me to be a clear campaign of anti-Israel sentiment expressed in practically every issue of the Black Panther News. Identifying Israel as a white racist society, identifying Arab hoodlums as freedom fighters, both seem to me to be unrealistic, unfactual, and examples of the same kind of racism that we both fight against.

I would like to know exactly what the Black Panther news items regarding Israel are intended to suggest. If you do actually intend to persist in anti-Israel attacks, then naturally I will be in a position where I must repudiate and work against you. That is not to say that I lose my interest and enthusiasm for the Black cause, but it is to say that it would no longer seem to me that you represent the dignity and best interests of Black people, and I would therefore have to find other channels for my interests. I would appreciate being corrected if I am in error, and if not would equally appreciate being told how it is.

From our brief examination of Knowland it is clear that he is the open, declared enemy of not only black people and Mexican-Americans in the city of Oakland, but of colored people throughout the world, and working people, students and all other people striving to live like human beings in this country.

Knowland is crude, overt, heavy-handed, obvious; but there is another, potentially more powerful, more dangerous enemy of the people who is quietly and insidiously gathering his forces in Oakland, preparing to challenge Knowland's right to be ruler of the city and chief exploiter of its people. From on top of his 28 story monument-building in the heart of Oakland, Edgar Kaiser has a clear view of the miles and miles of flatland ghettos, where more than 100,000 poor people are crowded together and held down by a vicious occupying police force. It is on the 28th story of this building that the Kaiser clique plots its plans for pushing Knowland aside, and running new games on the people who live in those vast slums. Unlike Knowland, Kaiser is slick, smooth-talking--although he has been known to make monumental blunders, as he did when he once impatiently told Kwame Nkrumah former head of the African government of Ghana, "hurry up and make up your mind-- you're free, white and 21." (Nkrumah, of course, is well over 21, black, and not yet free from the snares of imperialist intrigue--but we'll have more to say about this a little later).

But despite occasional blunders of this kind, Kaiser Industries, Inc., whose headquarters are in the 28 story building near Lake Merritt, is the 110th largest of the more than half a million American corporations. Its assets (total value) amount to more than \$750,000,000,000. Kaiser Aluminum and Chemical ranks only a few notches below Kaiser Industries--with a value of over three quarters of a billion dollars and sales (1967) of almost one billion dollars. Much of the Kaiser fortune is due to contracts from the U.S. government--paid for, of course, out of our taxes--which have helped since World War II, to spread the Kaiser Empire outward from Oakland across the United States and into most of the world, especially the underdeveloped and superexploited countries of Asia, Africa and Latin America. Kaiser has a crew of full-time crooks, known as "lobbyists"--the businessmen's term for their flunkies who bribe government officials--which keeps Kaiser in fight with the men in Washington who hand out the government's big give-aways to big business.

Africa has been one of the most fertile fields for Kaiser's business gangsterism. In 1958, Kaiser swung a deal with Kwame Nkrumah, then head of state of Ghana, a 30 year agreement, according to which

Kaiser built a dam on the Volta River in Ghana, and received, in return, the rights to a aluminum smelting plant, made possible by the dam. So now, Kaiser ships bauxite from Trinidad in the West Indies--where he has also penetrated--to Ghana, where he uses the smelter to convert the bauxite to aluminum at very low cost and a very high profit. This amounts to grand theft: Kaiser, Reynolds and the giant firm, ALCOA, use their monopoly power to smash Nkrumah, if he had tried to use the smelter plant for the benefit of the people of Ghana--cutting the big U.S. companies out of a big profit, Nkrumah could probably have outfoxed the U.S. companies, however, if he had been willing to pull out of the American-British sphere of influence and trade with France and Eastern European countries. This would have meant hardship for the people of Ghana, for a few years; and, even though it would have paid off in the long run, Nkrumah may have been afraid to risk it, since he had not built a mass base of support among the people and had not really involved them in the revolutionary rebuilding and restructuring of the Ghanaian economy. Still, the major crime of blackmail was committed by the giant U.S. aluminum firms.

Kaiser Industries also operate in the openly fascist country of South Africa, where the majority of black Africans are denied all basic human right and are forced to work in wretched conditions for an average wage of less than \$1.00 per day, despite South Africa's relatively high level of industrial development. No doubt Kaiser would say that by building plants in South Africa he is helping to "liberalize" the government of South Africa and make things a little better for the millions of brutally oppressed black Africans; but the truth is that things are getting worse, not better, for black people in that miserable country and Kaiser is only leading support to the murderous regime of Premier Voerster.

And Kaiser is repeating this same patter--investing in countries where the masses of people are bitterly oppressed, held in literal slavery or forced to work for slave-wages, throughout other parts of Africa, Latin America, the Middle East and the Far East, Kaiser Industries, aided by the U.S. government, works hand-in-hand with other giant American businesses and the puppet governments of most of the "third world" to make the hundreds of millions of people their beast of burden to turn out billions of dollars of profits for AMERICAN BUSINESS.

With his eye on his expanding empire throughout the world, it is not surprising that Edgar Kaiser has overlooked business at home in Oakland, until very recently. But lately, the growing resistance of black people, the organization of the Black Panther Party and the development of the black liberation to a new stage in this area, has shocked Kaiser into realizing that Knowland has made a mess of things; that the people through his game entirely; that they are not afraid to stand up to him and that they have started to get it together. So Kaiser has decided that he has to take things out of Knowland's hands, right away. He has ordered his chief lieutenants, headed by Norman Nicholson, a Vice-President at Kaiser, to run through the streets of Oakland, with a fistful of money, to find the Judasses who will sell the people out. More specifically, Kaiser has played a leading role in forming what is called the "Oakland Urban Coalition"--a group of business gangsters like Knowland, Cyril Magnin of I Magnin's and Quentin Reynolds of SAFEWAY, the third largest retail firm in the U.S., with assets of over half a billion dollars and headquarters in Oakland. These big business mobsters meet regularly with what they call "civil rights" leaders--men like, Negro Attorney Barney Hilburn, who ran as a Republican against Huey Newton in the November Congressional election. These traitors cooperate with Kaiser and the other local financial kingpins in tricking the poor people of Oakland, subjecting them to new, more clever, forms of exploitation.

Unlike Knowland, and his cronies, the "benevolent dictators" who make up the "Oakland Urban Coalition" are far-sighted. So, for example, they helped get Proposition M on the ballot and supported it, even though it would have divided the city into districts with each district having one representative on the city council, almost guaranteeing that the black community could elect two or three councilman. Their reason for supporting Proposition M... well, as one Kaiser executive admitted, in less than fifteen years, the majority of people in Oakland will be black and Mexican-American, and then they will be able to control the whole City Council, instead of just two or three seats. So by dividing the city into council districts now, the white-controlled majority on the Council can be maintained, even when white people become a minority in Oakland. (This of course assumes that all white people in Oakland can be tricked into identifying with the Kaisers, Reynolds and the rest of the exploiters, who cheat most white people, while they rob and brutalize blacks and chicanos.)

Kaiser and the rest of his big-time exploiter clique will, of course, insist that the purpose of the "Oakland Urban Coalition" and Kaiser's general interest in the black community is to help the people improve their miserable conditions--just like he insists that by going into South Africa, he is helping the black slaves there. But Kaiser's record in Africa, Asia, Latin America and everywhere else he has extended his tentacles of exploitation, makes his real intention very clear: to make as much money as he can and do just enough to keep the "natives" from getting too restless. Kaiser is very proud of allowing black people to work in his industries and of his "affirmative action" program to get a few Negroes into higher paying jobs. Kaiser executives brag about how they are helping black people, especially young kids, to become capable of "competing" for the better jobs. But will Kaiser endorse the Panther Program, demanding FULL employment for all black people (as well as whites)? Of course not: Kaiser only wants black to engage in cut-throat COMPETITION with other working people for jobs. But why should black people, or anyone else, fight like dogs for crumbs, when the wealth and technology of this country could give everyone in the WORLD a decent life? Kaiser will give a few more crumbs and a lot more sweet talk to oppressed people. But he draws the line at giving them everything they are due and everything they need and could have to live like full human beings.

It would be a very great tragedy, now, that black people, chicanos, and even many white people are finally getting hip to the game gangsters like Knowland has been running on them; if they fell for the cheap con game Kaiser is trying to put over on them, it should be clear to the people of Oakland--black, brown, yellow, red and white--that, if they want to end the misery that they have been put through, they must now rely on themselves and follow the vanguard leadership of the Black Panther Party in building a real people's movement.

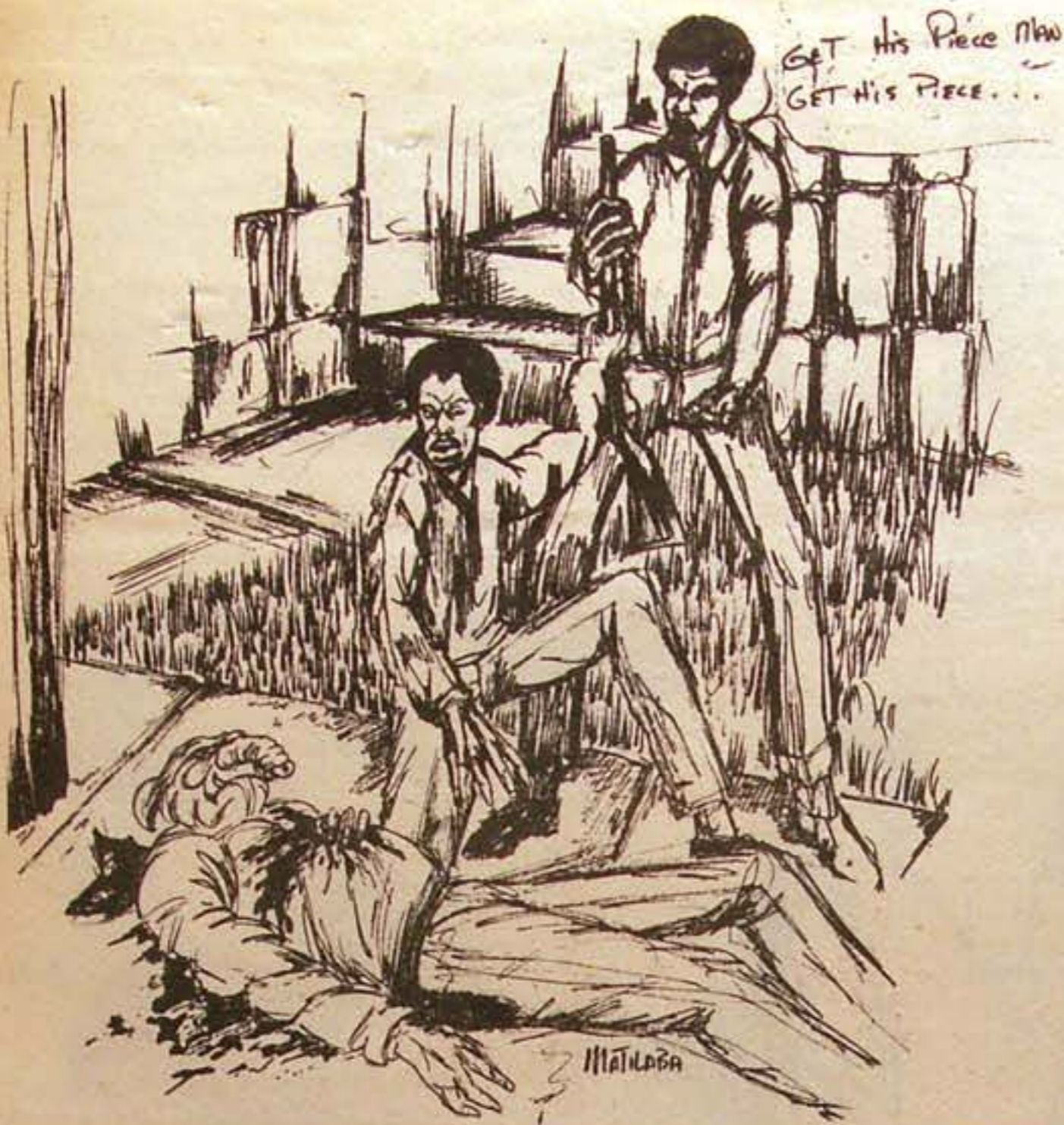

On Friday, May 19, 1967 the Black Experience held at Merritt College (Oakland, California) addressed itself to the topic "Black Culture and the Students Dilemma - Getting an Education or Getting Jived." The Black student panel, without exception, expressed feelings that the present educational structure of most schools in the United States were not meeting the needs of Black Students.

POCKET LAWYER OF LEGAL FIRST AID

This pocket lawyer is provided as a means of keeping black people up to date on their rights. We are always the first to be arrested and the racist police forces are constantly trying to pretend that rights are extended equally to all people. Cut this out, brothers and sisters, and carry it with you. Until we arm ourselves to righteously take care of our own, the pocket lawyer is what's happening.

1. If you are stopped and/or arrested by the police, you may remain silent; you do not have to answer any questions about alleged crimes, you should provide your name and address only if requested (although it is not absolutely clear that you must do so.) But then do so, and at all time remember the fifth amendment.

2. If a police officer is not in uniform, ask him to show his identification. He has no authority over you unless he properly identifies himself. Beware of persons posing as police officers. Always get his badge number and his name.

3. Police have no right to search your car or your home unless they have a search warrant, probable cause or your consent. They may conduct no exploratory search, that is, one for evidence of crime generally or for evidence of a crime unconnected with the one you are being questioned about. (Thus, a stop for an auto violation does not give the right to search the auto.) You are not required to consent to a search; therefore, you should not consent and should state clearly and unequivocally that you do not consent, in front of witnesses if possible. If you do not consent, the police will have the burden in court of showing probable cause. Arrest may be corrected later.

4. You may not resist arrest forcibly or by going limp, even if you are innocent. To do so is a separate crime of which you can be convicted even if you are acquitted of the original charge. Do not resist arrest under any circumstances.

5. If you are stopped and/or arrested, the police may search you by patting you on the outside of your clothing. You can be stripped of your personal possessions. Do not carry anything that includes the name of your employer or friends.

7. Do not engage in "friendly" conversation with officers on the way to or at the station. Once you are arrested, there is little likelihood that anything you say will get you released.

8. As soon as you have been booked, you have the right to complete at least two phone calls - one to a relative, friend or attorney, the other to a bail bondsman. If you can, call the Black Panther Party, 654-2003, and the Party will post bail if possible.

9. You must be allowed to hire and see an attorney immediately.

10. You do not have to give any statement to the police, nor do you have to sign any statement you might give them, and therefore you should not sign anything. Take the Fifth and Fourteenth Amendments, because you cannot be forced to testify against yourself.

11. You must be allowed to post bail in most cases, but you must be able to pay the bail bondsmen's fee. If you cannot pay the fee, you may ask the judge to release you from custody without bail or to lower your bail, but he does not have to do so.

12. The police must bring you into court or release you within 48 hours after your arrest (unless the time ends on a week-end or a holiday, and they must bring you before a judge the first day court is in session.)

13. If you do not have the money to hire an attorney, immediately ask the police to get you an attorney without charge.

14. If you have the money to hire a private attorney, but do not know of one, call the National Lawyers' Guild or the Alameda County Bar Association (or the Bar Association of your county) and furnish you with the name of an attorney who practices criminal law.

WACO SUES EMPORIUM

The Western Addition Community Organization (WACO) will file an Unfair Labor Practice charge with the National Labor Relations Board last month against the Emporium on behalf of two recently-discharged employees of the store.

The employees, Tom Hawkins and Jim Hollins, were fired on November 11, 1968, for distributing leaflets in front of the store on Market Street. The leaflets accused the Emporium of racial discrimination in its personnel practices and asked shoppers to boycott the store until discrimination stopped.

WACO, an activist community organization, is demanding that the two men be reinstated in their jobs with back pay, and that all employees be notified of this action. Black people and other minority persons, according to WACO, are not getting a fair shake from San Francisco employers in hiring and promotions, and they must be free to exercise their constitutional right peacefully to protest racial discrimination wherever and whenever it appears.

WACO is being represented by Attorney Jotham Pierce, Jr., of the San Francisco Neighborhood Legal Assistance Foundation.



OPEN LETTER TO PALO ALTO SCHOOL BOARD

It is time that this School Board answered questions repeatedly being asked in public and private meetings by responsible representatives of the community.

- 1) Why do you totally ignore the moral deterioration to which our children are daily exposed by the continued existence in our community of the Midpeninsula Free University? Are you not even aware that at least one member of your faculty demeans the excellence of your educational system by personally contributing to this degrading activity which represents itself as an educational institution?
- 2) Why do you totally ignore the disruptive influences to the educational excellence of our schools exerted by the irresponsible activities of such listed subversive organizations as the Students for Democratic Society, and other student groups disrupting our schools such as the Black Student Union and the United Student Movement?
- 3) Why, instead, do you address your efforts to placate militant elements, totally alien to Palo Alto, with a bi-racial program calculatedly misnamed the Multicultural Project?

If there is doubt in the community about the bi-racial aspects of the so-called Multicultural Project, may I first quote from Dr. Oliver, "The ability to win the cooperation IN SOME OF THE MORE MILITANT AREAS OF EAST PALO ALTO will be strongly impaired by not having a Negro filling this position." Secondly, may I exhibit the advertisement you are currently circulating which is captioned, "PALO ALTO WANTS BLACK TEACHERS FOR MULTICULTURAL PROJECT," and, "THE OPPORTUNITY FOR BLACK TEACHERS IN PALO ALTO IS REAL." The text goes on to read, "This multicultural program is not a 'token' attempt to employ blacks, but a unique voluntary effort to bring about significant changes in curriculum and humanistic attitudes among 70,000 children and adults in the Palo Alto community." We recall the statement which your chosen Coordinator for Multicultural Activities put forward at the Asilomar Conference to the effect that, once the Multicultural Program is underway, there will be a moratorium on the hiring of white teachers until sufficient black teachers have been hired to achieve an ethnic balance. Is such a moratorium planned? Or, is it in force at this time? What means of judging the necessary ethnic balance will be employed? Will militant negroes, or whites, be sought to provide our underprivileged children the educational experiences this school board and its administration appear to feel are so desperately needed?

Those of us who have seen our children benefit from the educational program of this district know that ours is not, and never has been, a racist community. We've seen our children's education broadened by beneficial exposure to the many ethnic minorities existing WITHIN our community. We find it incredible when we hear Dr. Oliver quoted as saying we need this bi-racial program "To cleanse our district

of any traces of racial bias or bigotry, conscious or unconscious."

Even if we were so gullible as to agree with your chosen Coordinator of Multicultural Activities that Palo Alto is racist simply because it is predominantly white, we would have to ask you, "How is the importation of this militant negro, openly advocating a racist philosophy, supposed to benefit our children?" By similar logic, do you intend to hire an active dope peddler to alleviate the drug addiction problem on our school campuses?

Now, it is time to ask the \$64 question. Is it your intention to pursue the stated objective, at Asilomar, of your chosen Coordinator of Multicultural Activities, that "What you have to do then is to adopt, annex or to absorb East Palo Alto into Palo Alto. I don't care how you do it, and I don't care about breaking laws ---." Many of us do not share his, and, apparently, your preoccupation with the problems of San Mateo County--at our expense and to the detriment of our children's education. Many of us do not relish having, as an administrative officer of our school district, a militant negro who unhesitatingly acknowledges his close association and warm relationship with other militant racists who are disrupting our nation's schools, coast-to-coast. For instance, Black Panther George Murray, lately associated with San Francisco State, was quoted in a Fresno speech as saying that the American flag was a "piece of toilet paper" deserving of being "flushed down the toilet." He also stated "All political power comes from the barrel of a gun." It is not a coincidence that this is a verbatim quotation from the Chinese communist doctrine, "Thoughts of Mao Tse-Tung". Another friend and Black Panther, Mrs. Kathleen Cleaver, stated that society must change OR DIE. Not surprisingly, this is also a direct quotation from each of Mr. Walton's public utterances, and from his single written pamphlet "Excerpts from the book, The Black Curriculum". Sincere attempts have been made to obtain any other publications he is supposed to have written. Where are they? Why does his office not make them available? Did the Search Committee request them or is it possible they do not exist?

In this same pamphlet, he writes, "the present Afro-American Studies program was built into the framework of the white school structure as an expedient measure only. Ideally black schools, black school districts and black universities are needed." Surprisingly, we agree on something. He, and those of his militant views, should have the segregated schools he desires. But, NOT IN PALO ALTO! It would appear that you have been singularly successful in provoking serious community conflict by virtue of your inept choice of an administrator espousing such radical philosophy. What do you--the school board and administration of the Palo Alto Unified School District--hope this project, in general, and this man, in particular, can contribute to our school system?

WHAT WE WANT

The program is usually divided into one section of ten points entitled "What We Want" and then ten paragraphs explaining these points in a section entitled "What We Believe." For the sake of clarity, we have put each one of the ten points in "What We Want" immediately above its corresponding paragraph in "What We Believe."

WHAT WE BELIEVE

1. We want freedom. We want power to determine the destiny of our Black Community.

We believe that black people will not be free until we are able to determine our destiny.

2. We want full employment for our people.

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed income. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all of its people and give a high standard of living.

3. We want an end to the robbery by the white man of our Black Community.

We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered six million Jews. The American racist has taken part in the slaughter of over fifty million black people; therefore, we feel that this is a modest demand that we make.

4. We want decent housing, fit for shelter of human beings.

We believe that if the white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people.

5. We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present-day society.

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything else.

6. We want all black men to be exempt from military service.

We believe that Black people should not be forced to fight in the military service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military, by whatever means necessary.

7. We want an immediate end to POLICE BRUTALITY and MURDER of black people.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The Second Amendment to the Constitution of the United States gives a right to bear arms. We therefore believe that all black people should arm themselves for self defense.

8. We want freedom for all black men held in federal, state, county and city prisons and jails.

We believe that all black people should be released from the many jails and prisons because they have not received a fair and impartial trial.

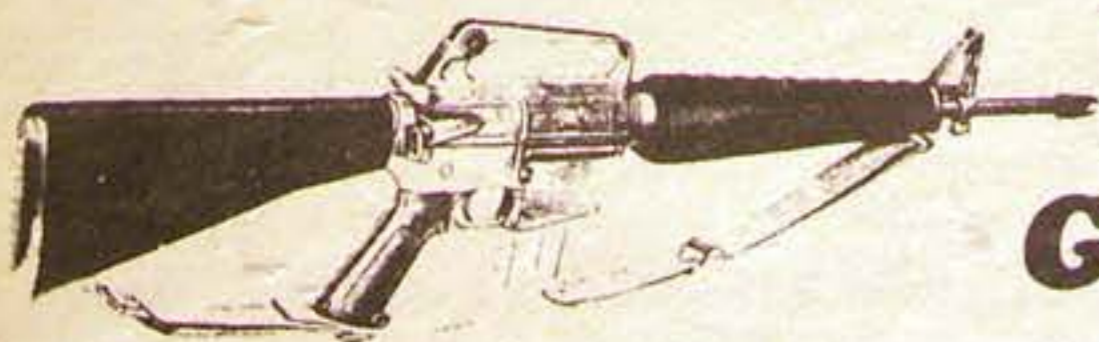
9. We want all black people when brought to trial to be tried in court by a jury of their peer group or people from their black communities, as defined by the Constitution of the United States.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a man a right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all-white juries that have no understanding of the "average reasoning man" of the black community.

10. We want land, bread, housing, education, clothing, justice and peace. And as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny.

When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume, among the powers of the earth, the separate and equal station to which the laws of nature and nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; that, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness. Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and, accordingly, all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But, when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security.
