IN TRIBUTE TO LIL BOBBY



A new day has dawned upon us. We are no longer suspended in mid-air, not knowing what to do. We are here, here with racist pigs, fascist pigs who are murdering us, torturing us and op-pressing us to a point of no return. A new day has dawned upon us, and things have changed. We are down here now and our feet are flat on the ground. We are standing here hearing the cries of the people, cries that come from a mother begging the pigs not to murder her son in cold blood, pleading with the greedy landfords not to evict her because she has no money to pay the rent on a roach infested hovel. Things have changed and we are no longer only hearing these cries, but adhering to them.

On October of 1966, a coura-geous brother heard these cries geous prother heard these cries and he came down from being suspened in mid-air. This brother, Li'l Bobby James Hutton came down and he placed his feet flat on the ground and he stood up in the midst of fascist America and vowed to all Black people-- I am here now and I have heard your cries and I will pick up the gun to defend your rights and your lives from these racist pigs that occupy our communities, that ter-

occupy our communities, that ter-rorize and murder our people. Lt'l Bobby Hutton was the very first member of the Black Panther Party. After Huey and Bobby got together, they went around in the communities and talked to the people and from this learned of their needs and desires; from this our ten point platform and program was drawn up. Li'l Bobby saw these as needs that had to be fulfilled, and when he joined the Party, he said, this is what my people want what they need and only by picking up the gun, as Huey and Bobby have done, can the people's ten point platformand program be imnted.

He was young, just 17 years old, and he began to see more clearly just what had to be done. He loved his people and he was constantly out in the communities working with the people, talking with the people, serving them when their needs called for his help. He followed the examples laid down by our Minister of Defense and our Chairman and worked with an arduous determination to do all he could to educate the people, to unite them against the fascist oppressor that lurks in the shadows like vuls waiting to drain them of what little money they had, what man-hood they had and what little life was left in them after going through they had suffered for 400 year Li'l Bobby set out to deal with the task of educating his people. He knew it would be hard but it had to be done, in the interest of the

people.

The following, a quote by Comrade Kim Il Sung, relates very much to what Li'l Bobby did in working with the people of the communities:

, "Comrade, educating and re-moulding people is really a diffi-cult task, isn't it? But we must educate and remould all people and go together to a better society. Man is most precious in the world. A Comrade must therefore love his people. We are going to built a society based on competation in the interest of the masses, for the welfare of all the people To educate and removal peop should, first of all, frust them and sincerely lave the and must know about them well. must work and live ammasses, breathe the same them and share the sweets and bitter with them.

On April 6, 1968, his life was snatched away by racist pigs. Af-ter hemming him and our Minister of information up in the base-ment of a house for more than 90 minutes, the pigs murdered him in cold blood. LL'1Bobby came out of the house with his hands up and after a volley of gunfire blazed through the air and the bullets ripping into his flesh, he lay dead, and his, just like all the other brothers that have been mur-

dered by the fascist gestapo, death was termed "justifiable homicide", He died for the people, serving the people. The pigs killed him because of this, Because they don't want people like Li'l Bobby exposing their demagogy, he had to be silenced. Li'l Bobby was indeed one of the most revolutionary men that ever walked the face of the earth and he still lives with-in our hearts. And we, the meman our nears, and we, the members of the Black Panther Party, say, "LL"! Bobby's death will be avenged, and to the racist pig cops of America, we will fight and we will gain our freedom by any means necessary." any means necessary.

EXECUTIVE MANDATE #1

On March 23rd, 1970, at 5:45 p.m. at the intersection of 24th and Columbia Avenue, a six-year-old child named Philip Green was struck by a police car driven as an excessively high rac of the community. This little-blood was struck so hard that after the car was brought to a stop, the pig driver had to reverse it to free the child from the front bumper.

The pig's excuse for driving in such a wreckless manner was that be was on an emergency and didn't see the child crossing at the intersection. It seemed that the application of common sense by this pig would have prevented the misfortune for the parents. The facts of the time of day frush hour for both pedestrians and cars), the conditions of the street) and parking on both sides of the street) and parking on both sides of the street) and the congestion of children in the area are all factors which would stress the need for cautious driving by anyone concerned with the lives and welfare of the inhabitants who populate the area.

As if this one incident wasn't

As if this one incident wasn't enough, after the pigs put in an emergency call for assistance, approximately eight more pig care charged into the area like a bunch of buils, creating the potential for another incident with the crowd of people who were gathered at the scene.

Being at the scene of the incident, the pigs were overheard to say they were taking the little brother to St. Joseph's Hospital, which was the closest, at 18th and Gerard Avenue. However, upon arrival at the hospital, we found that the emergency ward was closed to the public due to some type of so-called "financial problem".

We charge genocide! Due to the fact that this particular emergency ward and this particular hospital are used mainly by members of the Black community. The decision by the Pig hospital administrators and the pig power structure to close the, doors to the people is equal to PREME-DITATED MURDER of those people whose lives depend upon immediate medical attention by a qualified medical staff. The nurses on duty at St. Joseph's Hospital at 8th and Thompson St., approximately 15 blocks away. Everyone knows that traveling 15 blocks through rush hour traffic is a stone trip!

At St. Luke's Hospital, we found that the blood had been admitted to the emergency ward but the pig who had run him down was nowhere to be found. Two hours later, he still had not arrived! We say again that the pigpolice force in the Black community is like a foreign troop in occupied territory, showing concern only for the interests of avaricious businessmen and having no regard for the lives and well-being of the citizens of the community.

We all remember the Harold Brown inclident of West Philadelphia in which another resident of the Black community was beaten, stomped, and shot to death. Also, we cannot forget James Hamilton of South Philadelphia who fell victim to the brutalization and murderous tactics of these racist dop pigs. Now we have little Phility Green, another name added to the ever-growing list of abuses and mistreatment being waged against the people.

On Monday, March 23, 1970, the parents of the students of Ev-erett Junior High went before the police commission of S.F. to pro-test police brutality upon their children and to introduce a pro-gram that in essence said "No more pigs on or near school grounds." John Bowman (my comrade) and I were at that meet-ing and as we sat there we saw Black mother after Black mother stand up before those racist dogs and tell them that they as parents (Black parents) would no longer tolerate this type of abuse of their children. The people were out-

The pig chief of S.F. got up and oinked in the faces of the people that he is against violence and that he would like to develop bet-ter relations between the parents, students, teachers and the S.F. Pig Department. You tell me how can a (pig) police chief be nor violent?

After this foul pig (Pig Chief, Al Nelder) was all but told by the

people to cease his oinking and sir his hocks down, it was the hour of the endorsed spokesmen (Uncle Tom, Bootlickers), Incidentally all of S.F.'s bootlickers were there ranging from Rip Ridley to Nasser Shabazz. The star performer (puppet) was Rip Ridley who oinked about better Community - Pobetter lice Relations. The intentions and plans of the endorsed spokesmen are to replace the pigs who are presently patrolling our schools daily with Black security Guards from the bootlicking organizations

These are the words of George Jackson, one of three of George Jacansa, black men being railroaded for the death of a guard at Soledad State Prison in Salinas. Jack-son told his mother "not to sate Prison in Salmas. Jack-son told his mother "not to worry," but she's a mother and she does. "That's the way I raised him. . They might kill my boy but he'll never be any man's slave."

Jackson, 28, is one of three isoners accused of first degree murder in the death of the guard. His co-defendants are Fleeta Drumgo, 24, and George Chubrumps, 24, and George Cul-chette, 23. Each of the men could receive the death penalty, but in Jackson's case it is man-datory if convicted, having serv-ed ten years of a one year to life term for alleged armed robbery. At age eighteen he was convicted without an opportunity for legal counsel.

e city of Salinas is heavy the stench of exploitation, ringed with labor camps, some of them fenced and guarded a-gainst "outside agitators." Throngs of men with nothing but to their names pedroll to their names wait a chance to break their backs in the fields for \$1.65 an hour. They sleep in the weeds, the contractors buses are filled and they

This fertile and rich valley 70 miles south of San Jose was once the home of California fas-cism. The Judge has denied every defense motion in an open effort to run the case through the mill withany chance to get at the

Richar Silver, lawyer for Flee ta Drumgo rose in the courtroom March 16 to state "I allege there is a conspiracy." Neither the judge nor the D.A. denied the charge. There is no way that

charge. There is no way that a conspiracy can be denied. When the three men were first accused, their mothers were told that they were just among many being questioned. Prison offi-cials told Doris Maxwell, mother of Cluchette that "he doesn need a lawyer." Letters from the defendants were withhe "he doesn't need a lawyer," Letters from the defendants were withheld from the malls for up to two weeks. It was try sheer luck and reading between the lines that the mothers were able to get the case continued long enough to get lawyers, At the early court appearances the three men were barred from hearing one another's court testimony

even though they were charged intly. The men are held able to visit with either their mothers or the lawyers without being shackled and watched by

snacked and watched by two armed guards.

The defense was denied the right to question any witnesses but those relected by the D_A., while many of the key defense wit-nesses were hustled off to prisons in southern California make them unavailable.

Judge Campbell, and the prison authorities denied the defense the right to even examine or photograph the stairwell where the guard was killed. During the time lapse the area has been larged and reconstructed beyond altered and reconstructed beyond recognition. The court refuses to halt the construction work, let alone order the prison to re-build it back to the original state.

The Judge, in the interest of "fairness" had gagged the law-yers and defendants, forbidding any discussion of the case wit the press. He stated openly press. He stated openly e prosecution is guaranteed

"The prosecution is guaranteed the right of a fair trial." In spite of his own gag rule, Campbell ruled on Marcy 16 to give the Grand Jury trans-cript to the press. Not even D.A. had the gall to ask such a prejudicial break in the press gag. The defense was not allowed to offer proof that the Grand Jury testimony was

examination. The judge made the motion for the D.A. and over ruled all defense objections.

Jackson's counsel, Fay Stender d San Jose lawyer, John Thorne, moved to dismiss the indictment on the grounds that the Grand Jury is unconstitution-ally a 'Die ribbon committee which is wholly unrepresentative of the black, Chicano and work-ing class portions of the com-munity," they were overruled. Campbell refused to allow any hearing on the matter on the basis

hearing on the matter on the basis that the Grand Jury 'has two Americans of Nigra ancestry' amd the panel from which it was chosen "had the name of a Spanish or Mexican-Rodriguez or something like that." He wouldn't

discuss the token use of blacks, or the fact that the county had never had a Mexican-American on the Grand Jury or its com-

plete upper class orientation.
The courtroom on 3/16 was filled with more than a hundred spectators supporting the defense. fense. One of the nine armed sherriff deputies in the room said "I ain't never seen a crowd like this in a Salinas court be-After a morning of defense motions denied and the court's attack on justice the spectators refused to rise for the entrance of the judge. They remained silent and seated, rising only when the defendants were led into the room their wrists shackled to chains around their waists, and under the crotch, their legs in irons, despite all

defense objections and pleas.

When called upon for a plea guilty or not the three men of guilty or not stood mute. The lawyers ad-vised them not to make a plea, having been denied any oppornaving been denied any oppor-tunity to examine the necessary evidence. The judge then pled the defendants not guiltly and set the trial for June 22. The de-fense begged for more time to thoroughly evaluate the evidence which had been denied, and to interview over a hundred and thirty witnesses, many now dis-persed to prisons all over the state. But Campbell was ada-mant about the date. George Cluchette was sched-uled for release on April 28, Fleeta Drungo was due for a parole bearing and George Jack-son was in his tenth year of an indeterminate sentence. They all have their Ives hanging in the balance. With thair cleato examine the necessary nce. The judge then pled

the balance . With their clen-ched fists raised to all but stretching their chains they looked out at the spectators in con-fidence and faith.

Richard Silver, in his final statement to the court on 3/16 said "The interest in criminal justice is seeking the truth, not rushing to the gallows."

According to sources close to the situation, the court is rigged for a quick conviction. If the defendants are to find justice it will be based on the strength of the people outside of the sourt. If the people fail to tear the cloak of racist fascism from the ritual of the court, the lives of these three men will be wasted.



While dictating his "Requiem for Nonviolence" in the Ramparts office in San Francisco, Cleaver got a telephone call and drove over to Oakland, be the start in the essay in the middle of a sentence. I think that the so-called shoot-out on 28th Street was the direct plant of frantic attempts by the Oakland Police Department to sabotage the Black Community Barbecue Picnic, which the Black Panther Parry has set up for April 7th in DeFremery Park. The shoot-out occurred to night before the scheduled picnic. We had been advertising the barbecue picnic over the radio (KDIA & KSOL) and we had leafleted the community very heavily and put up many posters, inviting the community to come out and share in the picnic. Also, members of the Black Panther Party had been driving all over East and West Oakland in a sound truck, for a week, telling the people about the picnic and inviting them to come out.

The barbacus picnic was a fund raiser for the Black Panther Party Campaign Fund and for the Husey P. Newton Defense Fund. We were until the funds for both of these operations, We were running three candidates for public office; Husey P. Newton for Congress in the 7th Assembly District seat in Asameda County; Bobby Seale for the 17th Assembly District seat in Asameda County; and Kathleen Cleaves for the 18th Assembly District seat in San Francisco. These campaigns were being sun on less fam a shoestring, and we came up with the idea of the Barbecus picnic hoping to state a little money. Assi, of course, there was a constant assist of funds for Husey's defense. We knew that the Unished Police Department was against the picnic

We knew that the Unitaria Police Department was against the plantic because at first they tried to block clearance when we sought it from the purk authorities fo hold the plend of DeFremery Park, They follow that, but they did succeed in getting the park authorities for impose a lot of ridiculous and crippling rules upon us, such as speeches at the park, no sound equipment, no passing out of campaign literature, etc. Also, there was constant harassment of the content of the content

We had solded that whenever we staged a large fund risising event, the Coshad police would move, first, to try to prevent it frow happening then, failing that, they would arrest a lot of Party members and drais off whatever money was raised because we would then librete ball these Party members out of jall and there were legal fees. We became very aware of this. This became very clear to as when we staged the Huey P. Newton Birthday Senefit Raily at the Cakhand Auditorium on February 17, At first the Oakland police tried to refuse at the use of the anditorium on the grounds that such a really shade, be a public nutsance and create a dangerous situation. But what a lot of people don't understand is that it was also very expensive to us. Even though the riddiculous charge was dropped, the real purpose of the cope was achieved successfully; to drain away our funds through exorbitant bails and legal fees.

So, in staging the barbecue picule, we had this experience in mind, and we had cautioned all Party members to be on their best behavior in order to avoid any incidents with the police that would provide a

Here I have to bring up the name of Captain McCarthy of the Caking Publice Department, because he is one of the chief instigators within the OPD against the Black Panther Party and he has a special grade against me. When we were making the preliminary arrangements for the rally at the Oakland Auditorium, Mr. Luddekke kept urging us to get in touch with a Sergeant White of the OPD to discuss matters of security with him. Such a discussion seemed disgusting to us at fixer so we avoided it, but as the date of the rally draw nearer it was clear that it would be best if the matter were dealt with, so on either February 16th, or 17th, I can't remember which, I called the number given me by Mr. Luddekke, talked to Sergeant White, and made an appointment to meet with him to discuss the subject of security at the auditorium

Why am I alive? While at Highland Hospital, a pig said to me: "You atn't going to be at no barbecue picnic tomorrow. You the barbecue now!" Why did Little Bobby die? It was not a miracle, it just happened that way. I know my duty. Having been spared my life, I don't want it, I give it back to our struggle. Eldridge Cleaver died in that house on 28th Street, with Little Bobby, and what's left is for'ce; fuel for the fire that will rage across the face of this racist country and either purge it of its evil or turn it into ashes, I say this for Little Bobby, for Eldridge Cleaver who died that night, for every Black man, woman, and child who ever died here in Babylon, and I say it to racist America, that if every voice of dissent is stlenced by your guns, by your courts, by your gans, by your money, you will know, that as long as the ghost of Eldridge Cleaver is afoot, you bave an EREMY to your mighs.

IRON WILLED PANTHER

Reland F-eeman was shot in the bottom of the forearm by the pigs on December 8th, at central headquarters in Los Angeles. The pigs at the New County Jail put a cast on his arm two days later. They didn't set the bone or anything. A couple of weeks later. another cast was put on. He kept it on for about four weeks. The bullet severed a radio nerve-he could move his fingers and arm a little bit.

After they took the first cast off, he kept asking them if the bullet was still in and when were they going to take it out; they told him that there were thousands of people with bullets in their arms. The bullet had broken his bone and severed the nerve.

His arm was hurring real bad and a brother, Leonard Talley, agreed to take the bullet out. Instruments:

Pine - sol (Disinfectant)

Toilet Tissue Ace Bandages (for tourniquet)

Razor Blades Tweezers

The brother laid down on the bunk with brothers acting as a doctor, nurse, look-out, and some being just there. Leonard could get at the bullet but he couldn't take it out because the muscle had grown around it.

The tourniquet started hurting so Roland asked Leonard to take it off. Leonard didn't want to because Roland's arm was bleeding real bad, but did. All the brothers took a short break and started up again, tying the tourniquet again. Leonard asked one of the brother's to go get some nail clippers. About 15 minutes later, after sterilizing the nail clippers, Leonard was able to cut the bullet out, Leonard used the Pine-sol and deluded it with water to clean the wound out. He made bandages out of some toilet tissue. The bullet was flat from being in the brother for so long and moving positions. The bullet had been shot from a M-16, which left a big hole in Roland's arm. He still has a lot of tiny fragments all through his body,

The whole thing took about an hour but it wouldn't have taken that long if they would have had other tools and anestetics because the bullet had moved to

the top of his arm and was laying at the top of the skin. The brothers didn't know if everything would work out alright but apparently it did because the brothe only has a tiny scar left on his arm, Roland said that there are a lot of brothers there who have bullets in them, and that the pain gets so bad that the brothers just start moaning at night, keeping the other brothers up. Brothers like Leonard feel like if they don't do something for one another no one will, and the pigs want the brothers to keep bullets in them to remind them who put the bullets there. They have the equipment but they refuse to treat the brothers. Roland also said that taking a bullet out of someone's arm is a natural thing to do while in jail, it's happening all the time.

Roland said that since he's been out he went to see a doctor Monday and that the doctor told him that the brothers had done a good job and that his arm was healing

When planning any operation, the pigs' CMI must be taken into consideration in planning tactics. Due to the brainwashing done by TV, movies, comics etc., there are a lot of incorrect ideas about firearms that must be cleared up. The first thing to understand is, there is no one piece (gun) that covers any and all situations. Although they show pigs on TV and in the movies killing people a block away with a snub-nose .38



revolver, in reality this is not very practical and shouldn't even be attempted unless you are an expert's expert. From seeing too much Wyatt Earp and Mat Dilloo too many beopie think that if they have a band gun either pistol or revolver that they are reedy for anything. When you do that you will discover that most pig care have at least one .12 gauge pump or automatic shotgun, one or two semi-sutomatic or automatic assault rifles, one or two both-action rifles with a scope mounted for sniping purposes, and, of course, the pigs have strapped on at least one handgun either an automatic pistol or a revolver. In San Francisco, the S.F. Tactical Squad members carry two handguns, their standard service revolver plus a second handgun which is their personal preference, in many cases an automatic pistol, So at this time leff a examine these three types of weapons-the shotgun, the rifle, and the handgun.

Every Black home should have at least one .12 gauge shotgun to be used to protect the door. Use 00 buckshot and it will deal with any criminals trying to enter uninvited, Cuban guerrilas used shotguns very successfully in the revolutionary war led by Fidel Casiro. They would set up ambushes close to roads usually only a few feet away and shotguns loaded with 00 buck would have a devastating effect upon the occupants of cars and/or trucks.

On Sunday March 22, 1970, the ring leader of the local lackey force made an upen unprovoked attack against one of the little sisters in our community. This prokehop is one of the self-appointed lying spokesment for this community, but he is also an exploiting merchant (O'Neal Tire Company). Sunday, pig Everett O'Neal, (no relation to Pete O'Neal), was called to Investigate a burgiarry at the Wayne Minor Auditorium, This pig, along with the regular occupational troops in this community, proceeded to enter the auditorium, quickly capturing two of the "alledged" burgiars.

Outside of the building these young brothers were interogated, until they gave the information that the pigs wanted. At this point, seeing what the pigs represented, the people in the crowd began to throw rocks. Everett, reacting in a cowardly manner attacked Sherry Conger, 13 year old sister in the community for alleged" throwing rocks. (Witnessees in the crowd stated that the sister had never touched any object for throwing) O'Neal began to lead the little sister away by pulling and snatching her arm. The sister told this pig that she was capable of walking by herself, and that there was no need for him to do what he was doing. This coward then threw the sister against the pig car and siapped her, not once but twice. He then throw her into the pattywagon. To top it off, the sadistic White pigs began to laugh and siggle. They due seeing this 'nigger' brutalizing this little Black sister.

What We Want What We Believe

1. We want freedom. We want power to determine the destiny of our

We believe that black people will not be free until we are able to determine our destiny

2. We want full employment for our people.

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed mome. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all of its people and give a high standard of hving

3. We want an end to the robbers by the CAPITALIST of our Black Community

We believe that this racist government has robbed us and now we are We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered six million Jews. The American racist has taken part in the slavighter of over fifty million black people; therefore, we feel that this is a modest demand that we make

4. We want decent housing, fit for shelter of human beings

We believe that if the white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people.

5. We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present-day society

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything

6. We want all black men to be exempt from military service.

We believe that Black people, should not be forced to fight in the mifitary service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military, by whatever means necessary.

We want an immediate end to POLICE BRUTALITY and MURDER of black people.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The Second Amendment to the Constitution of the United States gives a right to bear arms. We therefore believe that all black people should arm themselves

8. We want freedom for all black men held in federal, state, county and city prisons and jails.

We believe that all black people should be released from the many jails and prisons because they have not received a fair and impartial trial.

We want all black people when brought to trial to be tried in court by a jury of their peer group or people from their black communities, as defined by the Constitution of the United States.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a many right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all-white juries that have no understanding of the "average reasoning man" of the black

10. We want land, bread, housing, education, clothing, justice and peace. And as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny

When, in the course of human events, it becomes necessary for one

When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume, among the powers of the earth, the separate and equal station to which the laws of nature and nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; that, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it and to institute a new government, laying its government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness. Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and, accordingly, all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But, when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under abolute despotism, it is their right, it is their duty, to throw off such governsolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security.

RULES OF THE BLACK PANTHER PARTY

NATIONAL HEADOUARTERS BERKELEY, CALIFORNIA

Every member of the BLACK PANTHER PARTY throughout this country of racist America must abide by these rules as functional mem-bers of this party, CENTRAL COMMITTEE members, CENTRAL STAFFS, and LOCAL STAFFS, including all captains subordinate to either national, state, and local leadership of the BLACK PANTHER PARTY will enforce these rules. Length of suspension or other dis-ciplinary action necessary for violation of these rules will depend on national decisions by national, state or state urea, and local committees and staffs where said rule or rules of the BLACK PANTHER PARTY WERE VIOLATED.

Every member of the party must know these verbatum by heart. And apply them daily. Each member must report any siolation of these rules to their leadership or they are counter-revolutionary and are also subjected to suspension by the BLACK PANTHER PARTY.

THE RULES ARE:

- No party member can have narcotics or weed in his possession while doing party work.

 3. No party member can be DRUNK while doing duity party work.
 4. No party member will violate rules relating to office work, general meetings of the BLACK PANTHER PARTY ANYWHERE.
 5. No party member will USE, POINT, or FIRE a weapon of any kind unnecessarily or accidentally at anyone.
 6. No party member and join any other army force other than the BLACK LIBERATION ARMY.
 7. No menty, member can be a second or the party member of the party member

- No party member can have a weapon in his possession while DRUNK or loaded off narcotics or weed.
- BRC YM or touted off narcolics or weed.

 8. No party member will commit any crimes against other party members or BLACK people at all, and cannot steal or take from the people, not even a needle or a piece of thread.

 9. When arrested BLACK PANTHER MEMBERS will give only name, address, and will sign nothing, Legal first aid must be understood by all Party members.
- 10. The Ten Point Program and platform of the BLACK PANTHER PARTY must be known and understood by each Party member.

 11. Party Communications must be National and Local.

 12. The 10-10-10-program should be known by all members and ulso understood by all members.

 13. All Finance officers will operate under the jurisdiction of the Ministry of Finance.

 14. Each person will submit a report of daily work.

 15. Each Sub-Section Leader Section Leader, Lieutenant, and Captain must submit Daily reports of work.
- Caplain must simmit Dairy reports of work.

 16. All Painthers must learn to operate and service weapons correctly.

 17. All Leadership personnels who expel a member must submit this information to the Editor of the Newspaper, so that it will be published in the paper and will be known by all chapters and branches.

 18. Political Education Classes are mandatory for general member-
- 16, Phinical Foundation of the personnel assigned to respective offices each day should be there. All others are to sell papers and do Political work out in the community, including Captanis, Section Leaders, etc.
 20. COMMUNICATIONS all chapters must submit weekly reports in writing to the National Headquarters.
 21. All Branches must implement First Aid and/or Medical Cadres.
