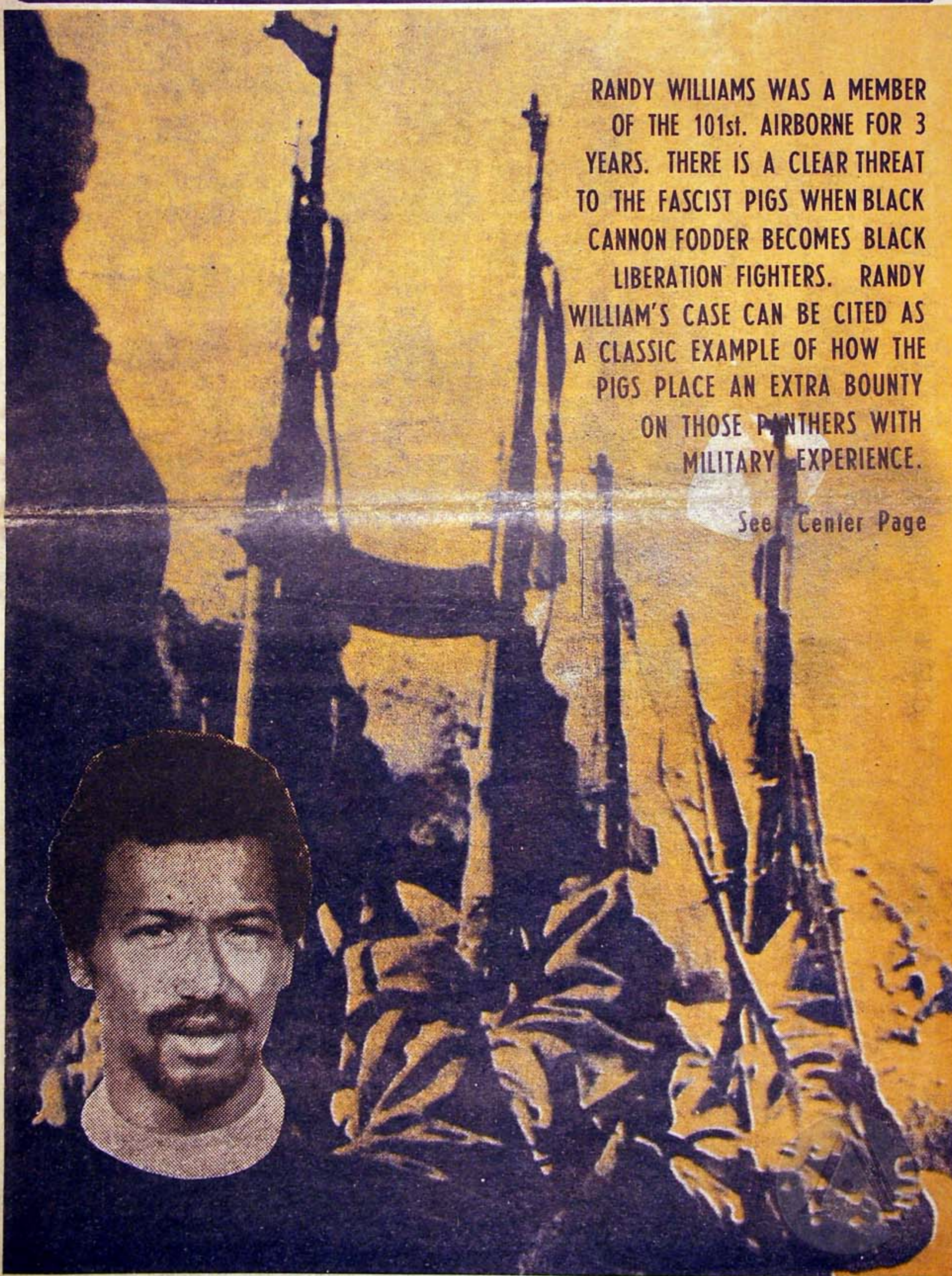

RANDY WILLIAMS: REVOLUTIONARY

Pigs allege that Randy and two other persons ambushed four gestapo pigs Friday night (April 17th.) in East Oakland and that as a result a high speed chase took place that left four gestapo pigs wounded.

Although Randy was arrested on Friday his wife was not allowed to see him until Tuesday afternoon. An attorney who attempted to see Randy was finally successful after a lengthy run-around. During the run-around the attorney was told by pig Sgt. Mast that, "If I had been down there you wouldn't have a client to represent." Sgt. Mast was eventually unable to prevent the attorney from seeing Randy and discovering that Randy had a badly swollen face, both eyes puffed and unable to focus, lacerations of the scalp, a badly gashed lip, a numb and swollen right arm and a broken and lacerated nose that the Pig Dept.'s Internal Affairs Unit claimed to be investigating. It was also learned that Randy had been denied pencil and paper, medical treatment, visits from a non-jail doctor and had been kept in a near nude state in a cold cell for three days. The pigs probably hoped he would catch pneumonia and die after they failed to beat him to death. After a Black pig judge (Brounner) refused a court order that would permit Doctor Fink (a leading research neuro-surgeon) to see Randy, a pig doctor made a quick visit to Randy's cell on Monday and prescribed penicillin every six hours and some eye ointment. Randy received no medicine until Tuesday. As a final attempt to add insult to injury the pigs approached Randy's attorney and requested permission to interview Randy about the origin of his "mysterious" broken nose. As the attorney was not the kind of man to hire burglars as bank guards or child-molesters as baby-sitters the request was refused. The pigs attempted to interview Randy anyway.

COUNTER-ATTACK

In Watts, in 1965, a man, Leonard Deadwyler, was driving his pregnant wife, who was in labor, to the hospital. He was naturally anxious to see her deliver their child with as much ease and care as possible. Leonard Deadwyler drove with all speed to see that his wife got to a hospital where she could be cared for. Leonard Deadwyler was killed for having felt and acted upon the natural urgency of any human being to care for another, especially those close to him. He was shot down by Los Angeles fascist pigs because he disobeyed some traffic laws. He was shot down by racist dogs because he was a Black man. The pig who shot him was said to have committed justifiable homicide.

In the 1950's 15 year old Emmett Till was going to the store in Mississippi to purchase something. He had come to Mississippi from Illinois to visit his family. And he was glad to be there with them. He was responding in a natural way to those feelings. Possibly he walked to the store idly wistling. A White woman claimed that he wistled at her. Emmett Till was killed because a White woman said that. Emmett was lynched, burned, shot, tied to chains and dropped into a river. Emmett Till was murdered by mad, vicious racists because he was just another nigger. No one ever paid the price for Emmett Till's life.

In the 1930's nine young Black men in Alabama were accused of raping a White woman--the Scottsboro case. Eight of them were lynched before this woman admitted they had done nothing to her. Everyone agreed it was a terrible mistake. No one even went to trial for the deaths of those eight young brothers.

In 1968, a young brother, a member of the Black Panther Party, 17 year old Bobby Hutton, was on his way to help prepare food for a bar-be-que for the people. He was riding in a car with Eldridge Cleaver, the car stopped and suddenly they were surrounded by fascist Oakland pigs. After a battle that lasted over an hour, Bobby and Eldridge came out of the house they had ran into for protection from this attack. They came out hands in the air, without weapons. Bobby Hutton was blasted by pig shotguns over 17 times and his hands still in the air when the first blast hit. It didn't take much time to kill Lil' Bobby. But the dogs who committed this murder did it with vigor and commitment. A coroner's jury declared the murder of Bobby Hutton justifiable homicide.

In 1968 a sniper's bullet killed non-violence in the form of Martin Luther King. Martin Luther King was killed because he was a Black man. Martin Luther King never even suggested that we use violent means against those who have been most violent in their oppression of Black people. Yet, he was violently, viciously murdered by a racist dog on orders from the insane government power structure of Babylon. A scapegoat was sentenced to life imprisonment for that

murder. Murder usually carries the death penalty.

In December of 1969, Deputy Chairman of the Illinois Chapter of the Black Panther Party, Fred Hampton, while asleep in his bed was violently murdered by gangsters who later claimed to be police officers. Fred Hampton's death was declared by those in power to have been a justifiable homicide.

The history of Black people is a history of blood, death, slavery and dehumanization. A history of hangings, beatings, burnings, rapes and shootings. A history of oppression perpetrated upon us by a racist structure of greedy men. We say that we know that. But how long can we repeat, "how long?" When will we overcome abstractly saying, "we shall overcome some day?" There is nothing left to us. There is no number of pigs' lives that will ever justify the horrors of our experiences in Babylon. There is no number of lives of the racist oppressor that will remove the mark our history has made upon us. So it shouldn't be necessary to rhetorize on the oppressive, dehumanizing horror that has been the history of Black people: Millions of our people murdered in a nightmare that was real, while being transported, by unknown people to an unknown place to labor forever for free; thousands murdered during chattle slavery; thousands more dying of starvation; indecent living conditions; murders by the enforcers of the law with or without a sanction of the law; deaths in jails and prison farms for the crime of being a nigger in a land that never really allowed for our existence; or just dying because there was nothing left to do or be.

But that is history. The insult is that it is not. It is today: Black children dying of malnutrition, starvation and od easily cured diseases; Black women scrubbing floors in big plantation-like houses for less than enough to exist on; brothers being sent to do long terms in prisons for the crime of having never understood how to take what they needed; Black people being an irrelevant body of human beings to be laughed at, shot at by fools who masquerade as our protectors, and finally to be ignored when we simply say - stop.

So we say that Black Panthers are what history demands. Black men and women in the streets with guns is what history demands and requires. Our history in Babylon dictates that we should come to no other point in this time and place (It is only amazing that this point was not reached sooner). It is necessary for our very survival to kill policemen - those with whom we are in most immediate contact and who attempt to determine our destinies on a day-to-day level; it is necessary that we kill mayors and governors and senators and judges and cabinet members and vice-presidents and presidents and big businessmen--all those who have really brought us to this point and who never knew in their madness and greed that

we would have come to this point.

So we say right on to the broghtrs and sisters who have picked up guns to lie in wait for those who've murdered and maimed us for centuries; right on to Black men and women who snipe at marauding gestapo pig cars; right on to Black people - any people - who are bombing courthouses and banks and jails or any strongholds of the oppressor; right on to Black families who are arming to protect their homes against vicious attacks by foreign occupation troops. BOBBY SEALE'S LIFE

"We hold these truths to be self-evident, that all men are created equal: That they are endowed by their creator with certain unalienable rights: That among these are life, liberty and the pursuit of happiness...But when a long train of abuses and usurpation, pursuing invariably the same object evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security."

This is what America is about; this country and its agents of deceit have been upholding the crimes of the Nixon-Agnew-Mitchell regime for too long. The pig power structure has perpetrated the foulest acts in history against the peoples of the whole world. But in order to commit these dastardly acts against mankind the pigs had to have a slave at home to step on in order to make its enormous profits off the people. This slave is none other than the American people in general and the poor oppressed Black people in particular. Ever since the inception of this fascist state, because this fascist government has to oppress to exploit, it forms the negation of itself by the resistance of those it oppresses to exploit. This fact is seen from the history of this country and particularly from the history of the most exploited people.

This country has had to oppress to exploit, the most revolutionary people of the world, Black people. From 1610 to 1970 oppressed people in this country have rebelled in one form or another and the most implacable resistance has come from the Black people. We have always fought and we will always fight a life-death struggle until the entire world has peace

from the pigs that exist on this earth, especially the pigs of the finance capital, military-industrial complex of the U.S.A.

To investigate the history of this country correctly and analyze the truth from the facts, in a dialectical manner, you will see that the rebellions that were most successful and inflicted the most damage upon the enemy were those that were fought by men and women who had an ardent desire to see their people free. Black people have had the experience of having Nat Turner, Toussaint L' Overture, Malcolm X and now Huey P. Newton and Bobby Seale lead their just struggles toward victory, and now, as was in the past, the oppressor wants to see our leaders dead and buried, but the Nixon-Agnew-Mitchell regime fails to see the historical experiences of Black people because if these fool-headed punks did, they would know that the struggle has progressed from a lower level of spontaneous rebellion to organized, planned counter-attack, by all means available. This means that if the pigs persist in their foul deeds against the peoples of the world and their pre-planned attempt on Comrade Bobby's life, then the peoples of the world, externally and the oppressed people internally will take your hydrogen bomb, your M16, your 357 magnums and take your life along with those who silently endorse and openly oppose the total liberation and freedom of Black people.

The pigs with their degenerate propaganda machine, the mass media, think that Black people can't see for looking. But we know that Comrade Bobby has dedicated his life for the freedom of all oppressed people and Black people particular-

ly. By his practice we have seen that to follow the path he has directed is to move in a revolutionary fashion to free Black people. So pigs of the power structure, Nixon, Agnew, Mitchell, Hoover, Minute Men, Ku Klux Klan, we see through your lame jive games and your time is up. You either release Comrade Bobby, so that the liberation struggle in America can pursue the correct road--a class struggle--or you die a cold death, along with those so-called 'White revolutionaries' who claim that they are down. Because pigs, the play is over and the last act is going down now and your time has passed.

Comrade Bobby Seale's life belongs to the people and he will be returned to the people or the people will counter-attack and take your life.

WHEN THE STUFF COMES DOWN, WHERE WILL YOU BE

This is a call from the International Committee to Defend the Panthers, New Haven, Connecticut, U.S.A.

The struggle against U.S. imperialism is a world-wide struggle occurring on many fronts, and finding its highest expression in the victorious struggle of the Vietnamese people. However alongside the genocidal war against the Vietnamese, the American ruling class has been intensifying its longest war against Black people. This war has been less visible. Its borders are within the Imperialist heartland, and the total arsenal of weapons that the ruling class has at its disposal to keep the White people down has been reduced vis a vis Black people, as with all col-

onized people of color, to one weapon: the GUN Against Black people, it is the Gun alone which prevents Black people from their liberation.

It is only within this context that the revolutionary development of the Black Panther Party and its savage repression by the ruling class is comprehensible.

The systematic attempt by the ruling class to wipe-out the Panthers through assassination (28 Panthers killed by the police), through exile (Eldridge Cleaver) and prison (hundreds, from Huey P. Newton to David Hilliard and Emory Douglas) is their response to Black people organizing, picking up the

gun, and dealing with their liberation.

The Black Panther Party recognizes as do all Marxist revolutionaries that the only response to the violence of the ruling class is the revolutionary violence of the people. The Black Panther Party recognizes this truth not as some unspecified mechanistic Marxist-Leninist truism, but as the basic premise for relating to the colonial oppression of Black people in the heartland of Imperialism where the White ruling class, through its occupation police forces, agents and dope-peddlers, institutionally terrorizes the Black community. STATEMENT OF JEAN LUC GODARD

Tonight at the Yale Law School auditorium, Jean Luc Godard, speaking to over six hundred students, faculty and members of the New Haven community affirmed his support of the Black Panther Party.

"I came to New Haven because it is now the focus of the repression of the Black Panther Party in the United States. Here Bobby Seale and the New Haven Panthers are on trial for their lives.

"It seems to me, also, that the outcome of this trial will very much effect the Panthers' effort to make a class struggle instead of a race war in this country.

"United States political leaders are trying to destroy the liberation struggle of the people of Viet Nam, Latin America and Palestine, as

well as in my own country.

"You expect me to speak to you of films, of my movies, but because we are no longer concerned with plastic images, but with revolutionary images we are now involved in this struggle.

"You must all participate in the political actions in this city, not just as individuals, but as members of a society struggling against the rise of fascism. Those of you who are students at Yale must join the strike and back the demands for Panther support here and all of you must join the national rally on the New Haven Green on May 1, 2, and 3.

defensive moment of picking up the Gun, as the condition for ending the pigs' reign of terror by the Gun. Black people picking up the gun for self-defense is the only basis in America for a revolutionary offensive against Imperialist state power.

The attack against the Black Panther Party by the ruling class is an attack against all Black people because the Black Panther Party represents the most highly conscious element of Black people.

The very fact that the ruling class has been capable of openly and arrogantly wiping out the Black Panther Party, the very fact that there is a trial and Bobby Seale is a political prisoner is an index of the extent to which Racism makes United struggle against Imperialism virtually impossible, domestically. Within the mother-country, the class struggle has reached an impasse. It is because of this impasse where independent class struggle is not possible at

this time that the Black Panther Party objectively represent the American proletariat.

Therefore the defense of the Black Panthers is an international priority of all progressive forces against U.S. Imperialism, it is especially a priority for us in the secondary metropolis of Imperialism, Britain, France, Italy, Germany, Scandinavia and Canada because the condition for taking independent class struggle to a higher level can only be the active defense of the Black Panther Party.

Vietnam on the outside, New Haven, Connecticut U.S.A., on the inside: these represent the two focuses for global class struggle at this time. The trial against the Chairman of the Black Panther Party is the INSIDE focus because the ruling class has decided to play out its hand in a Race War unless the people and especially we on the outside prevent the assassination of Bobby Seale in the Electric Chair **BY ANY MEANS NECESSARY.**

ON SPECIALIZED REPRESSION

On April 14, 1970, two members of our Party drove the Chief of Staff, David Hilliard, Jean Genet, the French writer and myself to the New Haven courthouse to observe the racist pre-trial court hearing in the trumped up murder charges against our Chairman, Bobby Seale and 9 other members of our Party; and to meet our attorney Charles R. Garry. At the courthouse we met the Area Capt. of New Haven, Doug Miranda. We all proceeded to walk up the stairs to the courthouse door, where we were greeted by New Haven's finest pork chops, the New Haven State Pig Dept., who made an attempt to refuse the Chief of Staff, David Hilliard, Doug Miranda, Jean Genet and myself entry into their courthouse, by sticking big axhandles in front of our path, at the same time they were oinking in our faces, asking us what business did we have to attend to inside their pig pen. Never breaking our pace, we walked through the barricade of flesh-hungry pigs, with axhandles and guns in their hands, stating that we had an appointment with our attorney, Charles R. Garry.

We walked down the hallway about 50 feet to the courtroom door, where we were greeted once again by oinking pigs with axhandles and guns in their hands. Never breaking our pace once

ple out of 15 spectators were asked to leave the courtroom, while 8 pigs stayed seated in the spectators' chairs, oinking at the people. We re-entered the courtroom, sat down and observed the courtroom proceedings of the D.A., who was playing the role of Georgie-boy Wallace to the big business judge, who oinked from behind home plate.

At this time Doug Miranda had to leave for Boston for a speaking engagement. So me, David, and Genet sat for about an hour, watching the fascist court proceedings, to see who would win the blue ribbon as the prize pig-the D.A. or the judge, both of whom were oinking one thousand. A big stone-age pig, who looked as if his role was that of the clean-up pig, came and stood next to David's seat, with his big nose pointed down at a letter that David and I were reading. We didn't know that this pig was there until we had just about finished reading the letter: this pig began to slobber at the mouth and onto the letter that David was holding in his hand. At this time we looked up, and David asked this pig what he was reading our material for. All this pig could say, out of embarrassment from being caught dirty, was oink, oink, oink. David stood up to protect himself before the pig could attack him. This stone-age

For years the lamentations of revolutionaries have been heard at rallies, in assemblies and meetings of every kind, crying and warning about the fascist pigs. Somehow these warnings have had the aroma of half-truths, or prophecies and speculations. Reality has slapped the Movement dead in the face and has literally knocked the people senseless. Our troops have become and continue to be decimated, the jails are overflowing with our comrades, the semi-faithful have vanished into the pseudo-security of bourgeoisie niggerism and psychedelic, vibrating drugs. While out of the shadows of the pre-dawn hours come highly trained, disciplined, efficient, well-equipped, professional teams of mad racists from the infamous Los Angeles Police Department.

Their names sound efficient and secret. These crazed, creeping, brainwashed, automatic, cloak and dagger goons go under names such as SWAT, SIS, CCS, TAC, AND METRO. Backed up by their network of spies, undercover pigs, and jelly-spined informers, their professionalism cannot be questioned, but their efficiency is due only to the amateurish nature of the people's forces. The very things of which we have warned each other for years are now reality.

It is no longer speculation when one hears of a brother's door being kicked down by glassy-eyed ghouls with automatic weapons--that they love to use--in the wee hours of the morning. No longer is it merely romantic imagination when a brother says that there are agents among us. That shotgun or carbine in the corner can no longer be used as decoration, or as an item to impress a sister of your heroism; it is now a death warrant, whether you use it or not. If you don't use it, these hand-picked, foaming-mouthed, wild-eyed assassins of CCS and SWAT will place it in your hands, after you are DEAD.

Who are these hand-picked maniacs, so reminiscent of Hitler's Gestapo and SS Corps? They are groups of dedicated, mad racists who are not playing. The rhetoric about not expecting justice or mercy from the racist enemy is now concrete reality. They are trained to kill and are efficient with it. Insanity and passionate hatred for Black people is undoubtedly a criterion for choosing them. They ride in unmarked cars, are unshorn and tacky in appearance and their glassy eyes reflect their lack of sleep and their willingness to put in long hours of dogging the servants of the people.

SWAT (an insulting term that implies spanking) means SPECIAL WEAPONS ASSAULT TEAM. These

weapons are AR-15's sub-machine guns, grenades, grenade launchers, tear gas, explosives, and other tools of death, including the internationally-outlawed Stoner rifle, that is reputed to penetrate stone walls.

TAC is ostensibly special tactical squads, organized, trained and equipped to try and deal with any explosive situation amongst the people quickly and in deadly style, while the buffoons in the Black and White patrol cars continue their dispersed patrols in all parts of the city, so as to avoid concentration of troops in one area and thinning out in others.

METRO or vice squad may be somehow intimately linked with TACK squads or under the same department. They are known for raids. In and out of uniform they ride in unmarked cars, and have been known to ride in tow trucks to TAXI CABS.

CCS (Criminal Conspiracy Section) are the slinking snakes who are masters of the frame-up. These lunatics sneak about the city trying to persecute brothers for merely organizing among the people or for associating with one another. After any type of political activity in the city, you can be certain that these dogs are out trying to create conspiracy charges against those who work the hardest.

SIS or SIU is a group of slap-happy, cracker-jack spies and informers. The noise on your phone or the television-type detective, reading the newspaper in the car across the street from your house, is very likely from this group. From information available, their jobs seem to be infiltration and surveillance of the Movement. They cooperate closely with the FBI, CIA, and the intelligence groups from other city police departments. Files are kept of all known political activists. We also tend to believe that these cloak and dagger fiends constitute the nerve center of the purely anti-Movement arm of the pig forces.

If tomorrow morning you hear a loud bang at your door, and as it flies open, lights hit you and a voice shouts, "Don't move nigger", and you open your eyes to behold wild-looking, glassy-eyed maniacs standing above your bed holding every type of weapon mentionable, you can be sure that the stuff has hit the fan! Amateurish moves are out of the question. In fact, it will be welcomed by these creatures of the pre-dawn hell.

The fact is that the next and last thing you see will be fire spouting from the muzzles of twenty weapons. The presence of your woman and/or baby is of no consequence to these crazed monsters, with brains

shorted out and programmed only to "KILL, KILL, KILL".

Amateurs, boys, girls, half-hearted pseudo revolutionaries, bleary-eyed dreamers, and trusters in blind justice will not do. The Black community is staggering under repeated blows from a group of hand-picked perverts who glory in the murder of innocent people. These fiends are trained and programmed to kill. Their minds shorted out in the face of reason. All they see is a target...your heart and head are the bulls-eye.

These groups have one purpose and one purpose only: political assassination and incarceration. They are dedicated to the sole purpose of crushing the Movement by any wicked means at their disposal. Execution of sleeping revolutionaries is their favorite method. They have already broken down many doors and entered people's homes with guns blazing, giving no warnings and without so-called 'legal cause or provocation'.

The people must realize that the pigs in the black and white patrol units that you see on every corner in the ghetto are the least of our worries. They constitute possibly a third of the concentration of police in our community. The unmarked cars, taxies, tow trucks, Cameros, Mustangs, beat-up cars, the multi-colored cars of the TAC and METRO Squads, the Mod Squad, SWAT, SIS, CCS, informers, community traitors who co-operate with these forces, the Highway Patrol, motor cycle patrols, FBI, all add up to a lot of pigs, most of them invisible as such.

The advent of the popular 'Rent a Cop' has freed the city pigs of much of their responsibility in the protection of merchants. Their sole responsibility and purpose has therefore shifted to political oppression, as the emergence of these specialized teams indicates. The rent-a-cops also enable the pigs to be more mobile and cover greater distances. This is one of the bases for the phenomena of seeing more police cars in motion, and, the reason so many goons were available to form SWAT and the other special divisions.

They have mobilized against the people. This repressive apparatus is shifting into high gear, but is by no means operating without efficient use of time. Remember, their efficiency is due to our inefficiency. You know what must be done, and you must immediately set about doing it.

again we walked through the oinking pigs into the courtroom, where our attorney Charles R. Garry was. Inside the courtroom there were 15 removable chairs for spectators-half of those were being occupied by pigs trying to pass off as people-but you can always tell a pig by the slobber running down his big ugly jibbs at the sight of a revolutionary. There were 4 Black students in the courtroom who gave up their seats, knowing that me, David and Genet were only going to be in New Haven for a couple of days - we thought.

We sat down to observe the racist court proceedings. Five minutes later, the pigs asked all of the spectators to leave the courtroom, because they forgot to search me, David, Genet and Doug before entering the courtroom. They told us that they wanted to be sure that we didn't have any dangerous weapons or explosives in our possession. Only seven peo-

pig then began to push David. At this point I rose from my chair to help my comrade, letting this pig know, through our physical actions, that an attack against one Panther is an attack against all Panthers.

A couple of seconds later it began to rain pigs from the pig pen. We were choked, arms twisted and shackled like slaves. At this point this big business judge, who was hiding behind home plate, decided to show his big, fat, flabby face, looking very nervous as if he was about to have a stroke from too much heat. This time he was in the disguise of a vulture, administering injustice of six months in jail to me and David for defending ourselves.

We say that it wasn't a bad thing, but a good thing. That shows the American people and the rest of the world the racist mentality of the U.S. government.

The New Trick

Richard "Mealy Mouth" Nixon has done it again; the latest in his bag of tricks being the "New York Plan." This plan is supposedly patterned after the "Philadelphia Plan", promulgated by the labor department last year in which building contractors make efforts to hire a certain percentage of minority-group workers in federally financed projects. Peter Brennan, a well known racist, and president of the building and construction trades council of New York is an ardent supporter of this plan for he knows fully well that this so-called "plan" is really the perpetuation of racism in the building trades. What in essence

it means is that Black skilled craftsmen, who have because of racism been kept out of unions all their working lives and are thoroughly qualified to do the work, can be assigned to a six month, \$80 a week pay, and after the training period be no nearer to becoming union plumbers, electricians, pipe fitters, etc.

This is a cruel hoax to play on Black people and other minority people projecting it as being helpful and a means to union membership and most important of getting good paying jobs. Most journeymen in the craft unions did not go up the ladder through programs such as this but rather got their training

on the job. Since the trade unions in New York are practically lily white, this would apply to 70% of White workers. Moreover White workers do not have to be promoted work through "special programs" and then spend four or five years as an apprentice; they learn by doing--it is only the Blacks and other minority workers who must serve an apprenticeship. Black people are at a stage in history when they can no longer afford the "luxury" of not confronting racism...THEY MUST SEIZE THE TIME!

Basically an education passes the heritage, learnings, the wisdom and the technology of human history to the coming generation"- Eldridge Cleaver

This capitalistic society instills its corruptive heritage, its misinformation, its so-called wisdom and the mass technology of its inhumane deceit into the minds of our future leaders. The main tool it uses is the present school system.

The law states all children must attend school between the ages of 5 through 16. The results are misinformation; how to be a capitalist or how to support them. Schools have been set up and economically supplied by pigs whose survival relies upon the way that future generations relate to their surrounding conditions. The road that the youth will take depends upon the manner in which his surrounding conditions are interpreted. If the youth see reality-the oppression and exploitation of all of those who are used to produce and buy the materials for the pigs to profit and those who do not aid the pigs are driven off the streets and out of the society, they will become subversive. It is All Power To The People, and Later for the Pigs.

So the pigs have to create machinery to deal with the potential subversiveness and reality. The pigs have to make sure that all possible leaks of reality are stopped up; the plugs used are lies

on top of more lies. Fantasies are created, the fantasy that if you believe and work with our pig pro-

The teachings at the school imply that the more a person learns in school the more this will en-

the indoctrination at the schools uses those that can't see reality and bends them for use to their own advantage. Those who can't be used as their lackeys become discontent and subversive-a threat to the pigs' survival.

The people that are the most exploited don't count too much as long as they can be used to buy the trash that the pigs sell to make their profit. The pigs have to make sure that the other portion of the people continue to aid and support them by continually working to gain what the pigs have. (The de-facto-segregation or the ghetto schools is used as a method to merely pacify the most exploited (Blacks) to ensure that they will not become subversive to this fact). The white schools are where most of the aid or support to the pigs goes because these are the people that the pigs rely upon to work (to carry out their tool of exploitation). If these people become subversive to the fact that they were being used just as the most exploited Blacks, there would be no machinery to aid the pigs in their plans for their individualistic profits. So the pigs have to make sure that this portion of the people continually receive what they need to pacify them. Racism is instituted to ensure them that they are doing well because they're better off than the Black population. Their schools are provided with the best heating, lighting, food, the newest books, etc.

The biggest farce lately has been the bussing issue. This pig lie is supported because of the fact that better material conditions are placed in the White schools-the fantasy of receiving a better education is created. The manner in which to receive this is defined as bussing. But because this portion of the people are being indoctrinated with lies also, neither the ghetto schools nor the White schools is in the interest of the people.

"We want an education for our people that exposes the true nature of this decadent American society. We want an education that teaches us our true history and our role in the present day society," this is Point #5 of the Black Panther Party 10 Point Program.

With this type of education the pig power structure would be exposed for what it really is. The youth would become subversive. It would truly be later for the pigs. Bussing is not the way to get equality and freedom because equality and freedom only come out of a righteous armed liberation struggle.

The Verdict Is Almost In, AND THE FASCISTS CAN EXPECT NO MERCY

After having spent about a week in jail, the Chief of Staff, David Hilliard, and the Minister of Culture, Emory Douglas, were released from jail. On April 21st a racist judge in New Haven, Mulrey, generously declared that he would withdraw his decision to jail David and Emory for six months on a ridiculous contempt of court charge. He apologetically stated that his decision had been biased, as he had not realized that Panthers do not enter courtrooms to disrupt them or to break laws governing courtrooms.

Chairman Bobby Seale was in the courtroom waiting to have injustice meted out to him on a trumped up murder charge. He advised the judge that he should not allow the events that took place in the Chicago courtroom-when Bobby was chained, gagged and bound-to have any bearing on this. Chairman Bobby and also David told this slick fascist that Panthers are upholders of the Constitution; it is only when our constitutional rights are being violated that we act to correct the situation by any means necessary.

The judge stressed his desire to be fair to everyone, including Panthers. He added that he wanted it to be clear that not only would he withdraw his racist decision but that he wanted it known that he would be completely fair and impartial in the murder trial involving Panthers (the trial of Chairman Bobby Seale and the nine other Panthers) now pending in his court. Therefore, David and Emory were allowed to walk out of the courtroom.

But we aren't fooled. No one should be fooled. This is the same New Haven judicial system that viciously arrested, jailed Ericka Huggins on a trumped up murder charge and has incarcerated her, without even mention of a trial

RACIST PIGS HARASS THE PEOPLE OF 840 W. SUNNY SIDE

There is another attempt being made on the part of the murderous pigs of racist America to make Black people of this backward society an extinct race of people.

A very clear case of genocidal action is being seen and felt by the people of 840 W Sunny Side. There are only twenty Black families in this building all of whom are seeking to escape the rampant indecent housing that exists in our Black communities. The pigs have dug on this attempt on the part of the people to find decent housing and have moved fascism off the streets and brought it into the homes of our people. Of the twenty Black families living there, six have received notice of eviction from the Chicago Housing Authority. The majority of the six are welfare recipients and the reasons for the evictions are all of the same nature-CHA gave these reasons for evictions: too much noise, their apartments weren't clean enough, or that the visitors who came calling on the tenants were not considered respectable enough for the pigs in the CHA. All these reasons were lies; the true reason was that the six tenants were poor and Black. This is the real and most common reason why people are evicted in this racist country of America. The CHA is just another chapter in the continuing story of genocide which is being committed against Black people by the American government.

The six families are going to be evicted to live in the streets because if you are on welfare you can't afford to live in any thing but a project and the CHA owns them. Only a heartless criminal would put a family on the streets with nowhere to go to find decent housing. By denying these people decent housing the CHA is saying 'people don't have a right to survive; because shelter along with food and clothing is necessary for people to live.'

So we can plainly see this attempt of CHA to play the part of Hitler and the Germans but we ain't going to play the part of the Jews. We, as Black people, own very little other than our lives, but we say this: "We demand decent housing fit for the shelter of human beings as it is run down in the Black Panther Party's 10-Point Platform and Program. If we are denied our rights then we are put in a position to defend our lives at the threshold of our doorsteps."

On October 18, 1969, he and brother Walter Toure Pope supposedly sneaked up behind a parked, unmarked pig car, at Manchester and Standord in an attempt to ambush the pigs sitting inside the car. It was reported that they were within inches of the pigs and fired at them with a shotgun and carbine; ironically only one pig sustained minor wounds, while Toure, our beloved brother, was killed, and Bruce was critically wounded.

Since the pigs were unable to murder Bruce like they did Toure, they slapped this ridiculous "assault with intent to commit murder" charge on him, so the court could finish the job the pigs started. He has been in jail for the last five months and he hasn't yet come up for trial. In addition, his constitutional rights have been violated in an attempt to make sure that Bruce will be convicted and sentenced to life imprisonment.

The courtroom is the legalized arm of this murderous beast, fascist America, in its obvious plot to exterminate the Black Panther Party and all Black people.

Not only are our brothers and sisters being shot down and killed in the streets everyday, but they are also being railroaded in the kangaroo courtrooms. A very clear example of how the pigs and the lackey judges work hand-in-hand is in the case of Bruce Richards. Bruce is presently at L.A. New County jail awaiting trial. He is charged with assault with intent to commit murder.

Bruce's case is a clear-cut example of what is happening to Black people throughout this country. It is up to the people to stand in defense of Bruce and themselves by any means necessary, because it has been proven that "the oppressor has no rights that the oppressed are bound to respect."

KANGEROO COURT CONVICTS PANTHERS

Robert Williams, Romaine 'Chip' Fitzgerald and Luxey Irwin, three dedicated and hard-working members of the Southern California Chapter of the Black Panther Party, have been convicted of various trumped-up charges, ranging from burglary to assault with a deadly weapon. These three revolutionaries, who were incarcerated for the last half year awaiting trial, had been tried, convicted and sentenced even before

He heard one of the brothers make a remark, and when he turned around to hear what was said, they supposedly shot him.

The trial was reminiscent of the "Emmet Till" era in the South. Robert was also charged with kidnapping a White woman. They allegedly ran into her house for safety because the pigs had been chasing them. Consequently, the pigs charged Robert and Luxey with kid-

liberating", and convicted Chip, Luxey and Robert on the other charges against them. Even this mockery of justice didn't satisfy these fascist pigs' unquenchable thirst for the blood of Black people. To add insult to injury, the New County goon squad pigs attempted to brutalize the brothers, after they returned from court, because it hurt their piggish hearts to see Robert, Chip and Luxey in such good spirits and saying, "All

they went to trial, not only because they are Black, but also because they are Panthers, freedom fighters, in racist America. In their unrelenting attempts to destroy the Black Panther Party and practice genocide on Black people, the pig department, as evidenced in these brothers' trial, will exhaust all of its foul tactics until the people stop them dead in their tracks.

The pigs claim that Robert, Chip and Luxey had been stopped one evening in September for a defective front light. (We'd like to know how a pig could see a front light from behind a car?) After the pig stopped the car and issued the brothers a ticket, he reportedly turned away and began walking toward his car.

napping. The pigs heaped lie upon lie on the witness stand during this 5-day trial - five days! (This is one day more than a murder trial in which Chip was convicted). From listening to the pigs' testimonies, you would think that they were the innocent victims of an unprovoked attack. But the pigs failed to explain how it was that Chip was seriously injured with a shotgun wound in his head, and Luxey was hospitalized because he had been shot in the leg.

On Friday, April 3rd, the racist jury began deliberating and by Friday afternoon, the jury had already convicted Robert and Luxey of 1st degree robbery, kidnap and assault. By Monday, they had completed "de-

Power to the People" after they had been convicted. But the brothers defended themselves and once again it was proven that "The People's Spirit is Greater than the Man's Technology."

The revolutionary fervor of these 3 revolutionaries, brothers-Robert, Chip and Luxey-and other political prisoners will light the fire of the people's souls and the people will rise like a mighty cannon, and defeat their oppressors and set their warriors free.

THE MURDER OF DONALD MILLER

Today at San Jose City College, a people's inquest was held into the fatal shooting of Donald Ray Miller, age 18, by a fascist pig Ed Jarrot. The prosecution was done by Michael Torrence of the San Jose State BSU. The inquest was presided over by Bill Calhoun, Chairman of the BSU of San Jose City. A crowd of about 500 college students, high school students, and members of the community, were present in the interest of justice, to hear the people's side, and bring about an indictment against pig Jarrot, for murder in the first degree.

The newspaper report of the incident, which occurred on March 31, at 12 p.m., conflicts considerably with the investigations of the People, and the coroner's report.

According to the media, Donald Miller and one or more accomplices, armed with a .22, attempted to rob the Jack-in-the-Box located at the corner of El Camino and Lafayette, in the city of Santa Clara. Pig Jarrot, responding to a call allegedly given by some unknown off-duty pig, arrived on the scene as Donald Miller and the other brother jumped a fence located at the rear of the Jack-in-the-Box, and were running across the parking lot. Jarrot, the paper says, shouted "halt" several times, fired a warning shot, and then shot and killed Donald Miller. The other person involved escaped and is still at large. Accord-

ing to the paper Donald Miller was shot in the back, and here is the first contradiction. The coroner's report says Donald Miller was shot in the chest. How can you be running away and get shot in the chest?

After speeches from the BSU, and the Revolutionary Action Movement, the prosecution first called upon John Keltch, a member of the Socialist Worker's Party to give some first hand background on pig Jarrot's activities as a strike-breaker at the Pittsburgh-Demolines Steel Plant in Santa Clara. Even then Jarrot had shown himself to be exceptional at brutalizing the people.

The prosecution then read a report by the attendant at the Jack-in-the-Box, who was possibly the only eyewitness to the entire incident. His story contradicts the pig's story very obviously.

He stated that at no time was Donald Miller armed. The alleged .22 was held by the other person, Donald and the second brother ran through the kitchen and out of the back door. They jumped the fence and ran off across the parking lot of the adjoining bar. Pig Jarrot ran around back, and the attendant is very clear on the point that only one shot was fired, and Donald Miller was dead.

A preliminary investigation by the local NAACP shows that on a police diagram the .22 was outlined on the pig's side of the fence where the brothers obviously dropped the

picion of being a suspicious nigger" and executed him on the spot. By acting as Judge, Jury, and Executioner this low-lived dog, (who is also a part-time instructor at San Jose City College in the Police Science School), violated Donald Miller's constitutional and human rights, and has shown once again that a Black man has no rights that the fascist pigs are bound to respect. The people found pig Jarrot guilty of murder in the first degree, and issued the following demands:

- 1) The immediate dismissal of pig Ed Jarrot from the faculty at city college, and the Santa Clara Police force.
- 2) An open public investigation

- 3) An indictment for 1st degree murder brought against Ed Jarrot by the Grand Jury.
- 4) The immediate withdrawal of armed pigs from our campuses.
- 5) The establishment of a Community Police Review Board.

On Saturday, April 18, at 2:00, there was a Community Meeting to formulate a plan of action for the implementation of these demands, at Our Lady of Guadalupe Church on Kammerer in East Side San Jose.

Statement For Release To The Black Press

April 6, 1970

During the early morning hours of April 1, one or more terrorists operating under the cover of night and taking advantage of a campus relatively vacant because of spring recess, did apparently plan and, in fact, effectively execute an arson attack against the Africana Studies and Research Center at 320 Wait Avenue, Ithaca, New York. Arson experts have concluded that the fire was not electrical or started by a cigarette. The material used to start the fire was highly flammable and it was started in more than one place. Apparently the person or persons involved had ample time to look over the whole building and choose the most strategic places to start the blaze. The total destruction of the building points to this being a professional job.

The Black community of Ithaca has consistently been viciously attacked in all aspects of our lives as has been demonstrated by the burning of the Southside Community Center, brutalization and neglect of Black children in the Ithaca Public School System, as well as the repeated attempts on the lives of the Black women living at Wari House.

The clear fact is that this incident reflects historical truism in America--that it has been in the White community that law and order has never been respected. It has been in the White community that the breakdown of law and order has been most criminal and, of course, most damaging to both life and property of Black people. We see oppression in the form of the political assassinations of Martin Luther King, Fred Hampton and Ralph Featherstone; constant harassment of Black polit-

ical organizations--the Black Panther Party, incarcerations and/or forced exiles of Black leaders and recent repressive legislation such as the Supreme Court decision regarding unruly defendants and the closing of the Black Studies at San Francisco State College.

The consensus of the entire Black community at Cornell reflects that of the larger Black community around this country, that their persons and their property are insecure and are threatened in this atmosphere. Dale Corson, President of Cornell University, rejected the following proposals:

1. Security for residences, for Black people by Black personnel;
2. That the Cornell African Commitment Fund be placed under the auspices of James Turner, Director of the Africana Studies Center;
3. Completion of a new Africana Studies Center, located on Plain Street in the heart of Ithaca's Black community, which was also damaged by fire.

Despite the opposition of the White community we are determined to defend ourselves and initiate programs for the improvement of the Black community. No fire can stop this determination. The urgency of the situation not only at Cornell but around the country makes it necessary that Black people hear the truth from one another. We are sending all communications directly to our Black press and publications.

PIG BRUTALITY IN FOCUS

The constant sickness and cancerous germs that infest the Black community manifested in the brutalizing forces of the pig department, continues to prey on the people. The brutal arrest of an intoxicated brother late at night on a deserted street stopped at brutality only because the pigs were caught in action by members of the Indiana Chapter who were returning from the seating of one of our members as student president at I.U. The brother was slammed against the pig car and pushed around quite roughly while handcuffed and unable to move or protest. The pigs were approached by members of the Party and asked the charges

on the brother; oinking and slobbering at the mouth, they gave their usual reply of being attacked. When they were asked why so many pigs were attacking this man, the reactionary reply was "move on or we will arrest you". Standing their ground no one moved and the pigs, therefore, could not complete their plan of murder; not being sure whether the bloods were armed or not the pigs moved on. Later that night we noticed 4 or 5 pigs cars outside our 'crib' watching the place, no attempt was made to enter the crib by these baffoons, but their mere presence caused an undesirable odor in the community. The raging tide of fascism is

very evident in Indianapolis, prior to this incident, threats were made to Black High School students by the KKK in letter form but the youth have a way of saying stick your threats up your behind. One of the basic elements that meet the needs of the people is to realize that self-defense is a very potent weapon when dealing with cowards who strike in the darkness of night.

On Thursday April 9, 1970, a five year old sister Yvette Oaks fell off her bike. All that day, and up until Saturday she complained of intense abdominal pain and not being able to eat without vomiting. The little sister was feeling so bad that finally her mother took her to the hospital; her mother, Mrs. Barbara Oaks, took her to the

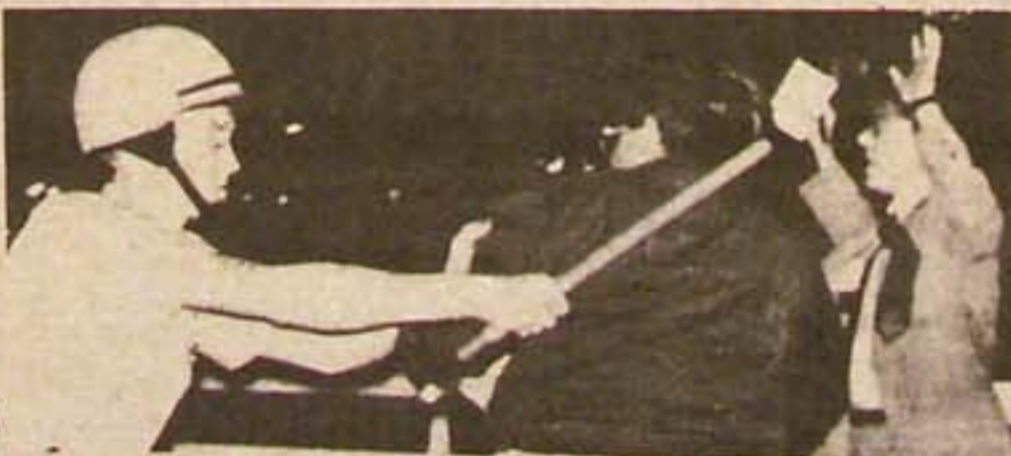
persisted and worsened, and on Sunday her mother became concerned and took her child and traveled some eight miles away. Taking Yvette to New Rochelle hospital which is a better hospital. Yvette was placed in the hospital with these conditions: dehydration (loss of fluids), a possible trama, also she needed a blood trans-

fusion. Another case was when Mrs. Julia Butler brought her son to Mount Vernon hospital to be circumcised, and later when she came to visit him, she just happened to pull back his blankets, the bed was soaked with blood, and her son was still bleeding. These are just some of the in-

idents that have taken place at Mount Vernon hospital in which slip-shot doctors provided inadequate services for poor people of the Black community. The treatment of patients has been so bad in some cases that the people say they will relate to nursing their own wounds, instead of admitting themselves to the Mount Vernon hospital for possible suicide, at the hands of these fools who have little regard for the life of human beings.

THE TIME IS NOW

Berkeley NCCF has collected enough signatures to put the issue of COMMUNITY CONTROL OF POLICE before the voters. To do this, we needed a number of signatures equal to 15% of the total number of registered voters in the city. That number is about 9600, or 15% of 64,000. We have validated 10,000 Berkeley addresses. Actually, we had collected more than 11,500 signatures, but due to phony addresses and out-of-town addresses, we had to eliminate more than 1500. We validate addresses; the County validates signatures. That means that when we file, the County will invalidate all those signatures which are not registered or appear more than once. So to assure our place on the ballot, we must collect at least 13,000 signatures, 3000 more in the next few months. The people of this city - of this country - want a different kind of police force, one that is responsive to their needs rather than to the financial interests of the community. There is no problem in getting people to sign the petition. The problem is getting the petition to them. We in Berkeley need registered voters to help circulate the petition. Everywhere there is an NCCF chapter, where they are working on the petition, qualified voters are needed to circulate it.

COMMUNITY CONTROL OF POLICE needs workers. We know that in Berkeley, as everywhere else, the mayor, the city manager and the rest of the political imposters will not agree to our taking their bodyguards away from them without putting up a fight. We need many people to bring this issue to the communities in order to build up the powerful base necessary to counter the attacks from City Hall. Our campaign has proven that the people of Berkeley are receptive and anxious to move on this issue.

COMMUNITY CONTROL OF POLICE attacks the basic tool of oppression wielded by capitalists

state and thereby give us more time to work with the people in building a revolutionary consciousness among them. It is not mere rhetoric to say that - the Community Control of Police petition is a program that will take the power to control the police department out of the hands of the private property and corporate interests and put it directly into the hands of the people of the community. This is the essence of the program: it sets the people diametrically opposed to the interests of the ruling class of the country. This will intensify the contradictions and educate the people to the inherent antagonisms between the oppressed and their oppressors.

There is another vital aspect of this program: We Are On The Offensive. We have taken the issue to the people who have signed the petition. When we get on the ballot, we will go back to the people to educate them to vote for it. Then, City Hall will have to react to us; they will be on the defensive - forced to defend their rotten system. We on the "left" have always been on the defensive, reacting to things the pigs have put down. No more of that! This time, we have taken the initiative we have attacked their system and they are forced to defend it. We need more attackers. To build a revolution we have to be where the people are. And that's where NCCF is. In taking our petition to the people, we talk to hundreds of people every week - about all sorts of things. People want to talk, and they want to listen, too; particularly to those who offer basic solutions to the problems that drain them of the vitality of living.

We suggest that those of you who wish to get to know the people, to become a part of your community, (the people have to know you before they will come to you), who want to "discover" where the people are, NCCF has the answer. Spend a few hours a week working with your local

At this point in the struggle of Black people for freedom and justice, we have reached a crossroad; we have two paths that we, as a people, can follow. Stating the facts simply, America is preparing for the mass elimination or genocide of Black people. Thus the two opposite paths that Black people can move along in response to the actions of the racist, fascist pigs are either acceptance or resistance - Either we are going to accept the systematic extermination of Black people and go to the gas chambers and ovens voluntarily, or we are going to resist this move by the fascists and begin to deal with the question of survival - not intergration, separation or segregation, but survival. Who is going to survive America? This is the fundamental question that faces us as a people and we must deal with it as a people with one goal in mind: national salvation. If we look all around us and examine the things that we see happening around us

in your mind if you wanna be" or go through some other changes, but playing the drums, or dancing the 'funky chicken' or laying up in bed with every man or woman that comes along or running around yelling "Black Power" and "Off the Pig" is not going to kill or even injure a pig. We can go to the ovens and let the pigs sock it to us, or we can sock it to them instead - only by socking it to the pigs are we going to survive America. The means of resistance are by whatever means necessary and the only thing that will slow down or stop the fascists in their attempts to eliminate Black people is revolutionary action which should be moved on at once. We must begin to put our theories into practice, so "Free

and we analyse these events and occurrences objectively, and in a realistic light, we can plainly see that America is preparing for genocide - total elimination of Black people. The Black population of the United States is about 20-37 million; or with only one thought on his mind anywhere from 10 to 30% of the spread out across the land area of the United States in such a manner that we exist on 10-20% of the land area of the United States. On the contrary, Black people in this country are concentrated in large urban areas; we are piled one on top of the other in housing projects. The same is true all across the country, where ever there is a huge area, a small part of it is filled to overflowing with niggers. Here in Roxbury, we can relate directly to some of the fascists preparations for genocide.

A short while back, Warren Street was ripped up from beginning to end, and repaved; however, a few changes were made: all of the gas mains, water pipes, telephone cables and electrical cables were dug up and placed ten feet deeper into the ground. Warren Street was widened and then reinforced with wooden beams, metal pillars and trolley tracks from the tracks that used to run up Warren Street; crushed rock, sand and gravel were used to fill the gaps and to strengthen the already reinforced street and then it was paved over with asphalt. Now Warren Street is so wide that in some places it resembles an expressway. Plans have been drawn up and space is being cleared for a new highway that will run through the Black community, in innerbelt highway. What is the significance of wide highways running through every Black community of a considerable size? The answer is very simple; once Black people begin to resist the fascist oppression, tanks, heavy armoured and artillery vehicles and troops will be using these wide expressways to seal off

All Political Prisoners" and "Off the Pig" must not remain empty words, they must become reality. We have to begin to relate to the principle of self-defense, arming ourselves from house to house, block to block, community to community in order to put an end to fascist attacks like the one that took the lives of Fred Hampton and Mark Clark in Chicago. Our principle of self-defense must be expanded to include attacking the enemy to destroy his ability and desire to attack Black people. Thus a pig blown away on the street with a .357 magnum or wiped out with a 30-06 from a roof top means that there is one or two less pigs a dead fascist means that there is one or two less pigs; a dead fascist cannot attack or kill anyone.

All Black people are going to have to unite around our common enemy and this enemy is anyone who is participating in the attempted massacre of Black people or anyone who goes along with the genocide of Black people. If we are not willing to counter-attack and act in a manner that will insure the survival of Black people in America, then we welcome a jolt similar to the jolt of 6 million Jews at the hands of Adolph Hitler. If we don't want to be made into soap and lampshades as the Jews were, then we will have to deal with fascism and show the American government that if Nixon, Agnew, Mitchell and their collection of assorted pigs are going to play Nazis and if the National Guards or the army or the marines or anyone else comes into our communities shooting and committing crimes against Black people, then they are going to get shot and we are going to make every bullet count. The choice is up to us and we will have to decide quickly because the conditions are rapidly forcing us to make our choice in the near future, like right now.

The fascist pigs who run America have a two-pronged attack plan against the Black Panther Party. Because we are a political Party that believes in self-defense, the ruling pigs have found that it was necessary to first destroy the political leadership of the Black Panther Party and then wipe out those members of our Party that have acquired military skills and experience in the pig military. It has become obvious that the imprisonment or deaths of Huey P. Newton, Bobby Seale, David Hilliard, Eldridge Cleaver, and Emory Douglas are only a part of the power structure's plan for the total destruction of the Black Panther Party.

The second priority for prison or the morgue is clearly those brothers with military skills or experience. This fact has become especially clear in the past year, with certain brothers being singled out for maximum pig attack. It is a reflection of what America really is, to see that those who have risked life and limb to spread 'freedom' and 'democracy' around the world, become the victims of a most vicious and vile attack when they decide to defend themselves and their communities against racist brutality, injustice and murder.

A Panther stands between Black America and racist genocide. The pig campaign to de-fang the Panther has

stepped up with the arrest, beating and frame-up of Panther Randy Williams. Randy's case can be cited as a classic example of how the pigs place an extra bounty on those Panthers with military experience. Randy Williams was a member of the 101st Airborne for three years. Over a year ago Randy was singled out for vilification in a McClellan committee report as an 'instructor in guerilla warfare' and a 'weapons expert'. Since the U.S. government trains Black men in these skills, it obviously is considered a worthy skill, as long as it is directed against Vietnamese, Koreans, Laotians, Africans or Cubans who have never lynched any niggers. This is plainly an open indictment from Congress and an incentive to local bloodthirsty pigs. Not that the local pigs need any urging from the U.S. Congress, but it helps them along in their blind and fumbling manner to point out choice targets.

Following their Congressional orders, the local racists have been a constant plague to Randy, and subjected him to numerous threats and many arrests. The last arrest was three weeks ago for an alleged murder. But after a five hour interrogation by homicide detectives trying to frame him, the best the pigs could do was

turn it into a traffic warrant on the borrowed car Randy was driving. The federal and local pigs had been watching and photographing Randy putting up heavy window screens, and sandbags in our National Headquarters and this definitely was a hang-up to their plans. The heavy screening and sandbags had become an obvious necessity after the Berkeley pigs' August '69 Attack Plan became known and the Los Angeles pig department's December 8th gestapo attack became a reality. To a racist pig's mentality this human response of self-defense constitutes 'guerilla warfare' and a row of sandbags constitutes a 'deadly weapon'. In two years Randy Williams has shown love, respect and a dedication to his people and in so doing has made the transition from 'good soldier' and 'gook killer' to 'criminal', 'murderer', and 'ambusher'. There is a clear threat to the fascist pigs when Black cannon fodder become Black Liberation Fighters. When the one-time mercenary becomes a Freedom Fighter, the fascists see problems coming. This is why they try as hard as they can to deprive the Black Panther Party of brothers trained in any military skills.

The pattern is nationwide. In Los Angeles the brothers under most bla-

tant attack are brothers like Geronimo, Deputy Minister of Defense of the Southern California Chapter. Geronimo is the holder of three purple hearts and 14 other medals and awards, including a Bronze Star. It is a reflection of America that an ex-paratrooper wounded three times in America's hypocritical attempt to export freedom and democracy to Vietnam (by force) could be the victim of a year-long attempt to murder or imprison him. In one year a model soldier has traded 17 medals for numerous arrests, five attempts to frame him and two blatant attempts to kill him. Across America those who have fought for freedom in a foreign land have increasingly become the victims of brutal beatings, frame-ups, and in some cases--death.

The pigs are trying to turn yesterday's heroes into today's criminals. But the people see through this trick. We do not know the brothers from the community who are alleged, along with Randy, to have 'ambushed' those pigs, but we know that whatever Black people do to these racist marauders who occupy the Black communities is RIGHT ON!

EDUCATION OR INDOCTRINATION

"Today, as always, the struggle of the exploited people within the United States is taking place on all fronts, but the most sensational and explosive clashes are being centered and focused more and more on the college campuses and on the high school campuses." We understand that those who control the mind control the body...." Eldridge Cleaver - Education and Revolution

The schools in the Black community are in turmoil. Everytime we pick up a newspaper or tune in to the fascist news media, we hear reports of this or that campus exploding. For a long time many of us, in the Black community, have looked at the school as being separate from the community, something higher and beyond our control. The struggles in Ocean Hill - Brownsville and Harlem changed the entire communities concept of the schools. The people began to see the schools for what they really are: institutions to train Black youth to accept the oppressive conditions we live in. We saw this and moved to change it.

In Ocean Hill and Harlem the people set up their own board comprised of people they could trust. The pig structure couldn't stand to see the Black community running schools that met their piggish standards, so they moved pigs in to push the people out and re-establish pig power within those communities.

Students (high school and college) throughout the city couldn't accept this. Why wasn't the Black community allowed to control their schools? Are Black students receiving an education or an indoctrination?

The role of an educational system is to teach the youth, of that society, the laws, culture, technology and wisdom of that society. To deny a person these basics is to deny him a chance to fit in and contribute his best to society. But under our present system of capitalism education has taken on a new out-look. Technology has reached such a high level that it is necessary for a small group of people to be deemed as educators. And only a small amount of technical knowledge is distributed among the masses. Schools today are more of a mental conditioning center than anything else. A center where vast amounts of select information and responses are programmed, like a computer, into peo-

Hundreds of Black youth enrolled in various colleges across the country, 'Uncle' James Brown made a record telling people to stay in school.

Malcolm X once said that, "A duck can only produce duck eggs and a chicken can only produce chicken eggs". American fascist training can only produce lackeys of fascism. The masses have begun to see that the solution was beyond

Education today trains you to look at the day to day oppression as only a temporary set back caused by our own inborn laziness and inability to work. We are taught that on Africa is, and was always, a land of naked savages. We are told to support the imperialist murder and exploitation of millions of oppressed people, who like Black people, have the same enemy-USFascism. Under capitalism the educational system has degenerated into a system of controlled indoctrinations; a system of fascist brain washing.

Many Black people have for years stressed the need for Black youth to attend school. Many of us were told that we could raise the level of the Black masses by attending school and pursuing higher education. Scholarships were set up. Huge amounts of money poured in from "gully" rich Whites and Blacks, Hassan

SCHOOLS IN BABYLON

Toilers of Baltimore, our struggle is a just struggle, we have been struggling from one generation to the next ever since the first slave ship arrived here in Babylon (America). The madness perpetrated by the capitalist parasite, has for centuries kept the masses of oppressed people in a constant state of misery. Our forefathers have gone, and today the struggle has been placed in the hands of the youth to carry the 'revolution' through to the end. students joined in, demanding that something be done about the teacher; the demands were met with sticks, feet and mace. One of the sisters was pregnant; after being kicked by those filthy pigs, the sister lost her baby--life inside of life--destroyed, it never had a chance.

Parents, it is your duty to stand up and help make Babylon a better place to live. The students are trying with everything in their power to bring about a change, a change that is needed in order to ease some of the suffering and misery that the toilers face each and every day, not only here in Baltimore, but all across this sick and decadent nation. Parents the 'cry' goes out to you to come forth and support the students in their just struggle. The students have drafted six demands that each and every one of us should stand up and support:

1. Complete amnesty for all students involved in recent disorder.
2. Fire all teachers involved in perpetrating madness against the students demands.

5. Community control of schools.
6. Student unions on all high school campuses, and all pigs must leave school campuses where students are.

VICIOUS CIRCLES

The game that the power structure is trying to run on society at large, is one of the biggest fraud programs of the century. The lies are about prisons which are supposed to be agents of rehabilitation, but they are in reality cesspools of brutality and degradation, concentration camps into which millions of Black people are railroaded every year.

When a brother or sister gets busted, it's usually on a scheme the pigs dreamed up; they do this in order to fill their arrest quotas which determine whether or not they are "good pigs". Many innocent people go to jail so that they can maintain their piggish status as "farmongers".

What happens next is a characteristic example of the type of treatment Black people get under the American system of justice. First,

they are arraigned and in most cases received balls which cannot meet a violation of their constitutional rights. Then the pigs throw their victim in prison where they will make him stay for months before he ever sees the inside of a courtroom. When they finally bring the defendant back to court, he is told that he has been indicted and rushed back to prison. After another long wait, he is brought to court and the already confused defendant must listen to fast-talking court appointed lawyers who tell him about "getting off easy" by pleading guilty to a lesser crime. The incarcerated defendant seeing no other out cops out to the lesser crime. This overjoys the pig judiciary who are busy filling their conviction quotas. Not long after this, he is sentenced to one of Babylon's many prisons where he is

viewed as another nigger who got busted. The only training he gets is from hustlers and pimps of the old school because the work he is assigned in jail is where the pigs need him, not where he needs to be. He decides to change, not by abandoning the "criminal" path (a path which the pigs put him on by taking his freedom), but by becoming a slicker. He even begins to simulate some of the ghetto conditions by talking slick and using cartons of cigarettes to buy heroin the pig guards bring in.

Months turn into years, and after giving the parole board a heart-warming dissertation on his rehabilitation, he is released on parole.

Once outside he sees that he cannot work because he has a record. He begins to party, hustle and shoot about a crime wave, the people will point out to you that the criminals on to him and has him sent back

to jail. Back behind bars he undauntlessly makes plans to recover and keep his freedom, not realizing that he has already made one trip around the vicious prison-parole-prison circle.

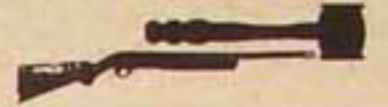
We see that recidivism rats are soaring in Babylon. This can only be because the pigs want this type of situation. In a nation that boasts vast technical knowledge obtained through cohesion and murder, we can see why they want Black people (especially those that threaten their profits) off the streets.

THE PEOPLE HAVE ALREADY DECIDED IN ADVANCE THE FATE OF AMERICA IF THE FASCISTS ATTEMPT TO MURDER CHAIRMAN BOBBY AND THE CONNECTICUT PANTHERS

On May 22, two days after Chairman Bobby Seale of the Black Panther Party returned to California after speaking at Yale University, New Haven pigs found the body of Panther Alex Rackley in the back woods of Connecticut. After finding Rackley's body, the pigs in true vigilante style vamped on the New Haven Chapter of the Black Panther Party, arresting 9 persons in connection with the body. (Charges against Sylvia Spurlock Kimbro were eventually dropped.) The remainder of the nine were charged with murder, kidnapping, and conspiracy. Two of those arrested were 15-year old sisters, one of whom was released and was to have testified against the others but fled to New Jersey. The others were: Ericka Huggins, Warren Kimbro, Frances Carter, Peggy Huggins, Rose Smith, George Edwards and Loretta Lukes.

Since that time Kimbro and Lukes have turned State's witnesses and

have pleaded guilty to second degree murder along with pig agent George Sams who lied and testified that Chairman Bobby Seale "ordered" the alleged act. Since that time Landon Williams, Rory Hithe, and Lonnie McLucas have been arrested on similar charges. The pigs have now committed their most absurd act, they have jailed Chairman Bobby Seale and have planned to murder him and the Connecticut Panthers in the electric chair for a crime which the Black Panther Party had no part in.

Alex Rackley was a Panther in good standing and was murdered by the New Haven pig department and George Sams in collaboration with the FBI, Attorney General John Mitchell, J. Edgar Hog, and pig Richard Nixon in a coordinated effort to destroy the leadership of the Black Panther Party and to smash the people's faith in the Party. The New Haven Panthers have been in jail, without bail,

since May 1969. During that time, Frances Carter and Rose Smith have given birth to two young revolutionaries. During their pregnancy and incarceration, the light was kept on in their cell 24 hours a day; they were denied proper medical treatment and exercise. In Rose Smith's six months of incarceration, she gained one pound, weighing 133 lbs.

In February, 1970, Frances Carter was bailed out for 52 hours, subpoenaed to court and railroaded to jail again for 6 months for contempt of court because she refused to answer questions concerning her fellow Party members. Several days later she lay unconscious in her cell, for saying "All Power to the People".

The case of the New Haven Panthers is indicative of the fascist American judicial system, it is part of the terrorist campaign of the Nixon-Agnew-Hoover-Mitchell regime to commit genocide on Black

people in general and the Black Panther Party in particular. Black people clearly understand the need and the purpose of the Black Panther Party, and can whole-heartedly identify with the program and platform of the Black Panther Party. Our 10-Point Platform and Program is just a basic program for putting forth the demands of Black people and making this program functional for Black people. Understanding the historical experience of Black people and the relationship of the Black Panther Party to that experience, we can understand why it is that the pigs in the power structure are desperately trying to annihilate the Party.

We are the sons of former slaves who have picked up the gun and the pen to wage a desperate war against our tormentors for the misery that they have caused our people.

The local pigs along with the federal pig power structure recognized the hope that the people have

of being free, of determining their destiny, and the progress of the Black Panther Party in fulfilling this desire through our platform and community programs that serve the needs of our people. The spirit of the Black Panther Party and Black people, and our determination to be free can never be crushed. The case of the New Haven Panthers whether they are found guilty by the fascists, or not, can never destroy the people's faith in the Party. If they try to turn the juice on the New Haven Panthers, the Black Panther Party and Black people are going to turn off the lights in America for days, there will be no hole in the world in which the pigs can hide. Black people will avenge the lives of every Black person murdered as sacrifice on the altar of American fascism.

HOUSING CONDITIONS IN THE BLACK COMMUNITY

PIGGISH LANDLORD

Point #4 of the Black Panther Party's Ten Point Platform and Program states that "We want decent housing fit for shelter of human beings. We believe that if the White landlord will not give decent housing to our Black community then the housing should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people."

The Black community of Mount Vernon is in grave need of senior citizens' housing, low income housing and cooperatives --- as in any other Black, poor and oppressed community in America.

lon (America) has always managed to keep everything a secret when it comes to the people knowing about what's going on. As long as the lying demagogic politicians can keep the people duped and in the dark as to what is going on in their community, they are not worried about being moved on.

But, the Black Panther Party is moving to educate the people to the fact that it is their right to know what is going on and about the lies that these lying demagogic politicians are running down to them. The people must understand that these public servants are responsible to them and not the people

years we have been forced to live under the most brutal attacks that could be dealt to a people. We understand that this racist government will do anything to get rid of Black people. We will not let ourselves be fooled by the lying, demagogic politicians.

The people demand cooperatives with low income leasing, so that they can own a share of the total building. The people further demand low income leasing under this program. 200 units of additional low income housing have been allocated to the city of Mount Vernon but only four of these units are being occupied. In previous years, for housing

We want decent housing facilities for shelter of human beings. The Black Panther Party realizes that for over 400 years our people have been forced to live in run down 'death traps' set aside by the pigs for the poor and oppressed people to live in. This problem manifests itself not only in Mount Vernon but all across fascist America.

We have found that the chief source of the problem here in Mt. Vernon is the fact that the avaricious (greedy) landlords who own the buildings in the Black community have no concern for the safety and welfare of their tenants. The only thing that these greedy pigs are concerned with is collecting their rent (money) which they extort from the people under the threat of eviction. Repairs are made very seldom if they are made at all. One particular building (49 1/2 W. Third St.) has an apartment on the third floor which was destroyed by fire. This apartment is now filled with garbage, which besides being a health hazard to the people, is also a breeding place for rats and

roaches; water drips from the ceiling; the door to the apartment is open, if a young brother or sister were to wander in, they would be seriously hurt.

This is but one example of the indecent, genocidal conditions that these low-lived, murderous pigs have created for our people to live in. We say that this has to stop. We say that if the piggish landlords won't provide decent housing for the people, then the housing should be turned over to the people so that they can create decent housing for our people to live in.

The people of Mount Vernon are tired. We will no longer consent to the oppression and genocide which we have been subjected to in the past. If the pigs don't straighten up their hands, there's gonna have to be some Bar-B-Que!

FACTS ON THE MURDER OF ROGER LEE DARRETT

Brother Roger Lee Darrett was murdered on April 5, 1970, by pig Harry Robinson. It was stated in the pig press (The Daily News), that pig Robinson caught brother Darrett burglarizing a bar, called the Chit Chat Club at 5144 Market St. It was also stated that pig nigger lackey Robinson gave brother Darrett a warning before he murdered the brother in cold blood. But brother Gene Jones, who was on the scene, rapped with members of the Black Panther Party, and stated that pig Robinson was shooting and warning at the same time! Another thing that is very important in this case is the fact that Mrs. Darrett, the mother of brother Darrett, has not received any news of the murder of her son. The only information she got was from the pig press, she said a pig came to her house with a piece of paper and told her to sign it,

not bothering to explain what it was for, or to tell her that her son was dead.

Another brother has fallen at the hands of one of Rizzo's fascist pigs. Just like: Harold Brown, Joseph Brooks, and George Hamilton, Roger Lee Darrett was murdered by pigs who patrol our communities, murdering and brutalizing our people. When will the people rise up and put a stop to this madness being perpetrated by these murdering pigs? Just like Thomas Lyons and Brinkley Evans, pig Harry Robinson is a murderer, and must be brought to Justice, by any means necessary. If the courts of Philadelphia will not bring these law-breaking-murdering pigs to justice, then the people must do so!

WE DEMAND THAT YOU RISE TO THE NEEDS OF SUFFERING HUMANITY FREE HEALTH CENTERS

Simultaneously, as the need for medical attention grows in our Black communities, an equal but opposite aversion to that need grows. This need must not be ignored any longer, nor even merely alleviated, but DEALT with! With the support of the doctors, though only a few have committed themselves, we will deal with the suffering of our people.

Hospitals are overcrowded, emergency rooms are where people die awaiting their turn or the usual bureaucratic routine of presenting some tangible means of pay for services rendered. Why must people present money before they're even examined...when death may be 30 minutes away? Why must we even pay for a doctor to save our lives?!

Free neighborhood centers or clinics are part of the answer, but there's another side to even THAT coin-- NOT ENOUGH doctors, nurses and concerned people willing to commit themselves (in time and energy, free of charge) to the people; and inadequate equipment to accommodate the doctors and nurses who HAVE committed themselves.

Two Free Health Centers will become functional for the people in East and West Oakland by June 1st, 1970, despite the seemingly insurmountable obstacles. They are not insurmountable because Free Clinics are a reality in cities all across America. Doctors and nur-

ses have given their precious time and skills, and donations of expensive medical equipment and medicine have been obtained.

Surveys are presently underway to determine what the people want and need most in their Center. A community board of directors will keep us aware of their needs and desires and assist with recruiting more personnel and technical equipment as the Center grows to meet the needs of the people.

An auxiliary program, in which first aid stations will be established in the community is also being developed in a desperate attempt to deal with emergency situations until professional help is at hand. First aid classes will be held at the NCCF-Bobby Seal Community Information Center, 1690 10th Street.

As professional servants of the people, we do not merely solicit your help...we Demand that you rise to the needs of suffering humanity. We remind doctors who are hesitant...that Hippocratic Oath; to nurses, their dedication to comforting the sick; to clergymen, their undying concern for others; and to the laymen, their relentless support of the People's Programs.

PANTHERS TORTURED IN L.A. NEW COUNTY JAIL

April 20, 1970:

Brothers Roger Lewis (Blue), Ronald Freeman, Bruce Richards and Robert Williams, in L.A. New County Jail, were attacked once more while awaiting trial in the fascist pig pen. Blue (Roger Lewis) talked to a Sergeant Mc Comas about the conditions on their cell row--2300. He pointed out that all the windows were broken out, that they didn't have enough blankets and as a result they froze at night. All the brothers (Panthers) wanted to be in a cell together. He agreed to put them together up front, away from the windows and EVEN allow them to go to chow with the other inmates as long as the Panthers didn't start any trouble.

Everything seemed okay, until the second shift came on. When they found the brothers were being moved, a pig, Sgt. Buck, told them to forget what McComas had promised them. He told Blue to come out of the cell he was in. Blue refused. About 10:00 p.m. they came back to remove Ronald Freeman from his cell, twisting his arm, punching him, and dislocating his already messed-up shoulder (he is an epileptic), by tearing the ligaments in his arm. Ronald was placed in "Siberia" (next step to the hole, where all your privileges are taken away, usually solitary confinement). About 2:30 a.m. on Tuesday morning (April 21st), the "Goon Squad", consisting of over ten pigs, came after Blue. They sprayed mace all over him, afraid he would resist being taken out of his cell and proceeded to jump on him. They had their large flashlights and used them to knock him in the head until the flashlights went out. They kicked him in the back and stomped him in the throat, till now he can hardly talk, and his tonsils are in bad shape. He has a bruise on his head, and the handcuffs on his wrists caused cut marks around them. They dragged him from module 2300 to 2900, and threw him into an empty cell where they ripped his clothes off and threw him in the hole. About 20 minutes later, a male nurse came in and threw some peroxide on his head to wash the blood away. Today the Sergeant (McComas), who originally promised them the improvement of conditions came by to see Blue. He was visibly upset upon seeing his condition and angered at the fact that his directives had been ignored and driven over. After Blue was taken out of his cell, the pigs moved to Bruce Richards' cell, tearing hair out of his head and beating him up.

Bruce was placed in Siberia along with Ronald Freeman. Robert Williams' exact location is still unknown. Blue had asked several times for medical help, but to no avail. As a final affront the pigs will probably move to file assault charges against them. They know the Party cannot allow such atrocities to continue to happen without anything being done or the incidents being exposed to the people. Other brothers witnessing the assault on the Panthers have agreed to testify if they aren't shipped off as the pigs have done before in assault cases on Panthers!

In February, five brothers, Roger Lewis (Blue), Lloyd Mims, Paul Redd, Geronimo, and George (Duck) Young were jumped on by the gestapo pigs of the Sheriffs' Department. This came about as a result of the pigs kicking one of the brothers in his back. This incident led to the brothers being charged with assault. This incident was followed by other incidents which brothers unjustly received assault cases. Another brother, Ronald Freeman, was charged on a separate instance later the same evening when the L.A. 18 brothers were attacked. The pigs jumped Ronald in the court line for creating a "so-called disturbance". Roland Freeman and Bruce Richards received their charge of assault behind some petty nonsense of who can and who can't sit at certain tables in the cafeteria. Robert Williams and Romaine Fitzgerald, on their way back from being sentenced in Torrence, were attacked by the pigs and an assault charge was thrown on them.

The pigs are doing anything and everything they can to keep the brothers in jail. It's part of their deliberate attempt to kill them in their fascist pig pen. We have to support our Comrades who are Political Prisoners and make certain the sadistic acts of the pigs are continuously exposed to the people.

"If we worry about what's going to happen to us, we couldn't accomplish anything...Justice is gonna come when the mass of people rise up and see justice done...The more they try to come down on us, the more we'll expose them for what they are... PIGS -Bobby Seale

Domestic and International Genocide

Today more people can clearly see the various roles of aggression that the American government plays in countries throughout the world. It is not difficult for us to understand the Genocidal tactics meted out to the Vietnamese peoples as exemplified by the My Lai and Song My war crimes. The total extermination of the Vietnamese race is the ultimate goal of the United States occupying troops in Vietnam.

The economic prosperity of America and other imperialist countries is based on declared or 'undeclared wars' such as Vietnam. This type of economic dominance in countries fighting for "self-determination" only benefits the American Giant Corporations and the avaricious businessmen who control most of the foreign investments. The plunder and pillage of the Vietnamese peoples has not only stuffed the pockets of the capitalist but has also intensified the race contradictions in the world. The Vietnamese people are a people of Colour; their life or death means no more to the racist Nixon administration than the life or death of any Asian, African, Arab, Latin, Indian, or American Black. Exploitation and murder abroad is merely an extension of what American racists are born and bred to practice on their own countrymen. The way a country treats its own inhabitants on a National (domestic) level is an example of the country's inter-

national policies.

An example of this Domestic extermination can be seen in the attempt to electrocute and murder Bobby Seale, Chairman of the Black Panther Party. Bobby Seale has repeatedly shown his support for the courageous Vietnamese; Bobby himself is an advocate of peace - National and International. He is a man fighting for the national liberation of Black people and he understands that American racism and imperialism is violence in its natural state, and will only yield when confronted with greater violence. His practice is evidence that he will never cease struggling to accomplish harmony in the world. Bobby set an example during the Conspiracy 8 trial where he was bound and gagged for asserting his Constitutional rights to defend himself. Here is an example of a man who has no special interest at heart, he has nothing to lose and all to gain by exposing to the oppressed people of the world what a racist bourgeois sham the courts and judicial processes are in America today.

Bobby Seale is not on trial alone. Every working class and poor person in America is on trial with him and if the verdict is death than we can be sure that our execution will quickly follow. The charges against Bobby along with the Connecticut 8 Panthers are: conspiracy to kidnap, kidnap, conspiracy to murder and murder. We shake our heads and fists at the Vietnamese massacres but we consciously

avoid the domestic genocide primarily manifested in our judicial processes. Our civil liberties, our rights to survive within the confines of growing racism and terror are on trial!

If Bobby Seale is murdered No moratorium-no demonstration or protest will save us from the tyranny and terror of Federal and State troops as they move to the total occupation of our communities because we have not dealt with the real issues: Domestic Genocide.

It is easier to condemn the acts of International Genocide in Vietnam as the atrocities rise to a higher level daily (Cambodia, Laos, Korea et.al.) but to condemn American genocide we will have to take a position (a revolutionary position). We will no longer be afraid to confront the obstacles to our liberation: the tact-squad, F.B.I., the attorney general, John Mitchell, and super pig Nixon. Are we nearly as courageous as the Vietnamese?...who fight the two evils of racism and imperialism, whereas we prefer to stick with the safer...imperialism and avoid the real threat...racist Domestic Genocide.

Keeping silent as the attorney general orders the executioner to murder Chairman Bobby Seale is to CONDONE ALL ACTS OF GENOCIDE.....DOMESTIC AND INTERNATIONAL

Will Racism Or International Proletarian Solidarity Conquer?

The White Left in the U.S.A. has shown through their recent actions that they have adopted an opportunistic line. They therefore find it difficult to follow the leadership of Black people which shows a form of White egotism manifested in deep-rooted racism. Racism which is so profoundly a part of America that it cannot be rooted out of the American system unless the same system these so-called revolutionaries are trying to overthrow is completely destroyed.

The American White Left finds itself in a state of confusion and bewilderment and the fact that racism is truly a way of living and cannot be discarded by overlooking it and saying I am a Revolutionary--has proven its point. The White Left in the U.S.A. is comprised of a large percentage of the Jewish population. Before the Black Panther Party took its stand on the Palestinian people's struggle there were problems but the support of the White Left for the Black Panther Party was concrete. However, since our stand the White Left started floundering and became undecided. This leaves us with no alternative than to believe that a large portion of these people are Zionists and are therefore racists.

It was a Zionist judge, Judge Friedman who sentenced Huey P. Newton to 2-15 years in jail. It was a Zionist judge, Judge Hoffman who allowed the other Zionists to go free but has kept Bobby Seale in jail and sentenced him to 4 years for contempt charges. Bobby Seale alone stands trial again in April on conspiracy charges. With whom did he conspire? The Zionists?

The other Zionists in the Conspiracy 8 trial were willing and did sacrifice Bobby Seale and his role in the conspiracy trial to gain publicity. We once again condemn Zionism as a racist doctrine. We reiterate our solidarity with the Palestinian people's struggle for national liberation against Israeli imperialism and Zionism aided and

abetted by U.S imperialism. The one-eyed bandit of Tel-Aviv, Moyshe Dyan must be hunted down and killed.

It is therefore incorrect for the White Left of the U.S.A. to travel abroad and tell or pretend to the Europeans that they are up-tight with Black Americans and the Black revolution.

The White racist government of the U.S.A. is manipulating the White masses along a racist line and are forcing Black people into a position where they cannot find White allies. Black people however realize and understand that they will have to fight on and on for their freedom.

It is very clear that Nixon has developed a foreign policy with Rhodesia, South Africa and Portugal and it is the first time that the international situation is parallel with the domestic situation, Racism internally as well as externally.

Black people cannot afford to go along with that. The Weathermen, one of the few White Revolutionary groups left in the U.S.A. have stated that to pamper the American White working class is criminal. They are living off the blood and sweat of other people and allowing the genocide of Black people without any resistance.

The racists think that Black people are so stupid that they cannot see Eldridge Cleaver's statement which seems to have gotten the White Left up-tight is delivered in view of the fact that it is a time of extreme responsibility and warning to our people. We do not want a race war. From the beginning of the Black Panther Party we have made that crystal clear but we have lost too many lives in order to keep the stand we truly believe in. However, we will not stop fighting until we gain our objectives. If our White allies allow the racist capitalistic system to once again use and misuse them without really diagnosing the situation then we will stand alone.

That will ultimately mean Black people fighting alone which in other words mean a race war. We think the decision rests with our White allies. For us Power to ALL the People can be a reality. It is left to the action of our White allies both here in Europe and the U.S.A. whether they believe this or not.

Of one thing we are certain, We will not sacrifice Bobby Seale, we will not allow any more of our brothers and sisters to be rail-

of the Party along with its members. How much more will it take before you understand what is happening? Fred Hampton was murdered in his sleep and people are still walking in a daze. The systematic plot against Bobby Seale has been going on since the founding of the Party in 1966 and this last trumped-up charge is so obvious that once and for all it should be clear to even a baby the pattern that is being followed. But do you understand or do you

What happened to your end of the bargain? Are you going to sit by and see Bobby go to the electric chair? A man who is only guilty of what he believes in--that there is a better life for us all. If you sit by and do nothing then you also prove that you are racists and condone the genocide of oppressed peoples.

Where does the European Left stand? The time is now for you to show by your actions whether you

BRITISH SOLIDARITY WITH THE MOVEMENT TO FREE BOBBY SEALE

On Monday March 2nd, the Black Panther Movement in England, with the support of the Black Peoples Alliance together with a number of White radical organisations in solidarity with the Black Panther Party organised a demonstration in front of the American Embassy in London, England against the pre-planned murder of Bobby Seale, Chairman of the Black Panther Party.

For over 1000 supporters picketed the American Embassy in London. The pigs were out in force and started harassing the demonstrators as soon as they arrived. The demonstrators were forced to leave the American Embassy for a while and took their march on one of the main streets of London. The pigs then started beating everyone in sight and immediately arrested 4 Black youths and 2 White youths. One of the Black youths was then beaten almost unconscious in jail. The four Black youths all members of the Black Panther Movement were Clement John, Keith Spencer, Stanley John, and Odling Umwalla.

In spite of the arrest the demonstration continued until night in front of the American Embassy

and the total arrests were 16. The charges ranged from obstructing the pigs in the course of their duty to assault on the pigs.

On March 3rd when the demonstrators appeared in court the racist Magistrate stated, "What has something in North America got to do with us in Britain? We cannot have people running on our streets instilling fear in innocent passersby!"

He then ordered the Black youths previously arrested to be remanded in custody. He did not attempt to hide his racism and the racism of the courts in England as he then ordered the White demonstrators released on bail.

When the racist magistrate refused to grant bail to our brothers in prison we immediately set about the costly process of "buying" their freedom by applying to a judge in chambers for bail. Through conversations with our counsel and chief pig in charge of the case we have found out that they are intending to frame up even further charges--of conspiracy to incite a riot. So far the brothers have made three court appearances the last being the 25th of March. In court that day

we heard the pig in charge of the case say that they are waiting on the director of Public Prosecution to see if the charge of conspiracy to riot can be applied, the brothers are to appear in court on the 21st of April when they will know if further charges will be placed.

In order to link the racism and brutality which Black people face both in Britain and in the U.S.A. a follow-up demonstration arranged by the Black Panther Movement with the support of the Black People's Alliance was held on the 15th of March. The demonstrators (about 600 in number), marched first to the American Embassy where a strong letter of protest against the brutality of American imperialism and fascism was lodged. The demonstration then continued in a Black community (Brixton) where rallies were held in the open air at two stages along the route. Again the pig police were out in full force.

The demonstration was held in two stages firstly, so that more Black people could have an opportunity to show their anger at the brutality practised by the American racist power structure

against Black people, and especially against the Black Panther Party; secondly as a means of politicising Black people (in the community) by using as lessons the extradition of Bobby Seale, and the assault and arrest of demonstrators at the demonstration of March 2nd. It was the largest demonstration ever held in the Black community. The pig police were out in force but were unable to use their fascist tactics, because of the strength which the Black people showed in the community. After these two demonstrations the pigs were frightened by the sight of organised Black people and stepped up their attempts to harass and intimidate the members of the Black Panther Movement.

The racist establishment has showed itself to be truly scattered by these two demonstrations judging from the instances of hysterics (as described in the leaflets) and brutal attacks on Black people. We saw quite clearly in both instances how frightened the pig police were and as a result how savage they behaved towards the brothers involved. But the effects have been even more far reaching

than these two cases of pig harassment and intimidation. Last week about 3:00 a.m. Wednesday morning the 17th of March three of our members Keith Spencer, Clement John and Ira O'Flaherty were returning home after a long night of work in Brixton, they were driving along Queen Victoria Street in the city of London when they were flagged down by the pigs who said pull aside and park. The pigs then proceeded to question and cross question all the occupants of the car; this was followed by a thorough search of each individual and then a large scale assault on the car itself. Pockets, brief cases and paper bags - everything was turned inside out - they were all arrested and taken to Wood Street pig sty near by. All along the brothers were protesting and trying to find out the reason for the outright act of unjust arrest and harassment. The pigs either refused to answer or mumbled that it was a routine check, they also accused brother Clement of stealing his own car which he owned for years. After an hour in the pig sty they were allowed to leave without being charged.

RULES OF THE BLACK PANTHER PARTY

NATIONAL HEADQUARTERS BERKELEY, CALIFORNIA

Every member of the BLACK PANTHER PARTY throughout this country of racist America must abide by these rules as functional members of this party. CENTRAL COMMITTEE members, CENTRAL STAFFS, and LOCAL STAFFS, including all captains subordinate to either national, state, and local leadership of the BLACK PANTHER PARTY will enforce these rules. Length of suspension or other disciplinary action necessary for violation of these rules will depend on national decisions by national, state or state area, and local committees and staffs where said rule or rules of the BLACK PANTHER PARTY WERE VIOLATED.

Every member of the party must know these verbatim by heart. And apply them daily. Each member must report any violation of these rules to their leadership or they are counter-revolutionary and are also subjected to suspension by the BLACK PANTHER PARTY.

THE RULES ARE:

1. No party member can have narcotics or weed in his possession while doing party work.
2. Any party member found shooting narcotics will be expelled from this party.
3. No party member can be DRUNK while doing daily party work.
4. No party member will violate rules relating to office work, general meetings of the BLACK PANTHER PARTY, and meetings of the BLACK PANTHER PARTY ANYWHERE.
5. No party member will USE, POINT, or FIRE a weapon of any kind unnecessarily or accidentally at anyone.
6. No party member can join any other army force other than the BLACK LIBERATION ARMY.
7. No party member can have a weapon in his possession while DRUNK or loaded off narcotics or weed.
8. No party member will commit any crimes against other party members or BLACK people at all, and cannot steal or take from the people, not even a needle or a piece of thread.
9. When arrested BLACK PANTHER MEMBERS will give only name, address, and will sign nothing. Legal first aid must be understood by all Party members.
10. The Ten Point Program and platform of the BLACK PANTHER PARTY must be known and understood by each Party member.
11. Party Communications must be National and Local.
12. The 10-10-10-program should be known by all members and also understood by all members.
13. All Finance officers will operate under the jurisdiction of the Ministry of Finance.
14. Each person will submit a report of daily work.
15. Each Sub-Section Leader Section Leader, Lieutenant, and Captain must submit Daily reports of work.
16. All Panthers must learn to operate and service weapons correctly.
17. All Leadership personnel who expel a member must submit this information to the Editor of the Newspaper, so that it will be published in the paper and will be known by all chapters and branches.
18. Political Education Classes are mandatory for general membership.
19. Only office personnel assigned to respective offices each day should be there. All others are to sell papers and do Political work out in the community, including Captains, Section Leaders, etc.
20. COMMUNICATIONS — all chapters must submit weekly reports in writing to the National Headquarters.
21. All Branches must implement First Aid and/or Medical Cadres.
22. All Chapters, Branches, and components of the BLACK PANTHER PARTY must submit a monthly Financial Report to the Ministry of Finance, and also the Central Committee.
23. Everyone in a leadership position must read no less than two hours per day to keep abreast of the changing political situation.
24. No chapter or branch shall accept grants, poverty funds, money or any other aid from any government agency without contacting the National Headquarters.
25. All chapters must adhere to the policy and the ideology laid down by the CENTRAL COMMITTEE of the BLACK PANTHER PARTY.
26. All Branches must submit weekly reports in writing to their respective Chapters.

Black Panther Party Platform and Program

What We Want What We Believe



*Huey P. Newton Minister of Defense
Black Panther Party*

1. We want freedom. We want power to determine the destiny of our Black Community.

We believe that black people will not be free until we are able to determine our destiny.

2. We want full employment for our people.

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed income. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all of its people and give a high standard of living.

3. We want an end to the robbery by the CAPITALIST of our Black Community

We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered six million Jews. The American racist has taken part in the slaughter of over fifty million black people; therefore, we feel that this is a modest demand that we make.

4. We want decent housing, fit for shelter of human beings.

We believe that if the white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people.

5. We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present-day society.

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything else.

6. We want all black men to be exempt from military service.

We believe that Black people should not be forced to fight in the military service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military, by whatever means necessary.

7. We want an immediate end to POLICE BRUTALITY and MURDER of black people.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The Second Amendment to the Constitution of the United States gives a right to bear arms. We therefore believe that all black people should arm themselves for self-defense.

8. We want freedom for all black men held in federal, state, county and city prisons and jails.

We believe that all black people should be released from the many jails and prisons because they have not received a fair and impartial trial.

9. We want all black people when brought to trial to be tried in court by a jury of their peer group or people from their black communities, as defined by the Constitution of the United States.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a man a right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all-white juries that have no understanding of the "average reasoning man" of the black community.

10. We want land, bread, housing, education, clothing, justice and peace. And as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny.

When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume, among the powers of the earth, the separate and equal station to which the laws of nature and nature's God entitle them; a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; that, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness. Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and, accordingly, all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But, when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security.
