

BOSTON PIG KILLED DURING BANK HOLDUP

"Wipe our some, some satisfaction; wipe out more, more satisfaction; wipe out the whole lot, complete satisfaction." Such way the case on Wednesday, September 23rd when the criminal pig Walter A. Schreeder was wiped out resolutely, wholely, completely and thoroughly in a bank holdup of the Aliston branch of the State street Bank; where he was hit in the stomach by a 45 callber bul-

Shortly before 10:00 A.M. un September 3rd three people entered the bank two men and a woman one with a 45 calibre submachine gun, one, a sawed off shotgun and the woman, with a .30 callbre carbine. The doors to the bank were immediately locked and they then demanded money (\$26, 000). As they proceeded to leave the building, pig Schroeder got out of the car and moved towards the front door and exchange of shots ensued. The pig was hit in the stomach by a .45 calibre bullet and fractured his skull as he bit the concrete. The alleged three people then jumped into a waiting car, then switched into one with Ontario plates and then disched that also. The plg

was, for a period of time in critical condition and later died on Thursday as his pig gang members sat in the hospital waiting to give him blood.

Since the bankhold-up hundreds of pigs, state, local and F.B.I. have been mobilized to avenge their fallen brother pig, one suspect is now in custody, Robert Valeri, Over 100 Boston, State and F.B.L pigs were sent to Hampton Beach, New Hampshire along with 17 pig dogs, that resemble their "masters", to search a marsh area where one of the suspects was allegedly

seen. The National Guard brought a helicopter to spray pepper-gas to flush out the so called suspect but it was to no avail. The pigs are now claiming this act to be the work of revolutionaries and "radical types."

Three of the people who are being charged with this act were students from Brandels University. The pig news media has already tried and convicted the nunpected band, which is a direct violation of our legal rights which til proven guilty.

Through it is not a proven fact

that the people who are suspected of the stick-up are guilty or respossible, it stands to reason than whoever committed the act was seting in a rightful manner, taking back from the oppressor what he has taken from the oppressed.

Pig Schroeder has proven himself to be nothing more than a lackey and a flunkey for State Street Bank in attempting to protect the interest of the avaricious (greedy) businessmen and therefore received a just reward for standing in the way of the oppressed during the act of reclaiming what is ours!



FASCIST BABYLON

On the 4th of September, pig detectives Lawrence R. Selman and Larry Sprague of the Dallas pig Metro Squad, stopped a pickup truck occupied by Guy Daniel Hourland and George Michael Wallace for no apparent reason. They shot Guy D. Bourland down in cold blood, The pigs tried to justify it by saying Bourland was mistaken for a known narcotics dealer, but yet Bourland had no previous arrest record.

Pig Sellman, that did the fatal shooting, was not indicted for murder but instead was no-billed by the county grand jury, Chief Pig. Dyson suspended Pig Detective Selman for 30 days, not because of the shooting, but because of his unlawful-like actions prior to the shooting. Members of the grand jury clearly stated, that they refuse to indict any pig for any actions they take against citizens while on duty.



PIGS PLOT GENOCIDE OF BLACK CHILDREN AT CURLEY SCHOOL

On Sept. 21, 1970 a group of Waite racists attacked and brutally beat a young Black teenager after Curley J.H.S. let out. The next day, this name group of racists, the children of the fas-During the assault on the house cist majority, again tried to attack a group of Black school children making them run back to the Bromley-Heath Projects, Un Monday of last week, they tried to do the same thing only this time we successfully fought back and the children defended themselves. On Tuesday, the situation changed for the worse and Boston's gestapo, the "boys inblue," came on the acene. They picked up one 13 yr. old brother, Larry Palmer and brutally beat him on Larry's head and told him, "Mr. one will know the difference." That night, a group of 50-75 young (10-16 yr. olds) people started throwing rocks at passing cars to show their anger at what the pigs had done to their friend, Again Boston's gestapo showed up. on the scene, and started shooting at the school children, Without thought these pigs tried to kill our children! Fortunately, no one was lairt. The aext day, pigs had the Curley School surrounded, the scene reminded one of Little Rock

or the University of Mississippl. Pigs were lined up from Bickford street all the way along the route to the school, Anumber of brothers from the neighborhood center in the projects were at the school

at the time and were responsible for the fact that the pigs didn't harm any of the Black school children.

Now on Monday, September 28, a meeting of parents was called at the Curley School to discuss the situation, However, no Black parents were informed that the meeting would even take place. About 5 mothers, however, accidently found out about the meeting and went over to the school. They found out that the White store owners of the area were buying such and walking to and from school. That well known racist, Louise Day Hicks attended the meeting and throwing garoline on the already intense flame of racism, told the group that it was obvious which group of mothers cared about their children. Of course, she knew, that Black parents were never even informed,

All this is happening today, Sept. 1970, and still we are not only denied the so-called " constitutional right to a free public school education, our children are denied the human right of security walking to and from the Curley School These pigs, both in and around the Curley School continue to plot their terror, intimidation andgenocide of Black school children. THEY DECIDED TO DEAL SO HARSHLY, MALICIOUSLY, AND WANTONLY WITH A GROUP OF BLACKS THAT IT WOULD TER-RIFY THE WHOLE BLACK POPULATION AND AT THE SAME TIME PROVIDE A SCAPE-GOAT FOR THE OFFICER'S DEATH, A SIM-ILAR METHOD OF MASS TERROR WAS USED BY THE GUARDS IN JANUARY 1970, WHEN THEY INDISCRIMATELY, AND VICIOUSLY SHOT DOWN THREE BLACK BROTHERS AND LEFT THEM ON THE YARD REFUSING TO LET OTHER BROTHERS AID THEM CAUSING THEM TO BLEED TO DEATH, ATROCTTES OF THIS NATURE ARE COMMON AT SOLE-DAD BUT NEVER SO OVERTLY, THEIR ME-THOOS OF TERROR ARE THE SAME ME-THODS USED TO INJECT FEAR AND CUNTROL THE PSYCHOLOGY OF THE SLAVE 400 HENDRED YEARS AGO IN URDER TO MAKE THEM FOREVER SUBSERVIENT AND MERE THINGS, THE GUARDS MARCHED IS BLACKS ACROSS GRAVEL GROUND, HANDCUFFED AND WITH ONLY A PAIR OF DUNGAREES ON, NOTHING UNDERNEATH IN THE COLD OF NOTHERN CALIFORNIA WEATHER,



Strikers are memhers of local 216 in Los Angeles) These General motors workers shut down the line ? hours in advance of the 12 midnight deadline on Sept. 14th. They also slowed down and temporarily stopped the cars of supervisors of the General Motors plant.

EYEWITNESS REPORT OF THE VAMP ON OUR WALLACE STREET OFFICE

Members of the Black Panther Party went in the community to compile a report on what the people of the community saw during the morning of the yamp in the Black Panther Party information center at 3525 Wallace street.

Use sister , Mrs. Edith Sisco, who lives directly scross the street from our office on Wallace street gave us a rundows on what

Panther: Mrs. Sisco, on the morning of August 31, 1970, just what did you see?

Mrs. Sisco: Well, it was about 5:30 A.M., when I was awaken by a loud boom, which sounded like a gun going off, I jumped out of bed, and went to the window, and there was this trash truck parked outside of your office, then I saw a man in a white trench cost, and he looked like he was grabing trash cans. Then suddenly he ran over to the door of the office and shook it as if he was checking to see if it was strong or not. Then he ran and got back in the truck and drove away real fast, then about five minutes later a police wagon came up real fast the same way the trash truck was moving and then the police jumped out with shot guns and bullet proff vest, and started dicking down behind the parked cars across the street from the office.

Panther: Did you hear anyone say they had a warrant?

Panther: Exactly what kind of weapens were they?

Mrs. Sisco: They started shooting up at the windows and at the door then they stopped shooting and one man ran over and started chopping at the door with an ax. He hit the door about four or five times. Then I heard a call from inside, "Do you have a warrant", and they opened fire again and there was shooting for about 20 minutes then a plain clothes police officer got on a loud speaker and said, "You inside come out now." Then a pig ran over to the door and started chopping on the door again. Another goy also also ran over to the door and shot something in the door and it flew open. Then the pigs ran away from the door and started ducking down, the man in all white then came and shot some more stuff in the hallway. waited for about five minutes, and the guy on the loud speaker said, "Come out now, and bring your weapons with you." The little sisters and brothers were so shridged with the nature of pigs, that when the pigs arrested Richard in their presence they yelled out "Off the Pigs". The arresting officers were Pig Sampson and Pig Burrows.

Brother Richard has been arresulted from trumped up charges that were supposedly dropped, during this time the pigs kept him long enough to put him through severe harassment and interogation. The second arrest resulted when Richard went to the aid of another brother (Ocie Curry) when he was being severly besten by two mad plus, at Fifth and Williams Street, When Richard tried to separate the brother from

the pig, the pig immediately forgot Ocle Curry and started to beat Richard. These mad pigs beat this brother so viciously that he had to go to the hospital for x-ray of his throat and head. This last arrest resulted from an incident where Richard stopped a lackey rent-a-pig from shooting a young blood for suspicion of theft.

The first two charges were dropped, only after Richard had been subjected to continous pig harassment and arrest.

This racist plg named G. Trick and his nigger bootlickers have continued to be star pigs when it comes to harassing the brothers of the Dayton N.C.C.F.

Number seven and number nine of the Ten Point Platform states: "We want an imediate end to police brutality and murder of Black people", and "We want all Black people when brought to trial to be tried in court by a jury of their peer group or people from the Black community as defined by the constitution of the United States".

GARY, INDIANA A STUDY IN NEO-COLONIALISM AND GENOCIDE

In a country built un slavery and run by modified versions of slavery, wherever the large campa of labor are, there will exist large camps of oppression.

Gary, Indiana is called the "Steel City", because of the numerous steel mills, such as Inland, U.S. Steel, Youngstown Steel, Republic Steel, Rockford Steel, and several other mills in the area. These steel mills require large quantitien of cheap labor in order to function, and this labor is supplied mostly by Black, Brown, and southern White workers, Anide from being known as the "Steel City", Gary, Indiana has a Black majority in population, and has its first Black mayor.

Inner city Gary has many Black people running downtown businesses and administrative positions in the city government, However, inner city Gary does reflect in its condemmed buildings and aumerous oppressed street people and blighted living conditions the corrupt - destructive - nature of capitalism. Although the White onpressor is gone, the oppression remains, foed still costs the same high prices, high rent on shon dwellings, the sydricions (greedy) businessman still exists, the demagogic (lying) politician still exists, the fascist pig still exists. The only change is the akin colorof the administrators, who still administrate a system founded on the exploitation and slavery of man. The "hoursh", yelled at the

inauguration of a Black mayor, in more correctly a call of human distress from the many visibly oppressed people of Gary. The ecstasy (warm excitement) which has illuminated as Black power, in proctice proved to be a smokescreen for the continuation of oppression against Black people, only under new rule. Classically we call this neo-colonialism, that is instead of having direct colonial rule from the mother country through envoys, we have lackeys from the Black communities appointed to handle the interest of the oppres-

Many people will say that Mayor Hatcher is a good Black mayor who wears dashikis and talks of Blackness. The reality of the situation is that Mayor Hatcher cannot possibly under the present governmental system help the broad masses of people in Gary, Under the present system, Mayor Hatcher doesn't run it, the other Dlack administrators don't run it, the mansem of oppressed "can", but don't run Gary. The economy of Gary is dependent upon the steel mills, so whoever rous the steel mills runs Cary, With all these steel mills in Gary one would think that the mances of Black and other oppressed people simply need to get a job in order to eliminate the effects of oppression, However, fiving in a society where everything in organized to secure the most work and most profit from people, we ob, give the people miking whit

appears to be large sums of money and then by human necessity forced to give it back to "capitalist institutions" in order to secure food, clothing, housing, medicine and other needs. So because of the organized social super structure of Gary it is impossible for a Black mayor or a Black anything else to raise the standard of living for the masses of people in Gary, without a revolutionary change in the system.

Most of the buildings which are unfit for human living are owned by corrupt aspiring Black capitalists who use their skin color as an excuse to misuse the people. Many of the condemned dwellings have been marked to be destroyed for Urban Renewal Funds, this will simply remove the people who lived in the buildings, force them to find other places to live figurally at a higher rent fee), and then the buildings will be torn down, and the land made available for some capitalist to buy and put some other exploitative interest

Some people would have us belive that the majority of Cary's residents are happy, but the early murning faces of lampes (street) niggers who have been forced to sleep out in the cold or in some alam building, is a face of a tired people bent on change. The people of (the nmall farm area) outer orban Gary find no happiness living with outdoor toilets, no running water, unpaved roads, and two

room shacks. These people will be the motive force in the making of the revolution (change) because they have nothing to lose and all to gain. Despite the efforts by the capitalist overseers manifested is the steel mills, to thwart the rising tide of revolution with the Black faces fronting as administrators, like all oppressed people, the people of Gary are revolutionaries out of necessity. As one lumper said in Gary, 'Either you're slave working to make steel, or stealing in your work for living."

Because a few niggers are prosperous at the expense of the masses of oppressed people in Gary and the White oppressor is not so obvious, the people in Cary have been minlead to think that the continued oppression by Blacks is progress.

We say that it may appear to be progress for these Black capitalist lackeys who are all over Gary exploiting people in every manner possible. But in reality this oppression will cause progress for the people's revolution.

The oppressed people of Cary say, "Get your White controlled Black foot off my neck or I'm going to match your leg off."

In this manner, they put Albert in the pig car and drove away. They did this to make the community think that Albert had not been hurt.

After driving him away, Albert was not seen for the next 2 hours and 15 minutes, although the nearest hospital in less than a five minute drive from the location of the community center. RACIST MURDERERS WALK THE STREETS WHILE REVOLUTIONARIES REMAIN IN JAILS

On July 31, 1970, fascist storm troopers raided the New Bedford N.C.C.F. (National Committee to Combat Fascism) by using community people as shields in the same manner as the cowardly attack on the New Orleans N.C.C.F., The 20 brothers and sisters were charged with conspiracy to marder, conspiracy to riot, and unlawful assembly. All these charges stem from an alleged shooting of a Mr. Barello who was wounded in the foot, in court it has been shown that this is clearly another railroading of Black IIberation fighters. Of the 20, three are still in Jail after the original ransom \$200,000,00 (\$100,000, .00 double surety) was reduced for the prisoners of war.

Before this incident there were nights of violence and one of the reasons was the murder of Lester Lima by four White racists who shotgumed Lester to death and wounded two, brothers and a nister. Three of these people have been apprehended by the fascist police of New Bedford.

These three racists Halph D. Brown 20, George Rose 20, and Gary M. Lauriers 18, have been to court and two are released on \$15,000,00 and one on personal recognizance. These three are known to have murdered Lester Lims and they are out on the streets while three revolutionaries have been held for over two months for allegedly shooting someone in the foot. Their lawyer and the prosecutors and the D.A. are trying to pull a whitewash job saying that there were shots fired prior to their murder of Lester Lima, But dig this the reason they came into the area was to get some food, they just happened to have a shotgun under the seat, In court these racist don't even answer questions the judge, D.A., prosecutor, and lawyers are trying to make it seem like they're "victims of circumstance."

My name is Mark Young and I'd like to converse with you about the men that have received so called bad discharges from the fascist military of this country, Today more and more young men are receiving undestreable and bad conduct discharges, I'd like to attempt to explain why so many of these discharges are being given out. There has been in recent weeks congressional and Pentagoninvestigations into drug use and traffic in Vietnam, Reportedly among the military men of the fascist pig power structure (U.S.). 

What We Want What We Believe



Haev P. Newton Minister of Defense Black Panther Party

 We want freedom. We want power to determine the destiny of our Black Community.

We believe that black people will not be free until we are able to deter-

2. We want full employment for our people

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed income. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all of its people and give a high standard of fixing

J. We want an end to the robbery by the CAPITALIST of our Black Community

We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered six million Jews. The American racist has taken part in the slaughter of over fifty million black people, therefore, we feel that this is a modest demand that we make.

4. We want decent housing. fit for shelter of human beings.

We believe that if the white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people.

We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present-day society.

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything else.

6. We want all black men to be exempt from military service.

We believe that Black people, should not be forced to fight in the military service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military, by whatever means necessary.

We want an immediate end to POLICE BRUTALITY and MURDER of black people.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The Second Amendment to the Constitution of the United States gives a right to bear arms. We therefore believe that all black people should arm themselves for self-defense.

We want freedom for all black men held in federal, state, county and city prisons and jails.

We believe that all black people should be released from the many jails and prisons because they have not received a fair and impartial trial.

9. We want all black people when brought to trial to be tried in court by a jury of their peer group or people from their black communities, as defined by the Constitution of the United States.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a man a right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all-white juries that have no understanding of the "average reasoning man" of the black community.

10. We want land, bread, housing, education, clothing, justice and peace. And as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny.

When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another and to assume, among the powers of the earth, the separate and equal station to which the laws of nature and nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights; that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; that, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and bappiness. Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and accordingly, all experience hath shown that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed But, when a long train of abuses and usurpations, pursning invariably the same object, evinces a design to reduce them under absolute despotism. it is their right, it is their duty, to throw off such government, and to provide new guards for their future security,

The evident spontaneity of the 14th incident negates the required criminal intent (174). The record at the time of the third incident affords no reason to believe that appellant's remarks were directed to the court rather than to Kunstfer: erarements intended for the ears of counsel cunnot become contemptuous merely because they are overheard by others in the courtroom (175). Most important, in neither of these incidents did the trial court take any particular umbrage at or even notice of appelant's statements at the time. The court's apparent indifference to the remarks when made is plainly incompatible with its later assertion that the remarks constituted a serious interference with the administration of justice (176).

Consistent with its past practices, (184) therefore, this Court should in considering the evidence supporting appellant's convictions limit itself to events of record.

(184) General allegations of wrongdoing have traditionally been disregarded in reviewing contempt appeals. In Parmelee Transportstion Co. v. Keeshin, supra, 294 F.2d at 314, the defendant was cited, inter alia, for a bad tone of voice, an attitude of contempt, and defying court orders. This Court overturned this part of the conviction, arguing that it contained mere conclusions rather than facts, that it was too general to permit the defendant to answer, and that this Court was not to be required to scour the record for evidence to support an allegation which did not refer to particular parts of the record. In Great Lakes Screw Corp. v. N.L.R.B., 409 F.2d 375, 379 (1969), this Court reiterated that:

(i)n reviewing judicial contempt orders, this circuit and others have espoused the view that mere conclusions of contempt, unsupported by specific facts or supporting citations to the record, carry no weight. The reason for this view is that the recitation of mere conclusions without a showing of the facts upon which the alleged contempt rests makes informed appellant review most difficult if not impossible,
