

In workshops, I often tell this story, for it describes the work we aim to do, and the train-ing we engage in. It is about the coming of the Kingdom of Shambhala, and it is about you, and me. It is a prophecy that arose in Tibetan Buddhism over 12 centuries ago. 1 learned of it from my Tibetan friends in India when, in 1980, I heard many of them speaking of this ancient prophecy as coming true in our time. The signs it foretold, they said, are recognizable now, in our generation. Since this prophecy speaks of a time of great danger- of apocalypse- I was, as you can imagine, very interested to find out about it.

There are varying interpretations of this prophecy. Some portray the coming of the kingdom of Shambhala as an internal event; a metaphor for one's inner spiritual journey independent of the world around us. Others present it as an entirely external event that will unfold in our world independent of what we may choose to do or what our participation may be in the healing of our world. A third version of the prophecy is the one given to me by my friend and Dharma brother Choegyal Rinpoche of the Tashi Jong community in northern India.

There comes a time when all life on Earth is in danger. At this time, two great powers have arisen; these are the laloes (the barbarians). One is in the western hemisphere and one in the center of the Eurasian landmass. Although these two powers have spent their wealth in preparations to annihilate each other, they have much in common: weapons of unfathomable death and devastation, and the technologies that lay waste our world. It is in this time, when the whole future of sentient life seems to hang on the frailest of threads, that the kingdom of Shambhala begins to emerge.

Now you can't go there, for it is not a place, it's not a geopolitical entity. It exists in the hearts and minds of the Shambhala warriors- that is the term Choegyal used-warriors. Nor can you rec-



ognize a Shambhala warrior when you see her or him, for they wear no uniform, no insignia, carry no banners. They have no barricades on which to climb to threaten the enemy or behind which they can rest to hide or regroup. They haven't even any home turf; for always they must move on the terrain of the laloes or barbarians themselves.

Now the time comes when great courage, moral and physical, is required of the Shambhala warriors, for they must go into the very heart of the barbarian power, into the pits and pockets and citadels where the weapons are kept, to dismantle them. To dismantle weapons, in every sense of the word, they must go into the corridors or power where decisions are made.

Now the Shambhala warriors have the courage to do this because they know that these weapons are "mano-maya." They are "mind-made."

According to Garrick Beck, the plaintiffs made their case on both technical and constitutional grounds. The judges weren't interested in the technical grounds at all, and hardly interested in constitutional ones- though they seemed to understand.

"We understand that your group has no organizational quality," Garrick sums up their position. "We've read your briefs, and we see the Rainbow as closer to an idea than an organization. But you still have to play by the rules like everyone else."

Made by human mind, they can be unmade by human mind. The Shambhala warriors know that the dangers that threaten life on Earth are not visited upon us by any extraterrestrial powers, or any satanic deities, or any preordained evil fate, but they arise, rather, from our own choices, our own lifestyles, our own relationships.

So in this time the Shambhala warriors go into training. When Choegyal said this, I asked, "How do they train?" They train, he said, in the use of two weapons. "What weapons?" I asked, and he held up his hand in the way the lamas hold the ritual objects of bell and dorje in the lama dance

The weapons are compassion and insight. Both are necessary, he said. You have to have compassion because it gives you the juice, the power, the passion to move; when you open to the pain of the world you move. But that weapon by itself is not enough. It can burn you out, so you need the other.

It is insight into the radical interdependence of all phenomena- their interconnectedness, their deep ecology. With that wisdom you know that it is not a battle between the good guys and the bad guys, but that the line between good and evil runs through the landscape of every human heart. With that insight into our profound interrelatedness you know that actions undertaken with pure intent have repercussions throughout the web of life, beyond what you can measure or discern.

By itself, that insight may appear too cool, too conceptual, to sustain you and keep you moving, so you need the heat of the compassion. Together, within each Shambhala warrior and among the Shambhala warriors themselves, these two can sustain us as agents of social change. They are gifts for us to claim now in the healing of our world.

minded the judges of their own recent decision in the Bough case, where a Parks System (interior Dept.) permit scheme was found unconstitutional for being overly burdensome and asking the signer to promise things he or she could not assure.

The judges were hard on the plaintiffs, even harsh, but in Garrick's estimation they were equally hard on the defendants. They asked one government witness where else the Forest Service imposes a similar permit scheme. He couldn't name one. They asked where else in the Dept. of Agriculture such a permit scheme existed. He had no

examples. Then they asked where else in the entire U.S. government such a scheme existed. He couldn't say ... A ruling is due within 90 days.

September 27, Springfield, Missouri U.S. District Court

Tony Nenninger, a.k.a. Goodwater, was found guilty of a permit violation at a May 1998 regional gathering. The charge against Kirk McFadden was dropped. Goodwater says he'll appeal (see below).

October 6, 1999, San, Francisco, California 9th Circuit Court of Appeals

Strider's acquittal in the Arizona '98 permit case is in danger of being overturned after oral arguments were heard in the government's appeal. He faced a hostile panel of judges who did not allow him to present the arguments he had prepared. The government made several deceptive claims about the regulation and its interpretation by the FS. In the interim, the U.S. Dept of Agriculture even enacted a new interpretive regulation that seems suspiciously targeted at undermining Strider's case. He did not learn about it in time to address it adequately at the hearing.

"I don't expect a favorable decision," he writes in an email communicade, "not because I am wrong but because I perceive the judges didn't like me, have no idea what a Rainbow Gathering is like (their questions involved Earth First!), and don't understand the regulatory scheme and will just buy the Govt's deceptions*

One of his arguments hinges on the fact that according to the regs, an "administrative appeal" process must be exhausted before a permit-holder can take his or her case before a federal judge. This could take longer than most permitted (or unpermitted) events would last. The government responded, untruthfully, that the appeal process only applies to commercial events, not non-commercial ones like Rainbow. The government's very deceptions, however, encourage Strider to believe that his arguments are valid chinks in the armor of the bureaucracy— if a judge will listen.

Oct. 20, Erie, Pennsylvania, U.S. District Court

Garrick Beck, Stephen Principle and Joanee Freedom are charged with a permit violation for the 1999 Pennsylvania Rainbow Gathering. An team of local lawyers weighed in on their behalf before a senior judge who seems to take the case very seriously— partly because of the constitutional issues and his own suspicions of the regs, and partly because both sides have declared their intent to appeal if they lose. After denying the defendants' motions to postpone, he announced inat he wasn't going to simply rule from the bench after hearing all the testimony, but would set a briefing schedule to deat with the deeper issues.

Four people testified on the government's behalf: Incident Commander Bill Fox; LEO Robert Poegh; District Ranger John Schultz (who in early June 1999 replaced another District Ranger who proved too friendly— who was interrogated afterwards for useful intelligence, under oath); and Steve Burd, the actual ticketer.

All four said a lot of nice things and painted a friendly picture of the Gatherings, giving a careful impression that the FS has no animosity toward Rainbow. They testified at length about publications, web sites, newsletters, our children's village, food supply, radios, parking, minimanuals and more — all in a positive way— to convince the court we're really an organization in disguise.

All four witnesses were then cross-examined by the defense. "Being restricted in our crossexamination to what was elicited in direct examination hindered certain issues which we would have preferred to pursue," Stephen Principle complained. "As the government bureaucrats we would have preferred to question were not 'available' to us, and one defendant's attorney had concerns about what was available— and in the belief that we ourselves had little to offer, as it is the law itself that's at issue— we rested without presentation."

Which means we had to be content with crossexamination of these same four witnesses. Asked by the press afterward why he hadn't testified, Stephen said, "it's not about how eloquently and beautifully we can paint the Rainbow. It's about an issue of law and justice, and our brief will explain it to the judge." The defendants' briefs are due on Nov. 8th; the prosecution's on Nov. 15th. —scribe

MAN FINED FOR ILLEGAL GATHERING Tony Nenninger is found guilty in Rainbow Gathering's lack of permits

Tues. 9/28/99: A Bourbon man who took part in a May 1998 Rainbow Gathering in the Mark Twain National Forest was found guilty Monday in Springfield's U.S. District Court of occupying National Forest Service land as part of a group of 75 or more without a permit.

Tony Nenninger, who was also found guilty of constructing a water line on National Forest land without a permit, said he'll appeal federal Magistrate James C. England's decision and the fine of \$70 the court imposed.

Friends and supporters of Nenninger who came to the day-long trial said Monday the principles of the gatherings don't allow any of them to sign a use permit. That's the offense Nenninger was ticketed for first at the gathering in Oregon County.

Rainbow Gatherings, open to anyone, are known for attracting freethinkers bent on promoting world peace and cooperation.

Donald Mangogna, who was with the group in Mark Twain National

Forest, testified Rainbow Gatherings have no leaders or organization capable of deciding who should sign a use permit. Mangogna and others objected to the idea that any one person had the authority to assume responsibility for other individuals at the gathering.

"I find that absurd on the face of it," Mangogna said.

The charge against a second man ticketed at the May 1998 gathering for refusing to sign a use permit— Kirk E. McFadden— was dropped Friday. Both men could have faced up to \$5000 in fines on that charge alone. Nenninger said after the trial that he will continue to appeal the \$70 fine and England's verdict because he doesn't want to live in a fascist society.

Another supporter from St. Louis, Scottie Addison, said those familiar with the gatherings will continue to support Nenninger.

"He shouldn't have to stand alone," Addison said.

I've always joked about becoming a monk, dropping out of society and devoting myself fulltime to spiritual practice. Thanks to one of those amazing coincidences I find myself a "monk" participating for six weeks in a silent *Vipassana* meditation retreat with 100 other men and women.

Vipassana meditation is a simple, direct and powerful practice — the moment-to-moment observation and investigation of the mind/body process through the development of a caim, focused and balanced awareness. As stillness deepens a quality of being develops, a natural spaciousness of mind that is pre-verbal, preconceptual.

Much of our daily lives we are lost in our heads, churning out thoughts of memories, regrets, plans, worries and judgements, and the present moment of Reality is barely noticed.

In Vipassana meditation, one starts to pay attention to Be, Here/Now, to the truth of the present moment. Using the breath as an anchor, one brings the wandering and clinging mind back again and again to the present experience of sounds (hearing), smells, tastes and touch

"Bring back a wife!" my friend said as I left, or was it "Purify your life!"? Perhaps they go together, like honey stirred in a hot cup of tea on a cold night.

Forest Path

Walking on the forest path there appears a huge pine tree with a companion a smaller maple tree wrapped around him in a spiral I know trees are androgynous but, keep wondering if these two are lovers rooted together in the earth reaching upward, mates for life (body sensations or feelings).

The breath is the key. Right now take a deep inhalation and exhale completely. Now, breathing naturally (not trying to control), close your eyes and notice your breath coming in/out of the nostrils and the rise/fall of the abdomen/chest ... Which is more noticeable?... Pick one and let that be your present moment anchor to relaxation, to peace, to letting go ...

In Eastern philosophy there is not two separate words for heart and mind. Purification of mind purifies the heart. Wisdom leads to compassion and compassion is wisdom.

Meditation is about understanding this deeply conditioned, constantly changing mindbody and learning how to accept and be with ourselves, our feelings, our breath. We realize the power and beauty of sitting still and quiet, doing nothing. We also awaken to the truth that spiritual practice is always here/now, without end. We commit ourselves to breathe into infinity and SEE all living beings with compassionate eyes.

A Council Arbor for the Tribe

I feel positive that if an adequate Council Arbor were built with an open center for Free Speech, this would do as much for Centering the Gathering as is possible.

Seems environmental conditions have a lot to do with our Gatherings. This last year the Gathering was immense, so spread out, and the Circles were, dare I say, at times spaced-out. If there is a designed Council Arena— an Arbor— like every other Tribal Culture on Earth have learned, people comfortably counciling can commune consensus, I am convinced.

The right kitchen or theatre scene, set up (i.e. Granola Funk etc.) provides opportunity for feeding or entertainment. As far as our Council trip goes, ain't it about time to get down with it? I reckon construct a Council space, folks will come Council in this place, and hang out and be--- when folks is with each other doing anything at the Gathering don't it help Center the entire Gathering, in one way or another? I am volunteering for this task this Gathering, and hope Spirit will open the Way.

Another type ticket was "interference with officers," and many of these tickets were for folks engaged in Cop Watch, folks acting as "fair witness" of various police actions. 

Old Rainbows Never Fade Away, They Just...

Retire to the old folks Home? Train grandchildren to carry gear?

It was no accident that I ran into Medicine Story exactly where and when I did: in the kitchen at Kid Village up in Pennsylvania. It was simply one more step in the lifelong spiritual journey that all my travels to and from gatherings seem to belong to. This summer, an eerie pilgimage into the not-so-distant future of my own old age.

So when I ran into the silverhaired elder of the Wampanoag tribe, I had to ask him my question.

The biggest difference I see between Rainbow Gatherings and the Native American gatherings I go to," Medicine Story told me, "is the attitude toward older folks." Among his Native relatives, he said, "it's always 'Grandfather, can I get you something to drink?' 'Grandmother, do you need anything?" While among his Rainbow relatives . .

Looking around, I realized that alongside our commitment to our children the Rainbow Family needs to cultivate an equal commitment to the elders among us.

My pligrimage had begun two weeks earlier at the Katuah Summer Solstice Gathering. As it happens. my 69-year-old father finally retired last year and this summer for the first time was free to visit this other family I had told him about. I was expecting him to arrive on the final day of the Katuah gathering and join our circle in honor of the Solstice.

At our beautiful Tennessee site, the trail to Katuah Kitchen crossed five different rock and log bridges, the trail to Coop Kitchen crossed four, and the trail between the kitchens crossed two. I helped build the crossings during the week- and rebuild them after a heavy rain - thinking the whole time about making the gathering accessible for my dad.

Midway through the week I was trying to get a council going, because - well, because the gathering was half over and we hadn't counciled yet. "Why?" people asked. I could see their point: for the second year running, Katuah Tribe was having no problems at all. What was to council about?

That was when it dawned on me that I was in the middle of a pilgrimage- the longest one of all.

If this year's gathering is cool and copacetic. what about next year's gathering, and the next? Could we conceivably make a good thing better? Do we have any vision or direction for the long-term sustainability of our tribe? How can we make sure that our greatest natural resource --- the folks growing older among us- keep on coming back? How can we keep our gatherings from becoming something people must eventually retire from?

As it turned out, my dad wore his sneakers and made it across all the stepping stones just fine. But many 69-year-olds could not. Neither could anvone confined to a wheelchair. And at some point

Move into a Winnebago at Bus Village? Check into a nearby hotel and ride the shuttle? Invest in an 4x4 wheelchair with giant tires? Stop showing up some year, never to be seen again?

in the future, I began to realize, neither could I.

So when I reached Pennsylvania, I began to ask the silverhaired people I met for their thoughts and feelings. Several felt they were close to the end of their Gathering days. Others planned to move up to Bus Village. Some had already made the move, which explained why I rarely saw them. But none summed up better than Medicine Story how far we have to go in our quest to be a tribe.

Then came my walk with Piano Dave up the Red Trail, where the metaphor of the pilgrimage and the pilgrim came literally to life.

I was posting a sign at info, completing my commitments for the day, when an old man with long white hair and beard and bright blue eyes sort of swayed toward me and spoke. I couldn't hear a word he said above the downtown hubbub, but I saw his lips move, so I bent closer.

His name was Piano Dave, and he needed help. He talked so quietly that it took me a minute to understand that he was meeting his ride at the top of the Red Trail, and needed help with his thinos. One helper was enough: he didn't have much. I seized the opportunity to be of service.

Don't misconstrue my action as unselfish. The older I get, the more acutely I feel the sad shortage of silverhaired elders in our tribe- our movement that started out as a rebellion of youth, and is still so young. I keenly felt the honor of helping Piano Dave, and several times refused to share it with a deserving brother or sister.

Though I would have loved to ask Dave the same question I was asking the other silverheads around camp, I didn't dare. He was laboring with all his might just to make it up the trail. Where it got steep or muddy, he had to concentrate on negotiating each footstep in turn, leaning on his stick, and I

had a nice meditative rest between every step. During our occasional longer rests I got a little conversation out of him, but I could tell he was being kind. His main agenda was just to regain his breath.

Plano Dave lives in Cambridge, Mass., where he works at a homeless shelter and has a long history as an activist. He'd come to his first Rainbow Gathering in Vermont in 1991, and thought Pennsylvania would probably be his last. I told him I hoped not.

All the way up the trail I could see Dave struggling against the need to rest. He had a ride all the way back to Cambridge, and didn't want to keep it waiting too long. But as we neared the trailhead two strong, brown sisters met us, coming the other way. I handed over his things and they thanked me for helping Dave. I thanked them in turn. All the way back down into the Gathering I kept wondering how those of us who value the silverheads among us can work together to make them more welcome.

Robbie Gordon camped at Katuah this year: he's hauled his burn leg into enough gatherings to qualify as an honorary old-timer. So I asked him the question, too. Together we visualized the "Rainbow Rickshaw," a human-powered taxicab with a luggage compartment and cushioned upholstery for hauling those too old, disabled or sick to transport themselves. One or two such vehicles could be stationed at every entrance to the Gathering, crewed by volunteers who want to build up a little good karma before their own turn comes.


And lo, before our eyes, it manifested! Someone had used one of those big-wheeled garden carts to haul in supplies; someone else had brought in some inflatable pool furniture. One night a brother was carried into Katuah camp who was too sick to walk. The next morning he headed up the trail- bouncing on rubber tires, cushioned in an armchair of upholstered air.

Robbie and I also brainstormed the idea of an "Elder Camp," perhaps near Kid Village, where younger people would cook for the elderly and make sure they had what they needed. And lo, not exactly before our eyes because it happened before we'd even arrived, it manifested: so many elders of the tribe camped up along the road this year, keeping an eye on things!

Another idea Robbie and I talked about was to make events at the Gatherings more accessible to keep them within the reach of everyone. And lo. what do you think happened? A Main Council consensus moved the site of our Fourth of July prayer circle up to the high meadow close to the road, where so many older family were camped.

I didn't make it up there, due to a prior engagement with a shitter cover I had hauled from Georgia, but I heard it was a beautiful circle. And I had a lovely walk in the Silence, meditating on all these things, traveling a few more steps on my long pilgrimage into old age.

FORGET PERMITS TO USE YOUR NATIONAL FORESTS FOR FREE... INTRODUCING THE "ADVENTURE PASS"!

The Adventure Pass is a pilot program to determine the willingness of the public to pay to use their National Forest. It is presently being conducted at 100 locations throughout the country. Federal funding was intentionally cut by 30% to Congress

to justify Implementation of this program. Free Our Forest L.A. is actively protesting the Adventure Pass and working diligently to inform the public about this corrupt recreational-fee pilot program.

The Adventure Pass was created by a large group of American corporations calling themselves the American Recreation Coalition (ARC). ARC lobbled Congress first to legally privatize and commercialize recreational facilities on public land for profits. Second, they know they can better sell their recreational facilities if they do not have to compete with free access to public lands. They have joined with our government to steal our public lands and a plece of our freedom so as to sell it back to us at the rate of \$5 a day or \$30 a year.

If this pilot program becomes permanent law, it will apply to all public lands. It is our understanding that Congress will act to make this program permanent law as soon as possible (sometime in 2000, unless we write a lot of letters). All citizens will be required to show a permit to gain access to our own public lands which should be our birthright in this free country. Write your congressional representative today. Ask them to support the Capps/Bono bill (H.R. 786) or any other legislation to stop the recreational fee demonstration programs.

Presently this program is voluntary. The Forest Service is trying to force compliance by deception and intimidation. They do not write violation notices which carry a penalty. They do, however, write "notices of non-compliance." These "notices of non-compliance" carry absolutely no penalty to you if you choose not to comply. Every Adventure Pass sold is a vote for the program.

Our group believes that access to public land is a right of all people. Recreation fees are double toxation and discrimination against low-income people. We are also opposed to the industrial-strength



recreation proposed by ARC. Our goals are: 1. Stop the recreation fee programs; 2. Stop privatization of public lands; and 3. Demand Congress restore federal funding to the public land agencies.

FORGET LOBBYING CONGRESS TO SAVE TREES... PRESENT-ING THE "GLOBAL FREE LOGGING AGREEMENT"

Before it's too late, let your government know that you oppose agreements that benefit multinational timber corporations at the expense of ancient forests, forest communities

and threatened eco-systems.

The World Trade Organization (WTO) and its 135 member countries are meeting at the end of November 1999 to write new international trade and investment agreements, including the "global free logging agreement" (GFLA) being spearheaded by the Clinton Administration. The GFLA could dramatically impact our ability to protect the world's remaining forests.

The GFLA will lead to forest destruction and the removal of forest protections in two ways. First, by rapidly eliminating tariffs on all wood products without putting necessary environmental protections in place, increasing consumption, production and unsustainable logging. Second, by opening discussion of the elimination of forest protection laws that the WTO considers "non-tariff trade barriers." Vital forest protection laws that could be eliminated include protection against invasive pests, recycled-content requirements, eco-labeling and "smart wood" laws, and bans on the export of raw logs and wood chips.

Sen. Barbara Boxer (D-CA) has written a letter to President Clinton opposing this attack on forests and forest protection measures. Senator Boxer's letter is modeled after a letter by 48 Democratic and Republican members of the House of Representatives opposing the GFLA that was sent to the President on Juty 28, 1999. We hope to have at least this many signatures on the Senate letter.

Call the Capitol Switchboard at 202/224-3121 and ask for your Senators' office. Ask for the Legislative Assistant who handles the Environment. Ask him or her to advise the Senator to sign Senator Boxer's letter to President Clinton opposing attacks on forests and forest protection efforts at the World Trade Organization.

What if the Babylon System you depend on for food and water should fail?

Information courtesy of the American Red Cross & the Federal Emergency Management Agency

In an earthquake, hurricane, winter storm or other disaster, you might not have access to food, water and electricity for days, or even weeks. By taking time now to store emergency supplies, you can provide for your Family. This brochure was developed by the Federal Emergency Management Agency in cooperation with the American Red Cross and the U.S. Department of Agriculture.

During and right after a disaster, it will be vital that you maintain your strength. So remember: eat at least one well-balanced meal each day. Drink enough liquid to enable your body to function properly (two quarts a day). Take in enough calories to enable you to do any necessary work. Include vitamin, mineral and protein supplements in your stockpile to assure adequate nutrition.

CLEAN WATER is a top priority. A normally active person needs to drink at least two quarts a day. Hot environments can double that. Children, nursing mothers and ill people need even more. You'll also need it for food preparation and hygiene. You should store at least a two-week supply for each Family member— at least one gallon per person per day. If you run low, never ration water. Drink what you need today, try to find more for tomorrow. Minimize the water your body needs by reducing activity and staying cool.

Store water in thoroughly washed plastic, glass, fiberglass or enamel-lined-metal containers. Never use one that has held toxic substances. Plastic containers like soft drink bottles are best, unless you buy food-grade plastic buckets or drums. Seal water containers tightly, label and store in a cool, dark place. Rotate water every six months.

If a disaster catches you without a supply of clean water, use the water in your hot-water tank, pipes and ice cubes. As a last resort, use water in the reservoir tank of your toilet (not the bowl).

Do you know the lecation of your incoming water valve? You'll need to shut it off to stop contaminated water from entering your home if you hear reports of broken water or sewage lines.

To use the water in your pipes, let air into the plumbing by turning on the highest faucet in your house. A little water will trickle out. Then obtain water from the lowest faucet in the house. To use the water in your hot-water tank, be sure the electricity or gas is off, and open the drain at the bottom of the tank. Start the water flowing by turning off the water intake valve and turning on a hotwater faucet. Do not turn on the gas or electricity when the tank is empty.

If you need to find water outside your home, avoid water with floating material, an odor or dark color. Use saltwater only if you distill it first. Do not drink flood water.

In addition to having a bad odor and taste, contaminated water can contain microorganisms that cause diseases such as dysentery, typhoid and hepatitis. Purify all water of uncertain purity before using it for drinking, food preparation or hygiene. There are many ways to purify water, none perfect; the best solution is often to combine them. The two easy methods below will kill most microbes but will not remove other contaminants such as heavy metals, salts and most other chemicals. Before purifying, let any suspended particles settle to the bottom, or strain them through layers of paper towel or clean cloth.

Boiling is the safest way to purify water. Bring to a rolling boil for 3-5 minutes, keeping in mind that some water will evaporate. Let cool before drinking. Boiled water will taste better if you put oxygen back into it by pouring back and forth between two clean containers. This also improves the taste of stored water.

Household liquid bleach kills microorganisms. Use only regular household liquid bleach that contains 5.25% sodium hypochlorite, not scented or "colorsafe" or bleaches with added cleaners. Add 16 drops of bleach per gallon of water, stir and let stand for 30 minutes. If the water does not have a slight bleach odor, repeat the dosage and let stand another 15 minutes.

Other chemicals that do not contain 5.25% sodium hypochlorite as the only active ingredient, such as iodine or water treatment products sold in camping or surplus stores, are not recommended and should not be used.

While these two methods will kill most microbes in water, distillation will remove the other microbes as well, plus heavy metals, salts and most other chemicals. It involves boiling water and then collecting the vapor that condenses back to water. Fill a pot halfway with water. Tie a cup to the handle on the pot's lid so that the cup will hang right-side-up when the lid is upside-down (make sure the cup is not dangling into the water) and boil the water for 20 minutes. The water that drips from the lid into the cup is distilled.

FOOD, unlike water, may be rationed safely, except for children and pregnant women. If activity is reduced, healthy people can survive on half their usual food intake for an extended period and without any food for many days.

Though it is unlikely that an emergency would cut off your food supply for two weeks, you should prepare a supply to last that long. The easiest way is to increase the amount of basic foods you keep on hand. Keep it in a dry, cool spot, dark if possible. Keep covered at all times. Open boxes or cans carefully so you can close tightly after each use. Empty opened packages into screwtop jars or airtight cans to protect from pests. Inspect all food for signs of spoilage before use.

If your water supply is limited, avoid foods that are high in fat and protein, and don't stock salty foods, since they will make you thirsty. Stock up foods your Family will enjoy that are also high in calories and nutrition, that require no refrigeration, preparation or cooking. (Canned food also contains water.) Babies, toddlers, elderly, nursing mothers, and those with special diets and allergies will need particular attention. Make sure you have a manual can opener. And don't forget nonperishable foods for your pets.

If the electricity goes off, first use perishable food and foods from the refrigerator, *then* foods from the freezer. In a well-filled, well-insulated freezer, foods will usually still have ice crystals in their centers (meaning foods are safe to eat) for a least three days. Finally, use non-perishables.

For emergency cooking use a fireplace, a charcoal grill or camp stove outdoors, candle warmers, chafing dishes and fondue pots. Before heating anything in the can, open it and remove the label.

Here are some guidelines for keeping emergency foods edible. Use within six months: powdered milk (boxed); dried fruit, crackers (in metal container); potatoes. Use within one year: canned condensed meat/vegetable soups; canned fruits, fruit juices and vegetables; ready-to-eat cereals, uncooked instant cereals (in metal containers); peanut butter, jelly, hard candy, canned nuts, vitamin C. May be stored indefinitely (in proper containers and conditions): wheat; vegetable oils; dried corn; baking powder; soybeans; instant coffee, tea and cocca; salt; noncarbonated soft drinks; white rice; bouillon products; dry pasta; powdered milk (in nitrogen-packed cans).

You may not have time to gather food from the kitchen, fill water-bottles, grab a first-aid kit from the closet and a flashlight and a portable radio from the bedroom. Have all these packed and ready in a handy place before disaster strikes, with at least a three-day supply of water and foods that are portable, nutritious and ready-to-eat, plus medical supplies and first aid manual; hygiene supplies; portable radio, flashlights and extra batteries; shovel and other useful tools; household liquid bleach to purify drinking water; money and matches in a waterproof container; fire extinguisher; blanket and extra clothing; manual can opener.

ARIZONA '98 PERMIT CASE

Representing himself, Strider won our only victory so far in the current round of legal action. The Forest Service took 6 months, but finally appealed. Oral arguments were heard Oct. 6th. Cross your fingers . . .

Presently, my case is before the 9th Circuit Court of Appeals upon the Govt's appeal . . . and I am awaiting the decision of the court. There is not much to add right now - but as an aside, oral argument did not go well and the Govt pulled a couple of last-minute manuevers, including enacting a new interpretative administrative regulation specifically designed to undercut my argument- but which in fact undercuts many of the Govt's arguments - and asserting a deceptive claim that the administrative appeals process contained in the regulations does not apply to non-commercial group use authorizations.

I have sent three e-mails to the lawyers handling these cases detailing how they should respond to these arguments; I was unable to do so at oral argument because the Justices bombarded me with questions, some of them off the wall. ... I don't expect a favorable decision- not because I am wrong but because I perceive the judges didn't like me, have no idea what a Rainbow Gathering is like (their questions involved Earth First!), and don't understand the regulatory scheme and will just buy the Govt's deceptions

However, I am even more convinced today that my arguments are correct than I was a month ago. The Dept of Agriculture's enactment of a new interpretative regulation on Sept. 2, effective Sept. 9, actually undercuts the Govt's arguments and strengthens mine.

Unfortunately, I was unable to adequately respond to the new interpretative regulation as I did not know about it until approx. Sept. 14th or so. The Govt also snookered me in a second way, by making a new argument in their Reply Brief-1) that the Administrative Appeals System does not apply to noncommercial group use permits and 2) that a person standing in my position would not be a party in an administrative appeal of terms and conditions and therefore doesn't have to exhaust the administrative appeals process but can go immediately to court and obtain prompt judicial review.

These last two arguments about the Administrative Appeals process are not true, and a deception by the U.S. Govt on the court- I believe a deliberate deception advanced merely so they win. Unfortunately I was unable to respond to this deception as it was advanced in my case for the first time in the Govt's Reply Brief and I thought I could respond at oral argument- I did not get an adequate opportunity to do so.

The lengthy, actually indefinite, and extraordinarily complicated administrative appeals process precludes prompt judicial review of a F.S. decision re a term or condition . . . It is not just a "term and condition" decision that has to exhaust the administrative appeals process. The duration decision- how long the fed, govt will allow citizens to exercise their First Amendment freedoms and thus limit their right to exercise their First Amendment freedoms- is also subject to the administrative appeals process.


The Govt states: "[Strider's] error is that the administrative appeal process, see 36 C.F.R. 251.80 - 251.102, by its own terms is applicable only to a limited class of parties, a class that does not include [Strider], or other applicants for a noncommercial group use permit. Only persons who are responding to a formal soliticitation from the Forest Service may invoke the regulations' administrative remedies. See 36 CFR 251.86(a). And, the Forest Service has consistently interpreted this portion of the regulatory scheme to make administrative appeals available only when the agency formally solicits applications."

But 36 CFR 251.86(a) does not require a formal solicitation. It provides, and the Govt ignores, that it applies to an applicant who, in response to a prospectus or written solicitation OR OTHER NOTICE by the Forest Service . . [emphasis added]. So if a Forest Service officer says . . . "you have 75 or more people here and you now need to apply for a permit," this will qualify as "other notice by the Forest Service.* . .

And here lies the severe - in fact overwhelming - problem with the lengthy time periods found in the administrative appeals process and I must tell you that the Gov't is trying to pull the wool over this Court's eyes. (Goodwater, this is where your Judge was just plainly wrong - he accepted the Govt's argument that all applicants for a noncommercial group use permit may challenge a term or condition directly in court and do not have to go through the adm. appeals process).

The Govt states: "Even if the Court were to reject this argument and find that the administrative appeals process applies to noncommercial group uses (and thus prevents prompt judicial review), that [sic] Court should sever the appeals process from the noncommercial group use regulatory scheme . . The Govt is suggesting that the administrative appeals process does not apply to noncommercial group uses (again, they ignore the fact that even commercial uses may implicate First Amendment freedoms, including expression).

[The] clause imposing group liability (which arises out of a separate subsection to the regulatory scheme, 251.56(d): "Holders shall pay the United States for all injury, loss, or damage") works at follows: The Forest Service will not allow a person to apply for and sign a permit for a Rainbow Gathering, either regional or annual, as an individual. They told Gary Stubbs this at the

1998 California all-state gathering. They will only allow a person to sign as a representative of the Rainbow Gathering or in their minds the Rainbow Family.

Thus, if someone were to apply and sign the permit, it can only be as a representative or agent of the Rainbow Gathering or Rainbow family. Thus the person signing the permit is the Signatory and the holder of the permit is the Rainbow Family.

Well, if the U.S. wants to sue for damages, including the costs of fire suppression, they sue in the name of the Rainbow Family, not against the signatory. If the U.S. obtains a judgment against the Rainbow Family, as holder of the permit, the U.S. can then collect the judgment by going after any member of the Rainbow family who may have the assets to cover the judgment. Perhaps they will only go after an individual's assets who actually attended the gathering in which the liability arose . . .



More on How to Get a Ticket for Peaceable Assembly

... if you fulfill what seem (now) to be their criteria, as described by I.C. Fox— (a) be a recognized person who is aiding and abetting the Gathering taking place, an active volunteer; (b) be someone who communicates or has contact with Forest Service or other public officials; apparently, if you speak up or actively participate, i.e. promote free speech through action/expression AND if you communicate with your government officials— i.e. petition for redress of grievance or try to communicate and work things out with government officials ... you are likely to be targeted for a ticket. This means anyone who visibly promotes

Gathering and comes to the attention of Forest Service personnel (or other gov't officials) are certainly likely to be targeted and ticketed.

Joanee Freedom ... was a reluctant persona, who did not want a ticket and only took one under "actual duress"— i.e. FS pursued her,

threatened her, went through many gyrations, and after a long dance, Joanee Freedom finally received a ticket, from Bill Fox personally on video tape and with two "fair witnesses' (right on!) who observed, reported, recorded.

In the midst of all this dance, the fact the FS wanted Joanee (dropped their demands for T.C. and Ruthie) and would not settle for someone else became a real problem— FS targeting someone specifically as being the responsible person for Gathering, whilst ignoring the fact that thousands of persons take individual responsibility for their actions in the Gathering and do not accept that anyone else can be held responsible for their actions, one of the basic thermes, one of the essential values held as integral to the Gathering texture.

More on How to Get a Ticket for Interfering with an Officer

Perhaps some of these folks should have been more cool, been less interventionary, stood back or not taken some of the overt actions they seemed to be charged with. I don't know: it is a tough judgement call. I have been in many circumstances, at Gatherings, where intervening when injustice was so apparent has gamered me threats of arrest and tickets. And in other years, and even at certain moments at this year's Penn. Gathering, I stood in the way and turned the Forest Service's well-fed LEOs away from the Bus Village— away from driving through where children and others were playing, gathering.

FS chose persons to be ticketed— it could have just as well been me. I likely would not have pleaded "No Contest," as one of these defendants was wont to do; however, I can't fault him for his pathway in the Courts, nor fault these individuals' actions, nor anyone else who were pursuing their Constitutional rights to Gather, whilst withstanding intense harassment, particularly on the roads, etc., and in one way or another during their Gathering process were interrupted and harassed and finally targeted and ticketed by official-dums.

Certainly, speaking up in various ways through the years has been difficult, but I believe to be a Citizen of this Country and an Earthling, in hopes of one day experiencing simple Constitutional Freedom of Peaceable Assembly and living in Peace on Earth, requires my standing up for my rights. Good Action, well worth the legal mumbo-jumbo hassle, if such should come my way. Gatherings, now slowiy gaining momentum in many places on the Earth, would have never been able to take root and grow except for the personal sacrifices made by the few on behalf of their own freedom, which in turn has benefited the many. From the many, emotional support, financial support, psychic support, spiritual support coming from other persons, even long-time Gatherers, is seldom forthcorning.

Once you stand up, in many ways, one is on one's own— and in fact, one can wind up being called by other Gatherers an "ego-tripper" or too "radical." So obviously, if you are on such an "egotrip" or are too "radicaf" in some way or another, you probably deserved a ticket. This has been

some of the attitudes I have had had to contend with over the years

concerning the fact that I have stood up against the official harassment of the Gatherings. For me, these kinds of vibes and trial by "tongue fire" is simply part and parcel of the process toward eventual

liberty and justice. This includes the apparent

indifference of the thousands who regularly attend Gatherings who do not seem to feel they need to take some responsibility in the form of support of persons who become "targets" for official harassment. I can testify it is no fun to be one of the targeted, and yet thousands of other "family" simply go on with their lives and take no heed of what personal hassle this harassment can be for someone, even someone like me, who seemingly has an adversarial-sivle personality— which I feel is more out of necessity rather than from any personal will or desire.

Other Ongoing Legal Work

Continuing to work on various "cases," including the ongoing West Virginia murder case; prayers and support are needed in order to try to keep the killer/s of Nancy and Vicki in jail or put them there. This year is a crucial period. Jake Beard may be tried again. He was found guilty in 1993, after 13 years of active investigation on the part of volunteers in service to justice . . . i.e. Apple Blossom investigators. Beard was sentenced to two life terms without chance of parole. He is currently on release pending new trial, etc. -sad, but true. And next year will be a return to Jose Antonio Ramos. who comes up for parole: 1986 sexual assault of children at Penn. Gathering. This case has taken years and much energy of every sort, on the part of the few, in hopes of protecting the many from predators like Ramos,

The U.S. Forest Service & Martial Law

The "Forest Service" – read that "Forest Service Law Enforcement Division under funding by Federal Emergency Management Agency" – directed by "Professor" John Carpenter, Federal Law Enforcement Training Center, Glynco GA, Roswell NM, Waco TX, Tucson AZ (Home of the Southerm Command, overseeing the War against Central and South America). The Incident Command system, as written up in Arizona Gathering Report 1998, includes Study Teams led by Dennis Neil, deputy Incident Commander, Wyoming Gathering, who commanded the forces trying to stop volunteer firefighters from fighting the forest fire within the HomeSpace of the Wyoming Gathering.

I have no doubt the martial law tactics and strategies used against the Gatherings will be used here in this country. FLETC trains ATF and FBI, the "boys" who did Waco— where Army Special Forces were used, in one capacity or another, as many suspected and know. The Government has to finally cop to it; their hand is weakening.

Obviously, when you are openly coming against "folks of difference," i.e. Waco, Rainbow Family et al, no question as to the fact that at some point you will slip up, and sometimes it happens, you are exposed. In the case of Waco, the "bad uns" are being revealed, maybe -- not so, yet, with the Rainbow.

The Gatherings are in jeopardy, and when the government publicly declares that the Gatherings will be ending in the next couple of years, as they did in news reports middle of July in Pennsylavania (Information Officer Rose Davis quote) there is cause for serious concern. Folks when they come to the Gathering got to take up with the government this issue of the government issuing what I would call a "veiled threat"— threatening to end Gatherings of the Peace Culture, Rainbow Family et al, on public lands— by whatever means.

Somehow or another the Great Spirit (whatever) opens the Way and the people come home to Be and then Be Gone, on public lands. However, in this public statement and in the Court cases, the government is stating more than less that either the people who Gather accept the authority of the Forest Service over the gatherings, i.e. sign a permit, be "managed," OR leave the public lands. Banning Peace Expressors, hippie-types, and the like.

Practicing for Y2K etc., all these years, on Gatherings—implementing martial law, and no one, even extremely few news reporters ever understanding and then reporting this fact out to the general populace.

Greetings, brothers and sisters of Region 4:

The Civil War is a perfect example of how violence doesn't solve things -- over 100 years later people are still bitter about the issues that war supposedly settled. How can you persuade anyone of anything by invading their territory, burning and looting and then occupying it? Of course they are going to resent you and pass their resentment down to their kids.

My answer to the quick and dirty solution of war is the slow and sometimes frustrating process of consensus. I believe an answer to every problem can be found that all parties can live with, if people are honest and willing to listen to each other, and if they stick with the process long enough.

I have no wish to start another war over the name "Dixie Rainbow," or create more resentment. The choice of your name is yours, and the resi of us will have to deal with it. But I do want to plead (not preach) with you to let the continuation of the Civil War take place somewhere else than at a Rainbow gathering. Rainbow should be a neutral territory where even bitter enemies can celebrate the deeper unity of all.

Thank you brother for your input. We held council this past September to bring this subject up. We have decided that since no one thought that Dixie meant anything to anyonc (i.e. it's just a name), we shall keep it the same; however, we will bring it up again at the gathering in the Homochitto National Forest in January.

On another note, I have found that, while conversing with African Americans, I have brought the subject up of the Rainbow Nation and described what it was about. Without ever mentioning the name Dixie and based solely on the description of the Rainbow Nation and given the fact that I have seen many African Americans at gatherings I have attended, the end result of the conversation is them telling me that "it's a white thing."

Most of the African Americans I know in this area would not participate in a gathering because they prefer to get together in the middle of town among others of their kind. Indeed, they tend to migrate together to make up a whole side of town sort of like you would find a china town in some cities.

Please don't get me wrong, I myself am not prejudiced against anyone except maybe those who look down on any type of alternative lifestyle. Most of the time when I do live in town, I actually prefer to live with African American neighbors. The area they usually live in is much more friendly and I feel more accepted there than with caucasians who tend to be nosey and judgmental. I can feel more comfortable sitting on my or my neighbors' front porch and talk for hours than to sit all alone in my yard while everyone else sits inside and peeks their noses out the windows.

I will agree with you if you say that I live in a prejudiced state. On the Gulf Coast there is less prejudice than anywhere else, but you can definitely feel the prejudice from BOTH sides through the whole state, especially in small towns north of the coast. I actually can't blame the African Americans for their prejudice though, since it is a conditioned response to being prejudged by the caucasians.

Light, Peace & LovenHugs, Jaybird

No matter how you view the name "Dixie," not everyone is going to agree. I know both African-Americans and Caucasians who on principle would not attend a gathering called "Dixie." This is not my fault, nor yours. But these people will be excluded, and the legacy of resentment will carry on.

My hope is that both sides of the controversy will be represented at your council, and this time instead of fighting it out a peaceful process of consensus will take place. That way when the next Mississippi gathering comes along, the Family will be united on the land.

I apologize if my words have offended anyone. I have tried my best to speak for peace. Whatever you decide, I will remain your brother under the Rainbow. But I have a request: please send Ho! some kind of statement of your decision, either the council's or an individual viewpoint.

It was a beautiful weekend for the fall council. The location was well chosen; it was a beautiful secluded section of land with a little bit of babylon close by. You felt like you were in the middle of the forest.

We gathered together to council on a few dcbatcd itcms. The first of which was a request by steven wing of the atlanta family, asking us if we thought the name of the region (dixie region) was a name that some family members feel is a name that reflects discrimination. We reached a consensus that no one among the participants of the council could come up with any reasion to change the name.

Dear Ho! readers:

Well, I got my wish. The Region 4 family held a council and discussed the issue I and others have brought up in past Hols. I was invited, and sent a letter as my representative. The council decided to keep calling their region and gathering "Dixie Rainbow" because, according to both of the reports I received via email, "it's just a name."

I guess you had to be there. To me, you choose a name because it means something — tells people who and what you are or aspire to be. In Region 4, I guess, "Dixie" is just part of the general background. The two voices from outside that region published in Ho! were apparently not enough to persuade this council that the name communicates something different in other places.

From where I sit, if you call yourself "Dixie," it's nobody's business but yours. Far from "just a name," it's a clear signal that you want to gather solely with "others of your kind." But if you call yourself "Rainbow," you are part of a vast and diverse whole which claims to be all-inclusive. Local prejudices do exist, yes; but do the Rainbow gatherings exist to change that situation, or accept it and become part of it?

It comes down to the usual paradox. Is Rainbow something we do for the whole planet, or just for ourselves? Is it a visionary conspiracy to bring every conceivable kind of human together in a miraculous moment, if not a week, of peace and harmony? Or is it a wonderful reunion where we see all our friends, build strong bonds with people a lot like us, and evolve our own neo-hippie culture?

At our best, both. We get out of Rainbow what we put in, and everybody wins. But the name "Dixie Rainbow" implies that a certain gathering, an

Hot I just received my new copy of Hol and was very happy to see that you've included my name, number and address. I'm all ways happy to receive mail but particularly so to get news from Family! So again I want to thank you, please keep up the good work and include my name and address in "Tear Down the Walls."

Now I would like to inform our Family of something that I feel is very important! I know that our Family as a whole does not promote or encourage illegal drug use. But as a diverse Tribe there are those of us that do continue to use and traffic in illegal substances. At the time of my arrest on drug trafficking charges I was ignorant of the extreme consequences or possession of even a small amount of LSD in Ohio. In Ohio 10 hits is considered bulk and being convicted of trafficking in bulk possession can carry one to five years. One hundred hits or ten times bulk carries 7 to 25 years. One thousand hits or one hundred times bulk, you can receive fifteen years to life as I said. So dear brothers and sisters be very careful out there. The laws in many states are comparable to that of Ohio. If I would have known the consequences beforehand I may not be here today.


Dear Brother and/or Sister,






