The theme will be the Panther concept of self-defense based on the active participation of the community in its own protection. The rallies can also be used as part of a program to attack institutional racism, and can serve as an occasion to help build a working relationship with the Panthers on local levels. Original program on "military" broadened to "militarization." Approved proposal calls for attacks on racism in unity with the black liberation struggle, on domestic imperialism, on the tracking system in high schools.

A program calling for a concentrated attack this spring on "militarization of the society" and its role as a class weapon was agreed to by a meeting of anti Vietnam demonstrators on Feb. 1-3.

The Princeton proposal called for anti-Vietnam attacks on the "neo-fascist" state of postwar militarization in the country, rather than a series of the glowing attacks on each intervention.

Against an anti-imperialist theme, the program was broadened to include the black struggle and the role of the military in imperialism.

Three Basic Positions

The three classes and movements program agreed three basic positions: first, based on the original "military package," called "Attack the Military in the Streets" (NYC, Jan. 16, 1968); second, "The War in the South" (NYC, Feb. 1, 1968); and third, "The War in the North" (NYC, Feb. 1, 1968).
