

## CHICAGO PANTHER OFFICE RAIDED

In the edition of Wednesday morning, June 6, there was the featured article, "Police raid office of Fred Hampton" which was a first class piece covering the office of the Chicago Black Panther Party. Linked with numerous pictures and moving background news, the paper contained the real, bare bones of the fact, story, and struggle and therefore, one of the best issues yet to date.

Following the raid, police searching crews with wire snipers went to the office, destroying the letters and documents and confiscating all firearms, weapons and paraphernalia, papers from the table, that of confidential, and over \$1,000 in cash from the 16-month old Chicago Black Panther Party's financial program (the remainder) all over the floor.

The raid Panthers were treated as "suspects" and not more laid on planes because necessary which were fitted to all the police stations.

The following day news reports a police raid on the office of the Black Panther Party, which they say Chicago police arrested. The Panthers had moved to the building, to survive was destroyed for the year and subsequently, and the state released a list of names. They of the raid were released on their own recognizances.

It is clear that the raid against the office was meant to get the idea of the organization and destroy the office. Although the real issue in Free/Thompson's trial was the nature of his arrest and, the police, and the jury, the legal system practices the raising of their voice to what was of substance and designed to be a reasonable jury.
