

CONTROL THE POLICE!

There is a crisis in Ann Arbor - six girls have been murdered and the police have in no way approached a solution. In fact, the police have proven to be incompetent, poorly coordinated, and vindictive. Based on information given to us by reliable friends, and upon facts and related events discussed at a number of Wed. night Free Community Council meetings at the Trans-Love Communes, we accuse the police

1. of not investigating extremely relative information concerning attempted attacks;

2. of not making it clear to the total public exactly what is being done to solve the murders:

3. of making it difficult for people with information to relay it to one central, responsible police source. (People are given the beauracratic run around, or are being treated like criminals!);

4. of <u>using</u> the murder investigation to harass street people, and people who smoke marijuana. (We know from experience that smoking marijuana harms <u>no one</u>, and that it is <u>criminal</u> that there are laws against its use, and enforcement of those laws is so harsh, selective, and a waste of taxpayers' money. The police should be putting their <u>total</u> energies into solving these murders.)

We have learned through the experience of organizing to obtain the city's cooperation to produce free, Sunday rock & roll concerts in the park that it takes the collective and unified energies of all the people to legitimize our needs, and to demand respect for our culture. As the pigs step up their harassment on the hip community, and continue to brutalize black people and fail to serve the whole community in a time of crisis, we must once again come together to expose them and provide for our own survival. We will not be fucked with!

We will exhaust all legal means, and we will use any tactics that will insure our survival, so that we may continue to serve the needs of the people. We will not be free until all the people are free. (To this end we plan to be at the City Council Meeting Monday, 16 June at 7 PM to demand a public hearing of our grievances and to make it clear to the police that they are responsible to the people - not in control of the people!)

Our complaints include a number of other incidents of police pig behavior, and since we have not been able to deal satisfactorily with the pigs on an individual or single commune basis, we are forced to educate and mobilize the whole community around the problems at hand. The final and total solution is in the hands of the people - All Power to All the People!

ITEMS

1. The Mistle Stop Restaurant on S.U. and Forest was ransacked (\$300 damages) and two of our black friends spat on by two punk fraternity (sic) boys on 11 June, while policemen in a car out

front watched. When the manager asked the pigs to arrest the punks, he was told that witness statements were contradictory and nothing could be done! It seems the pigs have conspired with the punks to harass the only and the best 24 hour restaurant in town. If the pigs don't take care of real crime, we will. Arm the People!

- 2. Two White Panther Party members were walking down S.U. a few weeks ago when Sheriff Harvey's goons pulled up and stole their rolled up white Panther flags, saying it advocated the violent overthrow of the government. Right on! The brothers went to the pig sty with friends and were unable to get their flags back. Charges of theft will be brought against these outrageous pigs. If there is no justice in the courts, we will have it in the streets by any means necessary!
- 3. A couple of young citizens attempted to go to a City Council meeting on 2 June, and were stopped at the first floor entrance and harrassed and searched by the local Ann Arbor pigs, and then told to get out because there was no City Council meeting that night. A government removed from the people foolishly fosters rebellion!
- 4. Fuzzy, a thite Panther, famous for selling many Black Panther papers, and organizing the street people into frizbee games on Forest and S.U., and helping many great toke downs get rolling on the streets, was busted for curfew 11 June out of a crowd of young people in the Satellite Restaurant. The police were down on his ass, and had threatened to get him if they saw him on the streets. The streets belong to the people! Fuck curfew! The demand an end to repressive pig behavior!
- 5. The Ann Arbor pigs consistently come by the Trans-Love Communes on Hill Street in the late night and put their damned search lights all over our houses. We surrounded a pig one night, confronted him, and demanded an explanation for such obviously attempted intimidation. All he had to oink was that he was looking at our lawn! What a fool! Leave us alone or feel the wrath of the People!
- 6. People have been harassed and intimidated by the pigs for distributing the Ann Arbor Argus and posting other community flyers. Pun and Skip, Ministers of Defense and Education, were arrested for distributing obscene literature to minors from Milan High School with intent to corrupt their morals. It's all bogus pigshit a pig attempt to suppress truthful information. We demand an end to fascism. We demand free community bulletin boards on every block in the whole city, so that buildings and trees don't have to be used to post community notices!
- 7. We demand an end to all marijuana laws. Unnecessary enforcement of irrational laws is a crime, and creates/perpetrates real problems for everyone. All people should plead not guilty to holy sacrament busts, and should contact Legal Self Defense. (769-2017) in Ann Arbor. We will not be fucked with! All Power to the People!

(note: Fun Flamondon, Minister of Defense, and Skip Taube, Minister of Education of the White Panther Farty were arrested for "distributing obscene material - to wit the WPP Statement and Frogram - to minors from Milan High School, and were bound over for trial in Circuit Sourt by pig-judge Elden. Everyone is invited to be in court for the fight at the June 20 % 25 arraignment and at dates to be announced as each round gets underway).

COURTROOM:

Fun, "The Supreme Court guidelines for what constitutes obscene material states that it must be totally without redeeming social value, totally offensive on its surface, and designed to arouse purient interests. Now, Foint #4 of the White Fanther Farty Program is, 'Free food, clothes, housing, medical care, dope, music -- everything free for everybody!'"

Judge Elden, in a classic oink, proceeds to say that the material goes beyond the limits of free speech as guaranteed by the First Amendment, and that we shall be bound over for trial in Circuit Court. Cink on you pig!

So goes the first act of the court circus -- not only does the judge not know the law of his own bankrupt system of 'justice,' he exposes his true fascist nature when put up against the bench. He sees no value in a statement of beliefs that describe how the needs of all the people can best be served, and which point to him and his cohorts as being the real enemies of progress. In fact, he becomes the hatchet man for capitalism when he attempts to not only isolate the White Fanther leadership, but tries to deny young people free access to a real & total education. Students are sick of having their creative talents channeled into lousy factories doing a machine's work, being drafted into an imperialist & rascist army, and graduated into bourgeois colleges.

The judge and the prosecutor are absolute fools when they refuse to listen to the kil's impressions of material which has changed their lives and brought the wrath of the self-appointed censors upon them (six students were suspended from Milan High, and some of them were intimidated into testifying at the preliminary exam that they had received the material at the WFP National Hdqts., 1510 Hill. Right Cn!) When Fun tried to carry on his questioning of witness Mike Huser - (Fun served as his own revolutionary lawyer) - to establish in the court record what Mike felt about the White Fanthers and the literature he had received, the prosecutor, pig-head Shay, objected with a grunt and an oink! He claimed that the question at hand was not what the students t . : : thought about the whole thing - or about anything for that matter but whether the material 'in fact' was to be judged obscene with the people, not in his fucked-up honkie value system which is antiquated and without respect for young peoples need and desire

to learn what the world is all about.

The obscenity bust is a meia-ruse --- designed to confuse the people (especially parents) by creating a controversy and a fear in the community. To cover their attempts to toally control students' lives, the pigs and administrators ascribe to be the guardians of 'community values.' If they can't manage to break peoples' natural spirit and natural curiosity in the schools, then they move on the people directly: they then suppress information and news and ideas, they intimidate potential leaders and organizers, and they repress political activity. Fascism! The defenders of phony-freedom represent a life-style and a set of values that are alien to the revolutionary youth culture that is developing rapidly in this country; just as they are alien to the cultures and needs of black people, Vietnamese people and all other oppressed people who are under attack by the fascist Amerikah government. Just as Amerikan fascism is commiting genocide in Vietnam, and engaged in counter-revolution against the black liberation struggle, it has begun to try and isolate mother-country radicals and revolutionary students and workers and hippies who are all becoming aware of the source of contradictions in society.

The enemy exposes his fascist nature at every turn -- and the people are brought together in unity out of necessity to survive. In terms of strategy, the choice is simple: you must be part of the solution or you will be part of the problem. It is not a question of whether to choose a side in the revolution, but which side you are on! In terms of ideology, we must generalize our communal life style and our radical critique of society, so that we serve the interests of all the people. The military/maniac/industrial complex and the media it controls to manipulate the people will be free and before every person enjoys his right to the best life possible.

Us we find ourselves fighting real battles in the courtrooms of fascist Amerika we must expose the bogus issues they arrest us for; and we must conduct a political offense as well as exhausting all legal means. The Feople must have power. Off





The pigs have sworn to convict Sinclair. IF CONVICTED, JOHN SINCLAIR MUST BE SENTENCED TO A MINIMUM OF 20 YEARS IN THE STATE PENITENTIARY! THE MAXIMUM SENTENCE IS LIFE IMPRISONMENT! The pigs are even more insane than usual since Sinclair has had the nerve to challenge the state marijuana laws and the right of the pig to arrest people for smoking the holy sacrament we all love.

This so-called trial has nothing to do with narcotics—it is a blatant and frightening political move by the pig power structure to further repress our growing revolutionary culture and our heroic cultural revolutionaries! The pigs want to rip this brother off and keep him from his righteous work in our community. We can demonstrate our support for Brother Sinclair and for all our brothers and sisters who are daily arrested and jailed for smoking the benevolent weed by showing up at Detroit Recorders Court, 1726 St. Antoine, each day of his trial. NOW DIG THIS! WHITE PANTHER CALL TO ACTION! We can only act on the information made available to us -- a lot of information about how the pig power structure continues to escalate its suppression of the people is available -- We urge you to be present by any means necessary at any Court functions the Pig forces our Brothers & Sisters to take part in. (note: Fun Plamondon, Minister of Defense, and Skip Taube, Minister of Education of the White Panther Farty were arrested for "distributing obscene material - to wit the WPP Statement and Program - to minors from Milan High School, and were bound over for trial in Circuit Court by pig-judge Elden. Everyone is invited to be in court for the fight at the June 20 h 25 arraignment and at dates to be announced as each round gets underway).

COURTROOM:

When Pun tried to carry on his questioning of witness Mike Huser - (Pun served as his own revolutionary lawyer) - to establish in the court record what Mike felt about the White Panthers and the literature he had received, the prosecutor, pig-head Shay, objected with a grunt and an oink! is Story Is Nearly Unprintable



My goodness.

Researchers studying adult Detroiters at work and at play have found that two of the 30 words they use most frequently are unprintable and that the fifth most frequently used word is "damn."

Students of Dr. Paul Cameron, Wayne State University psychologist, hid tape recorders in executive washrooms and concealed themselves behind potted plants in other places to record 40,000 candid words spoken by people in 80 different types of jobs in the metropolitan area.

They found that of 2,091 different words by adult Detroiters at leisure only the pronouns I, you, she and it topped "damn" in frequency spoken. Ten percent of the words spoken at leisure were profane.



People were more restrained on the job. "Damn" came in 17th in rate of frequency spoken, and total percentage of profanity was 3.5 percent.

Two other four-letter words considered taboos in polite society and unprintable without threat of criminal charges are the seventh and eighth most frequently used by Detroiters at leisure. They are the 27th and 29th most-frequently spoken on the job.

Cameron, who reported his findings in a paper at a meeting of the Midwestern Psychological Association in Chicago last week, said the study showed women use profanity as often as men.

He said the 100 most frequently used words in the English language include damn, God, hell and Jesus.

A listing of the 200 most frequently used words in the language, as compiled by Cameron's students, includes another six profane words all of them also unacceptable in polite society and unprintable.

The cleanest-spoken group of Detroiters surveyed were secretaries, Cameron s a i d. Less than one percent of the words they used were profane.

SALESCLERKS used profanity two percent of the time, executives five percent, factory workers 20 percent and pool players—at one poolroom surveyed—30 percent.

Cameron said he has concluded that the use of profanity at work "isn't a function of sex, but a function of how a worker feels about his job."

He said that based on the information his students collected, he believes that one in every 1,000 words spoken is a profane one. Researchers estimate that one in every one million words written is profane.

Cameron said the study, made over a two-year period, is believed to be the first of its kind

He hopes to continue study along the same lines working on the problem of why and when children begin to use profanity.

People use profanity, he said, "because in a way it is a protest."

Cameron said he had some problems conducting his research on profanity.

"Many of my colleagues made depreciating remarks about it," he said. "In fact, I was asked to leave the department because it is considered unacceptable research."

The WSU psychology department chairman, Dr. Ross Stagner, denied that Cameron had been asked to leave because of the profanity study.

"I would never at any time object to a study done on profanity," Stagner said. "There had been some criticism within the department about the publicity Cameron's gotten.

"He has used research methods we thought were inadequate. We all don't agree that undergraduate students are the best researchers."

Cameron said he used a triple-check system to assure that his students reported findings accurately and that he found only two who falsified their reports.
