

Sisters and Brothers,

On July 28th a Fast will begin. A Fast for Justice. A JUSTICE/FAST for John Sinclair.

There are many of us who have stood by and observed the trial of John Sinclair and his sentencing on July28, 1969 to 92-10 years. We witnessed Recorders Court Judge Robert Columbo sacrifice the integrity of the law and the court on the altar of vengeance and reaction. We watched as the Dept. of Corrections, under the petty control of beauracrats Gus Harrison & Perry Johnson, shipped John 500 miles north from Jackson to Marquette; claiming he was organizing prisoners while he was in quarantine! Now we read about censorship of his mail and denial of visiting rights to friends, media, and business representatives. We can only imagine the hardships put upon his wife and two daughters and parents and the difficulty for his lawyers in preparing a legal defense due to the cost of travelling 1000 miles to and from Marquette every two weeks. To make the financial hardships even greater for the poor Sinclair family, John was assigned to a job sorting prison laundry and is not allowed time to work on and financially benefit from his talents as a writer, music critic, and band manager. The prison authorities will not even allow John to use his education as a teacher to help unschooled inmates. Punishment, and not rehabilitation, is the order of the day.

We are going to fast four days -- July 28 thru31. This is a cleansing process for our bodies and our spirits....It is a testimony to our outrage and to our powerlessness. John went to prison under protest 1 year ago July 28. He has been denied bail pending appeal of his case. The JUSTICE/FAST is our physical statement to the State.

We invite all concerned citizens to join us or to spread the message of the JUSTICE/FAST while you Fast at work, school, or home. On Sunday, August 2 you are also invited to a Rock 'n' Roll/Feast benefit at one of the ballrooms.

We are circulating the attached statement to raise the money necessary for placing a full-page ad in the Detroit Free Press during the JUSTICE/FAST. This ad will be designed to educate the people about the political repression of John Sinclair, and to raise money for his legal defense.

We feel a sense of urgency in undertaking this task. You can express your concern for justice now. Don't give up on John Sinclair....Join the JUSTICE/FAST July 28-31! Help finance the full-page ad; send your donation with the clipped form soon. Thank you. Free John Sinclair!

Judge Julius Hoffman [upon request to subpoena John Sinclair during the Chicago CONSPIRACY Trial]: "I don't think a judge in this building or a judge in Michigan would sentence a man to 9½ years in prison for possessing two sticks of marijuana." Leonard Weinglass [CONSPIRACY defense lawyer]: "Your shock is shared by the defense and a good portion of the country."



"One week before I was sentenced to 91/2-10 years for possession of two marijuana cigarettes, Judge Robert Colombo, the Recorder's Court magistrate who sentenced me on July 28, 1969, gave another man 7 to 10 years for second degree murder.

"I am a political prisoner, presently being held WITHOUT BOND, in Marquette Prison. I am serving 91/2-10 years, not for possessing two joints of marijuana in the privacy of my own home, but for "flaunting the law," as Judge Colombo put it."

July 4, Independence Day, 1970. Was John Sinclair "flaunting the law," or was he just speaking out against its injustices? Let's look at the record. It took two disguised undercover agents two months to entrap John Sinclair into giving them two marijuana cigarettes. No charge. He gave them the marijuana, and Judge Colombo himself ruled that the transaction was a case of "Illegal Entrapment," i.e, that the police created the crime! The same evidence, which had been obtained illegally by the Judge's own ruling, was then used to convict Sinclair on the possession charge. Who was flaunting the law? John Sinclair's case also involves another important aspect. Since 1967, when he was arrested (along with 55 other people) on this charge, he has mounted an effective attack on the constitutionality of Michigan's anti-marijuana laws. The effects of this legal attack, aside from his 9½ year sentence without appeal bond, include bills in the Michigan House of Representatives, which remove marijuana from the narcotics category and the felony laws, and a bill which makes possession a misdemeanor under Michigan's law and provides a maxi-num sentence of one year in jail for the crime (27 states have already done this). All of these bills have passed in the Michigan House of Representatives and have received Governor Milliken's strong public endorsement. The bill that would make possession of any amount under 2 oz. a misdemeanor was passed by the House by 83 to 3 votes! On May 21, 1970, Gov. Milliken told a group of educators and medical experts that "We know that marijuana is not medically or scientifically a narcotic drug like heroin or morphine. . . It should not be associated with narcotics, either medically or legally."

John Sinclair has argued this point in his legal briefs for more than three years now, yet the Michigan Supreme Court, in denying his motion for an appeal bond, stated as their only reason for denying bond that Sinclair had failed to show that he had a "meritorious basis for

appeal." Who is flaunting the law? Who is making a mockery of our legal system? John Sinclair has taken this case against the marijuana laws to the Legislature, and they have agreed with has taken this case against the marijuana laws. Yet the courts, who know better, refuse him. The Governor has agreed with his arguments. Yet the courts, who know better, refuse for three years to answer the questions presented in John Sinclair's legal briefs because they know that to do so would be to sign his release papers, and they do not want John Sinclair in the community.

AS RESPONSIBLE CITIZENS we urge the Court of Appeals and the Michigan Supreme Court to investigate the record, read John Sinclair's legal briefs, and to reconsider their arbitrary decision to deny bail to John Sinclair. He has already served one year of his 9½-10 year sentence, and justice cannot be served until he is released.

If he is indeed guilty of political crimes, then a trial should be held and those charges against him brought forward. But to keep John Sinclair imprisoned on the cynically stated grounds that he has presented "No merit-orious Basis for Appeal" is a blatant miscarriage of justice which must be corrected immediately.

We are not asking for amnesty for John Sinclair, although that is the proper demand to make in behalf of political prisoners. What we are asking is that John Sinclair be admitted to bail in this case while he waits for the courts and the legislature to repeal the admittedly cruel and unusual penalties surrounding marijuana prohibition. This is not a frivolous request, and we should not be forced to bring this injustice to the attention of the public if the courts of Michigan were not so callous in their disregard for the rights of political prisoners, and of John Sinclair in particular. JUSTICE/FAST!

One day the apolitical intellectuals of my country will be interrogated by the simplest of our people.

ANN ARBOR

They will be asked what they did when their nation died out slowly, like a sweet fire, small and alone.

No one will ask them about their dress, their long siestas after lunch, no one will want to know about their sterile combats with "the idea of the nothing" no one will care about their higher financial learning. They won't be questioned on Greek Mythology, or regarding their self-disgust when someone within them begins to die the coward's death.

They'll be asked nothing about their absurd justifications born in the shadow of the total lie.

On that day the simple men will come. Those who had no place in the books and poems of the apolitical intellectuals, but daily delivered their bread and milk, their tortillas and egges, those who mended their clothes, those who drove their cars, who cared for their dogs and gardens and worked for them, and they'll ask:

"What did you do when the poor suffered, when tenderness and life burned out in them?"

Apolitical intellectuals of my sweet country, you will not be albe to answer.

A vulture of silence will eat your gut, Your own misery will pick at your souls. And you'll be mute, in your own shame.



There seems to be an unspoken agreement between the freeks and the pigs in this community, in which we leave them alone and they leave us alone. Of course, there are occaisonal busts(see this issue), but on the whole, the represaion scene is very light--at least for white people. Its a totally different scene in the Black community. The incedent a couple of weeks ago in "est Park where the pigs vamped on some thirteen year old Plack kids was no isolated case. The Black community has presented forteen demands to the Ann Arbor Shitty Council, none of which have been responded to among the demands are the dismissal of the officers involved in the west Park incident, dismissal of all charges against those arrested there, and turning West "ark into a Black cultural center. This last was already been hoppening, and is the reason for continuos pig harrasment at the park--somehow the man cant relate to a lot of Black people getting together...

Anyway, the whole thing has recieved virtually no support from the freek community, despite publicity in the argus. Why, we say as we take another toke off our joint, should we worry about it? After all, the pigs dont bother US that much... A couple of things. One is that our lives and the lives of Black people in this country are totally tied together. The Black liberation struggle has always inspired and given leadership to white youth. The pigs respond to Black energy with brutal racist repression, and a couple of weeks ago, the people responded with a righteuos ripoff/kidnapping of a pig judge and jurors in Marin, California. Bringing it all back home to Ann Arbor, the people of the Black community are responding to the same kind of thing. Of gourse, the repression is not due entirely to the pigs racism-it also that Black people are really getting together and moving on the houks who run this town. They deserve our total support in this. The reason the freek community hasnt felt some of the same repression is because we've sat by and let the pigs shit all over black people, we've kept in or place

and not really made any trouble for them. If we keep on in this manner, we shouldn't be surprised if the righteuos wrath of Black people starts coming down on us too.

"The best way to support a revolution is to make your own"--Abbie Hoffman We have to create a new society, a real community in this town, defining our own lives and terms of struggle instead of just existing in the space set aside for us by the pigs. We must create a new society out of the ruins of the old --the dialectic between creation and destruction of the pigsystem must be constant. We have to remember that the pigs are our enemies, are the enemies of ALL the people, however nice they may come on. In fact, the nicest ones are the worst, people like Staudemeir who get next to you, smiling all the time, telling you how much they love you, while all the time gathering

OAKLAND (LNS)-Outside the old wooden church in Oakland's black ghetto, a sea of black, brown, and white faces filled the sidewalks and streets. They had been gathering there for hours, waiting in the hot sun. Two lines of Black Panthers-in full uniforms of black jackets and berets, were all that kept the crowd in check. But people were unusually quiet.

Two hearses pulled up in front of the church and the crowd in the streets moved back to make way for it. A brown mahogany casket, followed by a grey one, were lifted out. "Panthers, salute!" a voice shattered the relative quiet. Clenched black fists shot up into the air, and fists from the crowd were raised in response.

Inside the church, Black Panther Party Chief of Staff David Hilliard began the service: "Wherever death may surprise us, let it be welcome, provided that this, our battle cry, reach some receptive ear, and another hand reach out to wield our weapon, and other men come forth to intone our funeral dirge with the staccato singing of machine guns and new battle cries of war and victory."

Father Earl Neil, spiritual advisor to the Black Panther Party read a fiery, moving statement from a Berkeley mother, and another from the Berkeley National Committee to Combat Fascism which affirmed: "Your son set an example for every revolutionary to follow. . You know, as all black mothers know, that youth will make the revolution."

And then, Minister of Defense Huey P. Newton came forward to deliver the eulogy. He began with a letter from George Jackson, Jonathan's brother, a prisoner in Soledad Prison, where he is on trial for his life. Prison officials are charging George Jackson and two other blacks for the death of a white prison guard, killed two days after prison guards opened fire on prisoners, killing three blacks. The letter will be the dedication to George's forthcoming book:

To the manchild, tall, evil, graceful, bright eyes, black manchild, Jonathan Peter Jackson who died on 7 August 1970,

Courage in one hand, the assault rifle in the other,

My brother, comrade, friend

the true revolutionary, the black communist guerrilla

in the highest form of development.

He died on the trigger, scourge of the unrighteous soldier of the people.

To this terrible manchild and his wonderful mother, Georgia B., To Angela Y. Davis, my tender experience

I dedicate this collection of letters,

To the destruction of their enemies

I dedicate

my life.

And then, from the depth of courage that is known only to people who are at the total mercy of the enemy, and dare to challenge that enemy, a letter from a group of black prisoners in Soledad maximum security "O" Wing. Fully aware of the possible repercussions, they asked that their names be read at the funeral "as being present in full ceremonial revolutionary dress: in mind, body and spirit.

and spirit. "And that these few words be said in our behalf; as coming from every Black Man in prison in the State of California, who may not know Brother Jonathan, but know well his brother George: Right on!. . . To the first of a new breed of freedom fighters to ever tread on Amer-ican soil in the history of the United States. We bury the body but embrace the ongoing spirit of Jonathan Pater Jackson?" of Jonathon Peter Jackson!"

Huey repeated the Panther tribute to fallen revolutionaries: "they have struck down the best that humanity has produced." And added, "and for this they will pay the price."

"These brothers didn't have murder on their minds," Huey said, "They had freedom." Then, ending with the words intoned by James McClain in the courtroom before they escaped, one hand placed upon his gun instead of the Bible, Huey concluded: "We have been englaved for too many years. The chains must be removed. We must be free-so help us God."



information for files and future busts. The University of Michigan sits intact in the middle of our territory, a center of imperialism where they make neat little things like the infra red tracing device that killed Che Geuvera. Our brothers and sisters are turning to smack instead of revolution, maybe because the concept of revolution is still abstract to them. What we have to do is make it a reality on all levels, starting with things like the tribal councils and making them really a basis for the community, and going on from there. We should learn from our sisters and brothers in places like Berkely, Isla Vista, Boston, who have followed the example of the Blacks and the Vietcong and are taking the struggle to a higher level--moving into the streets and beyond into firebombing pigs and pig institutions and businesses, all the time building togetherness and tightness with each other as the fight grows, and the need for that love of each other grows. Its time we injected some of that same love and energy into our own lives, its time we started figuring out where we should move--its time to put our town in the map!!

Tuesday, August 25, a sit-in began at t. Francis Roman Catholic Church in Ann Arbor. We requested a sum of \$10,000 for back-to-school clothes for children on welfare. The sit-in was broken up by the arrest of four people. Arrested were Kate Emerson, a welfare mother, Charles Thomas, WCBEDL president, and two supporters, Vicki Price and Pat Kosinski. They were charged with trespassing.

Following the arrests, the head priest of St. Francis said to Charles Thomas, "Spiro Agnew will probably come down here and shake my hand."

But some of those dudes were not at all what they were said to be.

They were oppressed by the same thing that a lot of people are oppressed by today-the pig system. Their alternative was to fuck it-to steal from itand to kill it.

These men were outcast from society because they couldn't live in the fast rising system—they had their own system power for the people. They saw the people getting fucked over and they took the offensive—armed struggle. Although they were not aware of the fact that it was armed struggle because it was so common to carry a gun then. They couldn't live unless they fought for their lives.

Zapzta was a bandito-a bad motherfucker-and he served the people. by giving them what they needed, as much he could. The was a revolutionaryin the vanguard, and carried out a revolutionary war; he was offed by a hundred pigs.

war; he was offed by a hundred pigs. Some where up a holler in the hills of Kain-tuck in 1884, Jesse James once proved to be the people's outlaw.

He was passing through Kentucky seeking a safe place to stay over night. came upon a house in a secluded hollow a ways from the town and the old lady who lived there put him up for the night. She feed him snd they talked about the hard times that the poor people were having just trying to live. She told him that the towm bank had a mortgage on her house and that the banker and the sheriff were comming in the morning to get \$500 from her. She didn't have more than a few dollars and if she didn't pay they were going to auction her house.

They slept and in the morning Jesse gave her \$500 and split. She paid the mortgage for the house, it then belonged to her.

The sheriff and the banker went back to the town, but on the way our man Jesse just happened to be waiting around the bend—"Up against the wall motherfucken this is a hold up."

Tribal smoke signals...

The Ann Arbor Tribal Council meeting began with Matt Lampe from Drug Help giving us a medical report on heroine. Heroine does not do as much mysical damage as speed and a lot of times speed freeks use heroin to get off speed. The people that get heroin around Ann Arbor get low grade heroin because it has been cut so much. They also don't shoot up correctly and use dirty needles. Heroin addiction is mental and physical. In the Ann Arbor area, because of low grade heroin, the occurance of mental addiction is far greater than physical addiction. The two main solutions were to stop the availability and to educate the people. Eugene Staudenwire reported that Non Borut and himself were looking for places for a cultural center, but madn't had too much luck. He also said that the city's attitude toward the project was one of knowing that they had to start doing somethi ng about drug abuse. committee was formed to do more research on the problem.

The Psychedelic Rangers have made \$3,470.00 for the Park Program, which will need only a small part of the money. The rest of the bread will go into community

projects. Now the Big Steel Ballroom will be able to open up under management by a people's ballroom committee.

Plans to organize a food co-op conspiracy were discussed. One suggestion was to first survey all the area suppliers. Then publish a price list and at the end of the week compile all of the orders and buy food in quantities. A committee was formed to orranize it.

The next tribal council meeting will be held Tuesday at the Ozone House offices where farshall Books used to be located. Things to think about for the next mosting are a transportation co-op and the fall elections and freeing Bobby Scale.



Fairy Tales in the Free Press and the Ann Arbor News say that White Panthers are helping the pigs with the problem of herion in our community. This is a bullshit lie and another case of the pigs turning the whole situation around. We are not going to help the pigs stick anybody in a cage. "The prisons are not rehabilitation centers. They are no more than concentration camps, so we consider all prisoners political prisoners, and blacks in particular, prisoners of war."

Huey P. Newton, Minister of Defence for the Black Panther Party, was released from Alameda County Jail, Wednesday on \$50,000 bond, He was charged with the slaying of an Oakland policeman in 1967.

A crowd of about 350 people greeted Huey at the steps fo the jail when he got out. The first thing he did was give the clenched fist and yelled All Power To The People. "Now you can see that I am free, now I want to do the same for the Sloedad brothers."

"Blatant racists are controlling the prisons...prisons are not providing rehabilitation. They are concentration camps." said brother Huey. He has also called for an all out attempt to free Chairman Bobby Seale, who is now a-



waiting trial in New Haven on murder charges.

A new trial date will be set on September 25. Newton's 1968 manslaughter conviction was overturned last May by the State Court of Appeal.

The reversal was upheld by the California Supreme Court. The conviction was reversed on the ground that the trial judge didn't tell the jury of the defence that Newton was unconscious from a bullet wound when the pig was killed.

The first trial was on a first-degree murder charge, but under state law the retrial cannot exceed an involuntary manslaughter charge.





LETTER FROM CHAIRMAN JOHN

Message of August 2nd, 1970

Brothers and sisters,

I can't begin to tell you how happy I am to be able to speak to you like this today, through my brothers voice, even though I can't be here with you. I'm happy that you're able to be here-that you are here-getting down in the park. being together like this in the sun, getting down in the music and coming together like you're supposed to-like were all supposed to do.

A lot has happened since I was dragged off the set and locked up in this penitentiary. A lot of incredible things have gone down, but we have to understand this is just the start, that things will get alot better and the bad shit will get alot worse before we're all together again like we're all supposed to be-together and free, running wild on the planet like the electronic aborigines we naturally are. Our culture will keep evolving, getting higher & higher as we get higher & higher, an d the forces of repression which are trying desperately to keep us from getting high like that will keep moving against us and trying to scare us away from each other.

As we get farther out and more together, the dinosaur people try harder and harder to keep us downand the struggle between them is implacable. But what we have to know is that the life/force will win/out the death merchants, and they will pass into history as all old worn-out forces always have-that's why I call them the dinosaur people, because they're on their way to extinction as a species, nothing they can do can arrest that inevitable process, and though they will fight it all the way they can't possibly save their hideous death system from extinction! And that's the only way it is supposed to be.

But we have to understand our situation in these term terms because if we don't see and understand the inevitability of our victory-of the victory of the LIFE/ FORCE over the death urge--then the creeps will just bring us down to their level where they can deal with us, and our progress toward the future will be slowed down for awhile, which will just make it harder on all of us. If we understand that we are the ascendant force, the natural successors of these obsolete creatures who control our lives right now, the pre-electronic people of the death culture, the decrepit old dinosaur people, if we





understand the laws of nature and our own place in the natural order as the ascendant or rising force on this planet, then we will be able to realize our destiny and carry on our total assult on the death culture with all the cinfidence and assurance we need to get this transitory stage of passage from the old order to the new with as quickly and as mercifully as possible, so everybody can start enjoying the beautiful new life of the New World right away!

WE ARE THE FUTURE, is all I mean to say, and the hopeless dinosaur people are just trying to keep us from realizing the full extent of our humanity because they're scared of us, they're scared fo the future, they're scared of taking the natural next step in human evolution. They try to destroy us, to make us go away, they outlaw us and call us illegal, they put us in jails and penitentiaries, they beat us on the head or shoot us trying to keep us down-but it's hopeless, it won't work like that, we simply cannot be stopped, and the only thing these old brontosauraus chomps can possibly do is slow us down for a minute and make things miserable for us as they possibly can, while they can still make us miserable.

But that won't even make more than a minute's difference in the eye of eternity- we are destined to move on into the New Age, and the repression the death creeps bring down on us only stengthens our will and our absolute determination to be free- free to evolve and develop ourselves and our beautiful high-energy culture to its highest and fullest extent. The more they try to keep us down, the more determined we get to move these people aside and let our culture, our humanity flourish as it's supposed to. Jails, penitentiaries, courts, massacres, the deaths of our heroic brothers and sisters in Berkeley, in New York City, at Kent State in Ohio, at Jackson State strength to go on, because we will go on and we will not be stopped!

A year ago, or maybe a week or two more than a Y car a ago. I was out here in the park with you. I've been in the penitentiary for a year, but I've got to say that I'm still with you, and all that this penitentiary time has done is brought me closer to you than I was before they ripped me off. It's given me the opportunity to do a lot of reading and studying, a lot of thinking and meditating, a lot of time to consider and study everything that's going on out there in the world, and it's made me realize more than anything the absolute inevitability of our victory. I used to hope for it and believe in it. I always had faith in our strength and potential-but now I know it. I know it down in my cells. I know without a doubt that we cannot possibly be stopped, and that knowledge inspires me to keep purifying myself in this place where they keep me away from you, to keep studying and learning and growing in this little prison cell so I will be able to make my work more effective when I get out of here and help my people keep moving faster and faster toward teh New Age of our holy marijuana visions.

I know that the more we work and play together like this, the closer we unite our bodies and spirits through the holy communion of our music of the killer weed I wish I was smoking with you right now, the more we come together and get down together and move together as a united people, the sooner our ridiculous troubles will be over with, and the sooner everyone will be able to live like they're supposed to, in the New World. You know you're here in this park right now because people have united and worked together, filled and inspired by the music, for four summers now to make these concerts a permanent weekly thing. The city government and the people who put them there-the local dinosaurs-tried to keep these celebrations from happening like this, but the people of the Ann Arbor youth community got together with each other and moved in a political manner to bring about a political result- we took petitions around, we organized ourselves and held community meetings to deal with our problems, we took ourselves downtown to the city council meetings and made our needs known to the "city fathers," and we made it clear that we had to have the music, that we wouldn't be denied our culture, that our needs had to be dealt with just like this, and you can see the results of the struggle. which went on over two whole summers, as you lay here

in the grass getting high and digging the music and each other on this beautiful day.

We have a lot of changes to make in this world, and we have hardly begun to mobilize ourselves to make those changes, but the leason of the park concert struggle is clear--if we unite with each other and get ourselves together as a people, united around our high-energy culture and inspired by it, we can make these changes, and we can make them now. Like I said, this is only the start, but it's a killer start if you can dig it, and it points the way to the future as clearly as anything I know.

That's all I can say today, I don't want to ramble on because I know you have to hear the music, and I wish to gos I could be here right now to dig the dangerous Upsters sock em out under the sky with you-but I'll be back with you before you know it, and we can all get it on together again, when that day comes. You know they're trying to hang some incredibly bogus rap on me and brother Pun about the CIA building that mysteriously disintegrated a couple of years ago, but we can deal with that when they let us in the courtroom to expose the snakes and pigs and creeps they've bribed into telling a bunch of bullshit lies

but that's ok too, and if they do decide to struggle this shit out in their plastic courtrooms they'll be sorry they even thought of trying to frame us like that. All I can say is Power to the brothers or sisters who did explode that creep joint-I didn't even know it was there until I read about about it in the papers the next day, that's how secretive and sneaky those snakes are, but I can't say that I wasn't happy to hear about it getting blown up. Right on to that, whoever did it, even if it was David Valler!

So we'll deal with that when the time comes to deal with with it, and we'll deal with it from a position of strength, because we will be moving with the strength of united people, and we will be saying then as we have now, All Power to the People! Power to Woodstock Nation! Long Live Rock n Roll! Long Live the People revolutionary Culture! Life to the Life Culture- Death to the Death Culture! and free music and plenty of joints to the People!

Dear Friends:

Almost one year has passed since John Sinclair was cruelly and unjustly sent to a maximum security prison in Marquette, Michigan for 9½ to 10 years for possession of two joints of the innocuous herb, marijuana. If that sentence, for such an absurd "crime", were not appalling enough, it is even further disappointing and depressing that members of the public have evidenced such scant concern and support for the case. A case which, with its further implications (denial of appeal bond, restriction of the paltry privileges one receives when incarcerated, removal from family and friends to a distance of 500 cold miles) bodes as ill for American justice as does the sentence itself.

We know, as you know, that John Sinclair is not now, and never was, a criminal. No marijuana smoker is a "criminal", and the recent actions of the Dearborn City Council in lowering the penalty for possession of marijuana to a misdemeanor, and the beginning of the move in the state legislature to accomplish that act, show that our lawmakers are slowly beginning to recognize this common truth. Far from being a "criminal," John Sinclair has in fact always been a constructive and energetic force in the youth community. He has established a number of cultural organizations, including the Artists' Workshop and Trans-Love Energies, he has worked with the youth of our community in establishing the Grande Ballroom and as a manager of many of their bands, he has served the community as a writer, music critic and poet.

In return, the community has turned their back on him, as he sits in a prison cell unjustly convicted and absurdly sentenced of a crime that is no crime at all. Given the unusual nature of his sentence, one would think that the public would rise up and demand that his case be reviewed, that Mr. Sinclair be released on appeal bond pending that review and that justice be served. It is time now to do so.

On July 28-31, we will hold a four-day fast, a Justice/Fast, for John Sinclair, as a demonstration of our outrage at the shoddy treatment that he has received at the hands of our courts and as a gesture of support for John, himself. We ask that you contribute to one part of our demonstration.

The Justice/Fast Committee wants to run a full-page advertisement in the Detroit Free Press on August 2nd. A copy of that ad is enclosed. But to run the ad we need funds and our resources are low. We ask therefore, as a minimal gesture of your support, that you send whatever funds you can spare to the Justice/Fast Committee at the above address. We would also ask for your support for Justice/Fast and for John Sinclair in his battle

Was John Sinclair "flaunting the law," or was he just speaking out against its injustices? Let's look at the record. It took two disguised undercover agents two months to entrap John Sinclair into giving them two marijuana cigarettes. No charge. He gave them the marijuana, and Judge Colombo himself ruled that the transaction was a case of "Illegal Entrapment," i.e. that the police created the crime! The same evidence, which had been obtained illegally by the Judge's own ruling, was then used to convict Sinclair on the possession charge. Who was flaunting the law?

John Sinclair's case also involves another important aspect. Since 1967, when he was arrested (along with 55 other people) on this charge, he has mounted an effective attack on the constitutionality of Michigan's anti-marijuana laws. The effects of this legal attack, aside from his 9½ year sentence without appeal bond, include bills in the Michigan House of Representatives, which remove marijuana from the narcotics category and the felony laws, and a bill which makes possession a misdemeanor under Michigan's law and provides a maximum sentence of one year in jail for the crime (27 states have already done this).

All of these bills have passed in the Michigan House of Representatives and have received Governor Milliken's strong public endorsement. The bill that would make possession of any amount under 2 oz. a misdemeanor was passed by the House by 83 to 3 votes! On May 21, 1970, Gov. Milliken told a group of educators and medical experts that "We know that manijuana is not medically or scientifically a narcotic drug like heroin or morphine. . . It should not be associated with narcotics, either medically or legally."

John Sinclair has argued this point in his legal briefs for more than three yearsnow, yet the Michigan Supreme Court, in denying his motion for an appeal bond, stated as their only reason for denying bond that Sinclair had failed to show that he had a "meritorious basis for appeal."

Who is flaunting the law? Who is making a mockery of our legal system? John Sinclair has taken this case against the marijuana laws to the Legislature, and they have agreed with

him. The Governor has agreed with his arguments. Yet the courts, who know better, refuse for three years to answer the questions presented in John Sinclair's legal briefs because they know that to do so would be to sign his release papers, and they do not want John Sinclair in the community.

AS RESPONSIBLE CITIZENS we urge the Court of Appeals and the Michigan Supreme Court to investigate the record, read John Sinclair's legal briefs, and to reconsider their arbitrary decision to deny bail to John Sinclair. He has already served one year of his 9½-10 year sentence, and justice cannot be served until he is released.

If he is indeed guilty of political crimes, then a trial should be held and those charges against him brought forward. But to keep John Sinclair imprisoned on the cynically stated grounds that he has presented "No meritprious Basis for Appeal" is a blatant miscarriage of justice which must be corrected immediately.

We are not asking for amnesty for John Sinclair, although that is the proper demand to make in behalf of political prisoners. What we are asking is that John Sinclair be admitted to bail in this case while he waits for the courts and the legislature to repeal the admittedly cruel and unusual penalties surrounding marijuana prohibition. This is not a frivolous request, and we should not be forced to bring this injustice to the attention of the public if the courts of Michigan were not so callous in their disregard for the rights of political prisoners, and of John Sinclair in particular. JUSTICE/FAST!

DO THE... LIBERATION BUGALOOS

TO THE PEOPLE GATHERED IN DIANA OUGHTON MEMORIAL PARK FOR THE FREE CONCERT:

How do you feel oday? This is Pun Plamondon, Minister of Defense for the White Panther Party talking, July 4, 1970.

A bunch of honkies, man, all around this country are out doing their thing. But not me, I went out target practicing today.

I think we are going to have to move to initiate our own independence day. But, of course, that ain't gonna come until we get our independence is it? So, we are going to have to work on that dligently. But, I would like to make a motion or a suggestion that we move our independence day to some day like July 14th. Now, July 14th is known around the world as Bastille Day. That's the day in France where righteous brothets and sisters got together and stormed the Bastille, stormed the jail, and cut all the mad men loose. And we sure enough got some mad men in jail and prison right here. So, on the day that we do that. on the day that we have our own Bastille day that will be our own independence day. I don't want to talk too long on that- I know you are all here to listen to some music and get high, dance and have a good time. But, at the same time we got to take every opportunity that we can to try to talk to our people, try to talk with our people, to carry on a dialogue with our people, cause the pigs they got computers working while we're sleeping, you dig. So, we really have got to be on our toes, we really got to push ahead.

It's pretty hard to be sending these tapes back and forth, but I'm really gonna try to do it as much as Ican, as much as people want to hear it. If they don't want to hear it then fuck it. I'm still underground here in Babylon, but I ain't so far underground that I don't know that the people are getting together, and I ain't so far underground that I don't know that the people are getting down, and the people are moving in a revolutionary manner to bring ALL POWER TO THE PEOPLE.

So, I always like to start by saying All Power to the People, cause to me that slogan is one of the most revolutionary slogans around today. To be revolutionary something must be totally new, totally different, it must embody total change, and All Power to the People certainity has all those qualities. C. are, right now in Babylon the people ain't got no power. People ain't got no political power. The people don't control their own destinies and certainly young people don't – people from the youth colony. But, in the final analysis, when you think about it, when you look at it, the people hold the ultimate power. You know, the ultimate power. The people and the people alone are the ones who write history.

We have been led to believe that history was written by Abraham Lincoln and George Washington, that racist, and Thomas Jefferson and all these other cats and we thought well, those are the cats that wrote history. But, when you think about it it's the people and the people alone that write history. The people have such unlimited energy, such unlimited imagination, and they can do anything. But, that ain't really what I want to talk about. I want to talk about Babylon. And I want to talk about structure, the power structure.

Right now in Babylon the power rests in the hands, or more correctly should I say, the power rests in the paws and hooves of three types of beasts: vampires, rats, and pigs- in that order. Now, the vampires, they're the ones at the top. They hide in caves and manipulate from caves, air-conditioned offices and pane'led offices and they're



bald headed sissies. Boy, I hate it! Wow! The Black Panthers call them avaricious businessmen, but we call them vampires. They're cats like Henry the second-hand Ford, H.L. Hunt, and beasts like that. They just suck the people dry. Now, below them are the rats. These punks are the demagogic lying politicians. They're the ones who will be slipping and slidding & scurrying around setting the people up for the vampires to suck. But, like we see, here we are in the later stages of the collapse of Babylon and we see now hybrid mutants like Rockerfeller. He is not only a slippy, slimy sewer rat, he's also a blood sucking vampire. Now, these two types of oppressors, the vampires and the rats, are cowardly, no dick, spineless assholes. But, they keep themselves in power by organizing, manipulating, and even oppressing the last category of oppressors, and that is, of course, racist pigs. And their standard bearer and torch bearer is none other than that hog of hogs, that top swine, the world's all-time sissy, Adolph Hoover. Cause, these vampires and the rats they got their

So, they got their guns together and they keep themselves in complete power. But, there is a very important lesson here we have got to bring up, we have got to have discussion about it. I hope the super lefties and the anarchists can understand this because, it's paramount in organizing the people. And that is that the everyday work-a-day pig on the street is not the primary enemy. That's right. The primary enemy is way up there hiding in all those air-conditioned offices. He's a cannibalistic, capitalistic vampire. Now, by all means, don't get me wrong cause, I ain't flim-flammin, shuckin and jivin about no pigs, cause I sure enough got no thing goin with no pigs. And I always say loud and clear, ALL POWER TO THE PEOPLE, OFF THE PIGS, FREE JOHN, OFF THE PIG, FREE HUEY, OFF THE PIG, FREE ERIKA, OFF THE PIG, FREE BOBBY, OFF THE PIG, FREE ALL POLITICAL PRISONERS, OFF THE PIG.

But we still have to understand that the pig on the street ain't our main enemy. But, we got to constantly keep pressure on those fools and make them make a choice; are they going to stand, with the people and march down the road to liberation or are they going to be low-natured beasts and stand in the way of the people's just struggle. They got to make a choice. Either they're part of the problem or part of the solution. If they shape up and become servants of the people like they're suppose to then there won't be no trouble, there won't be no trouble at all. Those pigs got to always understand that it's the people who pay their wages, who feed their families and feed themselves. And if they are not acting in the interests of the people are gonna off them. That's all. So we always say for ever pig there's a frying pan.

Now this whole system, this whole system of oppression needs a front man, needs a mouth piece, needs a rallying point and that is none other than Richard the pighearted. But, he knows he's uptight, he knows he's on his last leg and all the fools, all those decrepit old BLAH! I can't even talk about it, man, without getting sick to my stomach. They know that they are losing their power over the people. So, they are constantly lashing out. Lashing out at the people the only way that they know how. And they whip together reactionaries all over the world. They're lashing out in Cambodia, Vietnam, and Laos. They're lashing out against our Arab brothers and sisters. They are getting ready to lash out against our Korean sisters and brothers. They are getting ready to lash out against the good people of Cuba. They're dying, they're sinking, they're falling, they can't take it no more.

You know, it's funny, the other day I was sitting in this bar with this cat drinking some beer and he knew I was on the 10 most wanted list, and he starts talking about, "man, you must be really uptight. Wow! You are on the 10 most wanted list. Man, the FBI is after your ass, the CIA, the Green Berets, all those cats. Man, you must be really uptight. How do you sleep at night? How do you fuck? How do you get high? How do you walk down the streets? How do you do anything?" And I said, "Wow! Man, it ain't like that at all. It ain't like that at all. I ain't the one that's uptight, it's them reactionaries that are uptight. I only got 3 or 4 thousand people after me, but them reactionaries, they got the whole world after them. They got people all over the world looking for their heads. So, they're in trouble, you know? It ain't me, I ain't uptight.

Time is always on the side of the oppressed people. Always. And we have got to remember that. All of us people have got to remember that time is always on our side. It's the pigs that are running out of time, and they show it by their actions.

Now, I've just dealt with this whole situation on a domestic level, on a local level, you see. But we've got to get away from that, cause we're part of the world-wide movement. People all over the world are dancing in the streets and they driving wooden stakes through the hearts of them vampires. And they are singing like the Rolling Stones sing, "my best friend shoots sewer rats and feeds them to his geeks." And they are following that up by "it's just a shot away," for all those racist pigs. And so, this whole system of oppression takes on an international scope.

So we not only got vampires and rats and pigs, but we got a huge octopus too. A huge white octopus that has all the characteristics of the other three monsters. Now, this is called imperialism. And it's a heinous, vicious strangler of the people's freedom all over the world. But, as the people dance they hack off a tentacle here and there. Like in Vietnam or Cambodia or Laos. And we're dancing and we're dancing right in the asshole of this whole big thing. And so we know that political power grows out of the barrel of a gun. But we also say that political power comes out of the end of a harpoon. So we've got to pick up a harpoon and jab it right up that octopus' ass and slay this monster once and for all, and then we'll do the liberation bugaloo with the rest of the people all around the world. Miami (AP)--Only one person of 50 approached by a reporter agreed to sign a typed copy of the Declaration of Idependence.

Two called it "commie junk," one threatened to call the police and another warned Miami Herald reporter Colin Dangaard: "Be careful who you show that kind of antigovernment stuff to, buddy."

A questionaire, circulated among 300 young adults attending a Youth for Christ gathering showed that 28 per cent thought an excerpt from the Declaration of Independence was written by Lenin.

The youths, mostly high school seniors, were then asked to describe briefly what sort of person they thought would make such a statement.

Among other things, the author of the Declaration was called:

"A person of communism, someone against our country."

"A person who does not have any sense of responsibility."

"A hippie."

"A red-neck revolutionist."

"Someone trying to make a change in government--probably for his own selfish reasons."

Next Dangaard typed up the Declaration in petition form, stood all day on a sidewalk and asked middle-aged passerbys to read it and sign it.

Only one man agreed--and he said it would cost the pollster a cuarter for his signature.

Comments from those who took the trouble to read the first three paragraphs:

"This is the work of a raver."

"Somebody ought to tell the FBI about this sort of rubbish." "Meaningless."

"I don't go for religion, Mac."

"The boss'll have to read this before I can let you put it in the shop window. But politically I can tell you he don't lean that way. He's a Republican."

PATRIOTIC FOG OBSCURES REAL REVOLUTION

America Day Misreads History

WASHINGTON-In the publicity material of Honor America. Day there is no mention of the fact that the Fourth of July celebrates an historic breakdown in law and order.

The stated purpose of the Disney extravaganza, with Billy Graham, Bob Hope, hundreds of flags, and a cast of thousands is "to rekindle the American spirit of patriotism . . (for) every American who loves his country and has a desire to reaffirm and display his loyalty."

It will be an old-fashioned Fourth, its producers say, the biggest birthday celebration ever. And it will perpetuate the sterile, simplistic, childlike notions about this nation's founding.

WHO WILL be able to tell from this celebration that on that July day, 194 years ago, a tiny minority gathered to display their disloyalty toward their government and flag and openly affirm revolution against one of the most civilized countries in the Western world?

How many of those who will celebrale Saturday have read recently it et all, the document signed that day in Philadelphia, or know of the events before and after the Declaration of Independence?



"Fourth-of-July" and "Declaration-of-Independence" have been e m a s c ulated by our teachers and the rhetoric or our politicians and run together and drop meaningless from our lips.

The signers of the declaration were not the demi-gods we have made of them. No one thought in those days, they would be cast in bronze. Had they failed they would have been clapped in irons and ignominy, for only successful revolutionaries become Founding Fathers.

They were, in the main, young, intellectual, long-haired radicals from the upper classes, defying tradition, their elders, and their sovereign. They had been plotting revolution and pamphleteering about it for a long cime.

IN THE SPRING of 1775, a year before the Declaration, the most fiery agitators who came from around the Harvard campus, hid a cache of (Like so many expressions from arms around Concord. The British, A merican mythology, the phrases understandably, opposed to force and violence, found out about the weapons and sent some men, under LI, Col. F. Smith, to destroy the rebel sanctuary.

Smith later reported to his commander "the considerable quantity of flour, gun-powder, ammunition, artillery, tents, and gun carriages" he had discovered and disposed of. And he reported too, that A mericans, fighting like guerillas, had fired on his men and had "scalped and otherwise ill-treated one or two of the men who were either killed or severely wounded."

Quite correctly, the following August, Great Britain proclaimed men like Jefferson, Paine, Hancock, Henry, and the Adams brothers outlaws, traitors, and troublemakers bent on overthrowing their government by force and violence.

What's more, George HI said, the young agitators were interfering with business, destroying property, and corrupting those who were loval subjects.

What the King said was true, and most Americans, although angry at

Great Britain's exploitation of the colonies, did not want violent, open revolution. They had been founded by England and ruled by her for 150 years. Some of the things she was doing to America, the moderates acknowledged, were not right. England was not perfect. But her faults could be corrected in time.

THE MODERATES sought reconcillation. But the extremists pushed and provoked violence, for they were set on independence and a system which could not be granted, but had to be wrested, a system founded on the rights of men, not kings.

George III, isolated, unaware of the power of the Democratic idea, and the dissatisfaction among American businessmen who saw their resources being drained in taxes, played into the hands of the extremists. And England lost the consent of the governed.

By the time the Declaration of Independence was proclaimed, revolution had already become a fact. And the central idea of the Declaration of Independence is the "self-evident truth" - that when a government no longer has the consent of the governed, when it is ruling only by authority, or tradition, or inertia, it is governing not at all.

And all the king's horses, and the king's men, cannot expect even Disney, Hope, and Graham, to put Humpty-Dumpty together again.

SAN FRANCISCO (AP) — Property has been purchased for a huge underground shelter to which corporate executives could flee in periods of rioting or bombings.

The \$10 million facility, first of its kind in the nation, will be a: big as a football field and will also serve as a storage house for important records. It will be equipped to shelter 1,000 clients for up to 30 days.

A spokesman for Bekins Moving and Storage Co. said Tuesday a 200-acre site had been purchased in Fresno County, some 250 miles southeast of San Francisco. The land cost was not revealed.

The firm announced plans for the project a year ago. Construction is scheduled to begin next year and be completed 21 months later. A landing strip will be built at the site.

The complex 40 feet underground will have two computers, recreation facilities, a library, food stocks, a surgical room, a dentists office and a morgue.

The firm says the facility "can withstand anything but a direct hit by a nuclear weapon."

You have to make a lot of sacrifices. You can't even pose before yourself the alternative of what am I going to do. Am I going to stay home and get high and have a good time tonight. or am I going out to try and rap with the people, to try to organize? You don't have that alternative anymore. It has to be only one course . . . the revolutionary course . . .

Bourgeois ideology says you have only one life to live. You know ... eat, drink and be merry, for tomorrow you may die. Don't give a damn about what your sister and brother are experiencing. Just do what you can do to get a little bit of pleasure out of life. What we are saying is that our lives are no different from the lives of our brothers and sisters who have been shot down by the pigs. from Huey Newton who is in jail and the Soledad Brothers who are being railroaded to the gas chamber for murder they had nothing to do with, from Bobby Seale who's being railroaded to the electric chair. We cannot separate ourselves from what is happening to them.

Of course, anybody who's talking about overthrowing the government, overthrowing capitalism, faces the possibility of losing his life. But ... that doesn't paralyze you, because you don't see your life, your individual life, as being so important. ... I have given my life to the struggle. My life belongs to the struggle. If I have to lose my life in the struggle, well, then, that's the way it will have to be. A hell of a lot of brothers and sisters have Iready given their lives for the struggle.
