課程主題

這門課是專門為清華大學與中研院合作的「中國研究學程」（社會所乙組）設計的碩士班導論課。這是一門基礎課。我們不預設修課學生對於中國研究的專門知識已經有相當的基礎，但是要求學生對於社會科學（尤其是社會、政治、與經濟等學科）的一般知識已經有大學部程度的訓練，而且對於中國社會的現狀有清晰的掌握。課程內容分成三個部份進行：(I) 到當代中國之路：針對中國市場開放改革前後的狀況與問題進行分析。這個部份是要讓學生熟悉中國當前政治、社會、經濟狀態的歷史脈絡。(II) 田野訪談：行前準備與事後筆記整理與分析。(III)當代重要議題：這些議題凸顯當前中國研究中最關鍵的幾個主題。

修課要求與評分方式

上課方式包括：課堂成員論流報告、教師講解、提問與討論。課堂成員必須事先完成每週的指定讀物，其餘推薦讀物自行延伸閱讀。每週上課前，完成一份指定讀物的短評 (critical note)，字數約在一千字左右，以電子郵件的附檔寄給所有課堂成員。

這門課同時也整合中國學程的年度中國實地參訪活動，包括田野訪談技巧與訪談心得與訪談稿整理。

成績考核方式：每週作業與課堂參與：30%；田野心得：10%；田野訪談整理稿：20%；期末考 (take-home exam)，40%。
